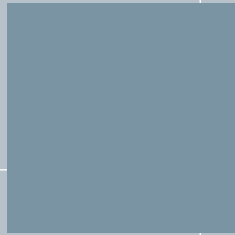
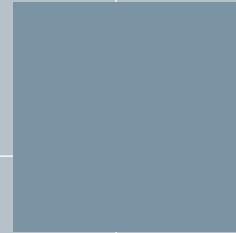

DEPARTMENT OF EDUCATION

Through the Office for Dispute Resolution, the Pennsylvania Department of Education (PDE) fulfills its statutory mandate to maintain a special education due process system. PDE contracts with the Central Susquehanna Intermediate Unit to provide fiscal and certain management support for that office, without becoming involved in substantive operations. The hearing officers and mediators are free from interference or influence on any matters affecting the outcome of individual mediations and due process hearings. This includes, without limitation, interference or influence from any entity, individual, or group, such as parents, advocacy groups, school districts, intermediate units including CSIU, ODR staff, and PDE. At the same time, those hearing officers and mediators are provided with administrative support, as well as training delivered in a manner preserving their impartiality through ODR, which itself is also free of such interference or influence.

The Central Susquehanna Intermediate Unit will not discriminate in educational programs, activities or employment practices based on race, color, national origin, gender, disability, marital status, age, religion, sexual orientation, ancestry, union membership or other legally protected classifications. Announcement of this policy is in accord with Title VI of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, and the Americans with Disabilities Act of 1990. Introduction

The Office for Dispute Resolution (ODR) provides the resources for parents and local educational agencies (LEAs) to resolve educational disputes involving children served by the early intervention system, students with disabilities (or thought to have disabilities) and students who are gifted (or thought to be gifted). Pennsylvania's recognition as an "exemplar state" by the Office for Special Education Programs (OSEP) and the Center for Appropriate Dispute Resolution in Special Education (CADRE) is an acknowledgement of the experience, education, and training of ODR staff and the quality of ODR services provided.¹ ODR's listserv is available at <http://odr-pa.org/subscribe-to-odr/>.

ODR Stakeholder Council

The ODR Stakeholder Council (SC) brings together representatives from a broad array of stakeholders to provide functional input and recommendations on the special education dispute resolution system. Outreach

ODR employees and hearing officers speak at conferences throughout the year as part of stakeholder education. The ODR Director (by invitation from CADRE), spoke at the OSEP Leadership Conference in Washington, D.C., as well as in a variety of other venues throughout the state. The hearing officers, singly and in conjunction with others, presented at a variety of conferences, including PA Principals Association; CADRE Symposium; various Pennsylvania Bar Institute seminars; PA CASE Conference; and Lehigh University's Special Education Law Symposium. The ODR Program Manager is the lead trainer for *Creating Agreement*, a conflict resolution training program.

ODR staff and the hearing officers collaborate to produce videos, webinars, and podcasts on topics germane to both parents and educators. Topics have included simulated due process hearings, tips for avoiding due process, an explanation of hearing officer settlement conferences, and similar topics. Development of training products for parents and educators is an ongoing process and based upon stakeholder needs.

Hearing Officer Training

The hearing officers engage in rigorous professional development each year, both in house and through highly regarded professional associations. They are members of the National Association of Hearing Officials (NAHO), and participate in the certification process. Hearing officers regularly attend the NAHO conference and/or the National Academy for IDEA

Administrative Law Judges and Impartial Hearing Officers, in addition to numerous trainings conducted within the Commonwealth where they are frequently asked to also participate as session presenters. In-house training in FY 2017-2018 included an interactive presentation on settlements/alternative dispute resolution and least restrictive environment issues. The hearing officers routinely attend PDE- and PaTTAN-sponsored conferences and presentations related to a myriad of issues impacting children with disabilities.

ODR Projects

Hearing Officer Settlement Conferences

Since March 2017, Hearing Officer Settlement Conferences (HOSCs) have been a regularly-offered service in any dispute where a complaint has been filed, and both parties agree to a HOSC. ODR maintains a randomized list of HOSC hearing officer assignments. When parties request a HOSC, the next hearing officer on the HOSC list is assigned to the HOSC (after confirming that the hearing officer does not have an ongoing case with the family or the LEA—if so, the next hearing officer on the list would receive the assignment). Each hearing officer has a slightly different approach to the details of a HOSC, but the same general framework applies—a three-sided conversation between the settlement hearing officer and the attorneys (or LEA attorney and pro se parent) takes place. Thereafter, the settlement hearing officer has a one-sided conversation with each party. At that point, each HOSC moves in its own unique direction— sometimes resolution has been achieved, sometimes further three-sided conversations are held, sometimes further one-sided conversations are held. The HOSC can continue until the parties feel it has met its goals, or their unassisted resolution conversations can continue without the settlement hearing officer. As of June 30, 2018, there have been 27 completed HOSC processes, resulting in a 74% settlement rate. As of June 30, 2018, seven HOSC processes are in the midst of being held. Virtual Hearings Pilot

Virtual hearings—and videoconference technology generally— became available as an ODR service as of June 2017. Using an internet-based, highly secure videoconference platform, easily accessed through any webcam-enabled computer, laptop, tablet, or smartphone, virtual hearings will allow participants to utilize videoconferencing to increase efficiencies and access in special education due process. Whether the hearing unfolds with all participants and the hearing officer gathering in a physical location and a witness participates virtually, or the participants gathering in a physical location and the hearing officer participates virtually, or all participants gathering virtually, the technology allows special education due process to be much more nimble in responding to the needs of participants in a world where notions of geographic-based processes and “physical presence” become much more flexible. Virtual hearings are entirely voluntary, only where all participants see value in utilizing videoconference technology for conducting the whole hearing, or some particular session(s), or the testimony of a particular witness. As virtual hearings have become more widely used by

almost all hearing officers, a data-gathering initiative is being designed to better understand the use of virtual hearing, and how use of virtual hearings can be improved.

Electronic Exhibits Pilot

ODR's electronic exhibit pilot program continues, with hearing officers receiving ongoing training. Most importantly, the program's protocol is in its final form. That protocol has developed over three years with extensive revision based on a significant amount of feedback from the bar. Currently, those attorneys who participate in the pilot almost uniformly send positive feedback. Some attorneys have requested deviation from the protocol. In those cases, the system is flexible enough for hearing officers to grant those requests on a case-by-case basis. Hearing officers are also able to implement the protocol across various software platforms, which enables ODR to seek out user-friendly, cost effective solutions.

CADRE Multi-State Project

Pennsylvania, via ODR, is one of three states invited by CADRE to participate in an initiative designed to enhance productive engagement between the state's parent centers and the state educational agency. During FY 2017-2018, ODR remained active in this initiative with ConsultLine staff participating in state partner meetings and projects associated with the initiative. The Pennsylvania state cohort decided to collaborate on the following three projects: a digital guide outlining available dispute resolution resources, a publication for parents describing services available to them from each parent center and ConsultLine, and a video that summarizes each organization's available services. These resources are scheduled to be completed at the conclusion of the CADRE-facilitated initiative in August and will be published on the website once finalized.

HUNE Project

During FY 2017-2018, ODR continued to contract with Hispanos Unidos para Ninos Excepcionales (HUNE) to assist in serving Spanish-speaking families in Pennsylvania. The Spanish Help-Line Plus, established by HUNE, provided families access to a bilingual information specialist who answered questions related to special education concerns and resources. The Spanish Help-Line Plus specialist received training from ConsultLine specialists.

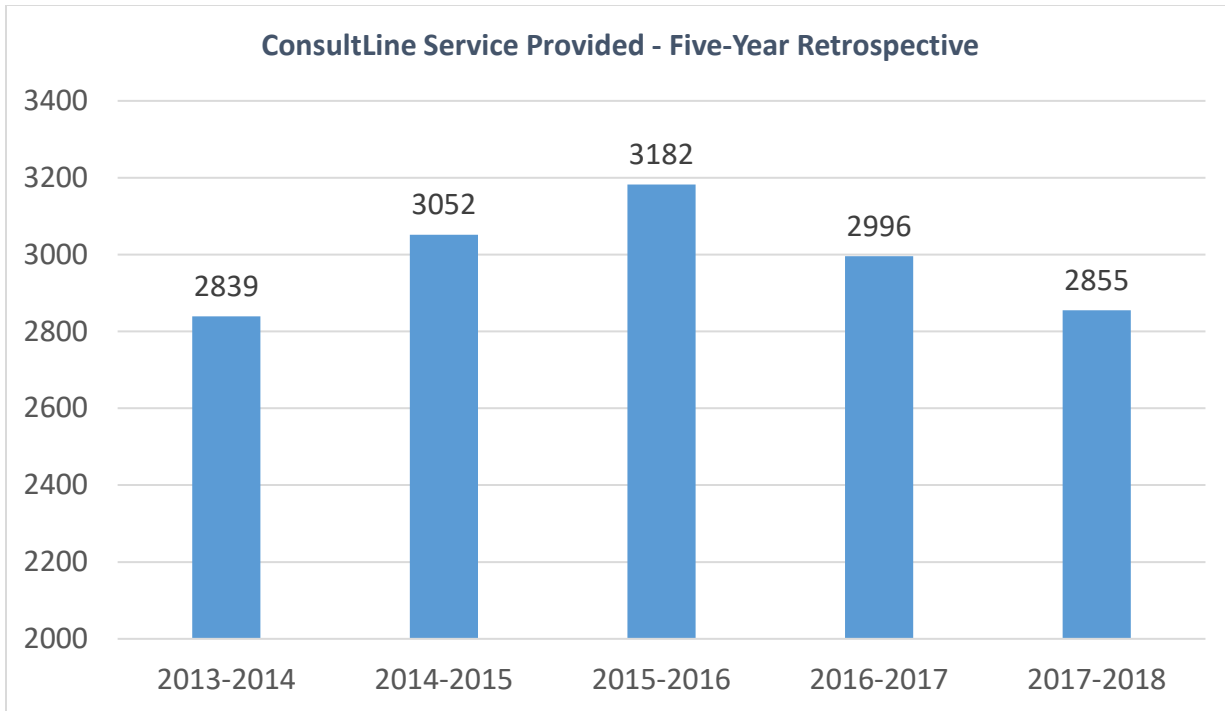


The Special Education ConsultLine is a toll-free information helpline for parents and advocates who have questions or concerns about special education for school-age children. ConsultLine is staffed by four Specialists who provide information about special education, gifted education, and Section 504 of the *Rehabilitation Act of 1973*. Specialists assess the nature of the caller's inquiry or concern and provide information and assistance. Examples of the service provided include:

- Information about the processes involved in having a child evaluated, identified, and provided with special education, accommodations, and related services;
- Parent's rights and procedural safeguards, including information about regulations;
- Information, assistance and access to the state complaint process managed by the Pennsylvania Department of Education's Bureau of Special Education (BSE);
- Dispute resolution services and options for resolving disagreements about a child's special education program; and
- Resources, publications, websites and referrals to disability-related organizations.

Call Activity

During FY 2017-2018, ConsultLine Specialists served 2,855 callers. ConsultLine Specialists are responsive to the contact instructions provided by the caller, i.e., date and times when the caller expects to be available to speak with a Specialist. Specialists will attempt to return the call at least three times over the course of three business days. This has been an effective protocol for serving callers in a timely manner given the volume of service requests. Despite staffing changes during FY 2017-2018, ConsultLine Specialists maintained a high standard for providing equitable and timely service to constituents.

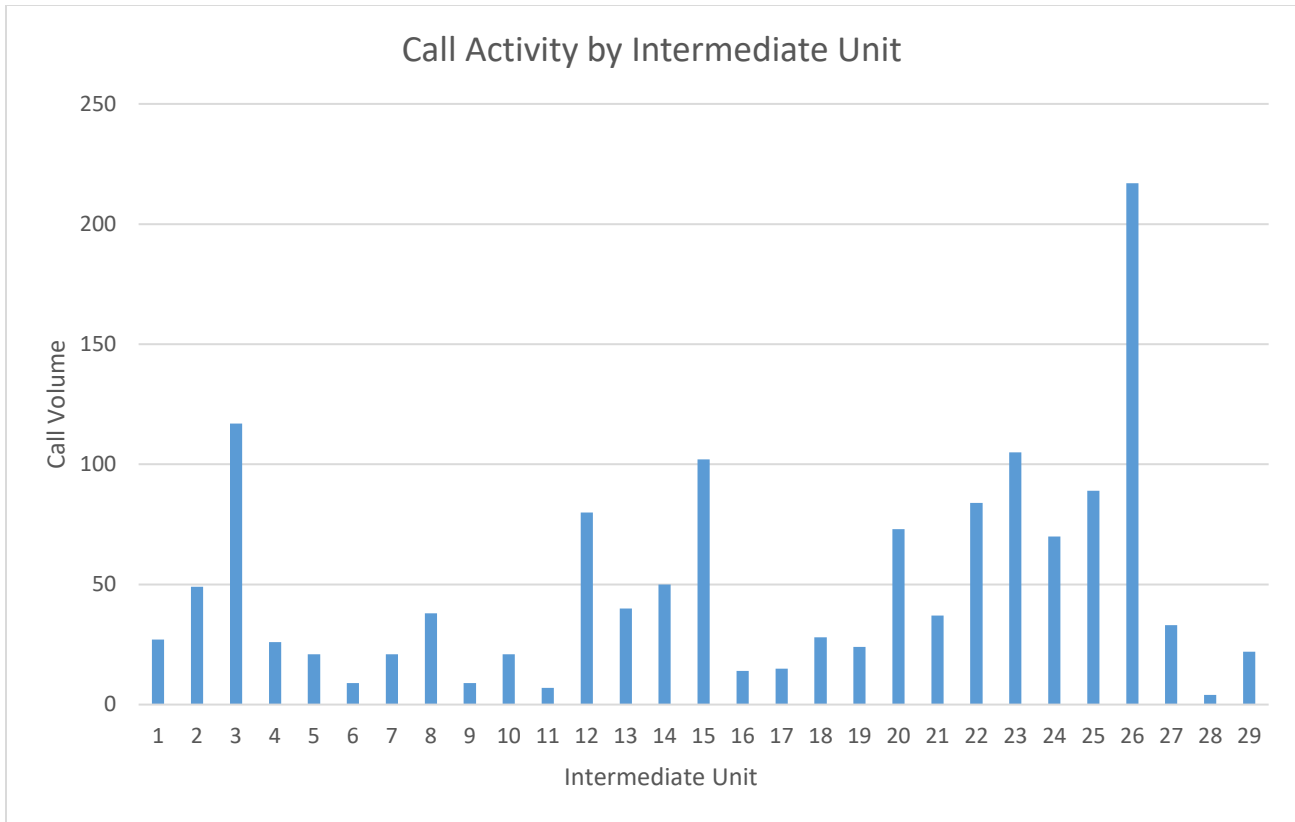


During FY 2017-2018, 45 callers speaking a language other than English were served in their native language. Languages included Spanish, Vietnamese, Portuguese, and Mandarin.

Caller Demographics

Demographic information was volunteered during 1,432 calls during FY 2017-2018. The following statistics provide a general impression of call activity across the state.

ConsultLine received the highest volume of calls from the following regions: Philadelphia Intermediate Unit 26 (217); Allegheny Intermediate Unit 3 (117); Montgomery County Intermediate Unit 23 (105); Capital Area Intermediate Unit 15 (102); Delaware County IU 25 (89); and Bucks County Intermediate Unit 22 (84).



Types of Inquiries

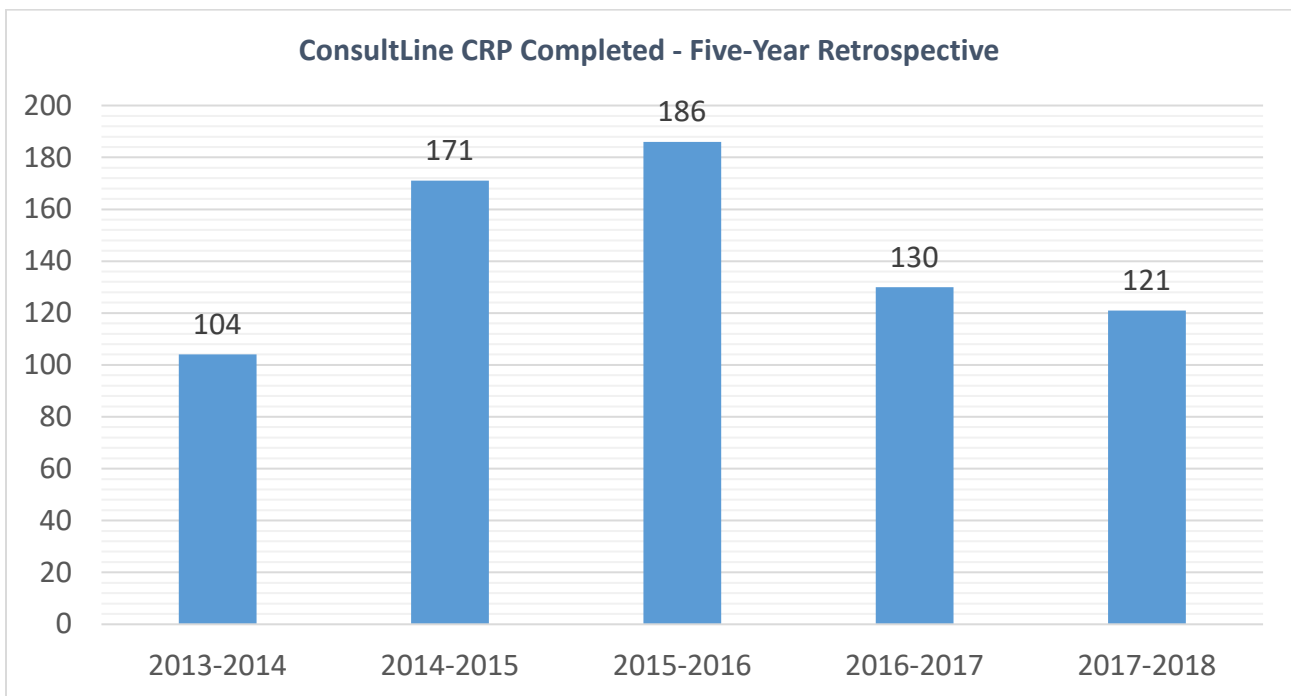
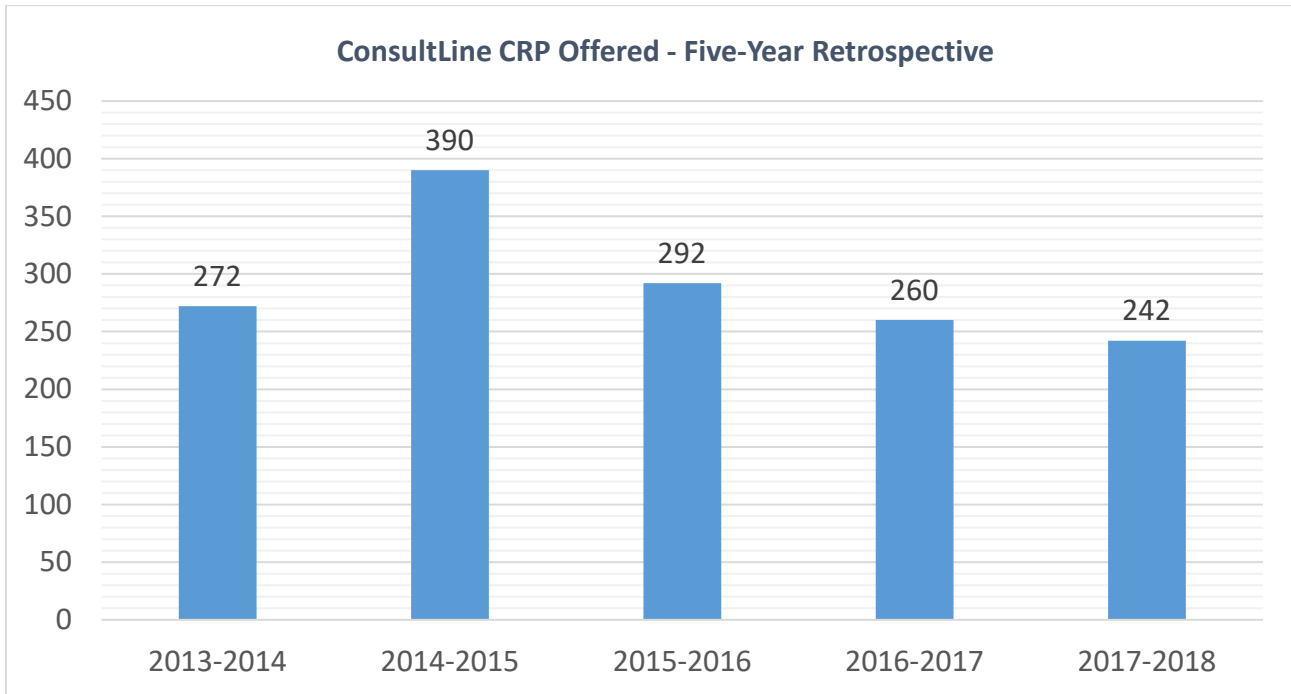
ConsultLine Specialists document the main topics associated with a caller’s question(s). During FY 2017-2018, the most regularly recurring topics, in order of frequency, pertained to the multidisciplinary evaluation; educational placement; IEP content; IEP implementation; and mediation. Other high interest topics included eligibility; Section 504; and advocates. Specialists provided publications, forms, web resources and other materials related to the caller’s interests in 1,576 instances; the majority of this information was delivered electronically.

Call Resolution Process and Provision of BSE Complaint Packets

ConsultLine’s Call Resolution Process (CRP) is an effective dispute resolution tool for compliance-related concerns for IDEA-related issues and certain types of concerns related to Section 504 of the *Rehabilitation Act of 1973*. During CRP, the Specialist acts as a conduit of information between the parent (as defined in 34 CFR 300.30) and the school; the Specialist does not serve as an advocate, decision-maker, mediator, or compliance advisor.

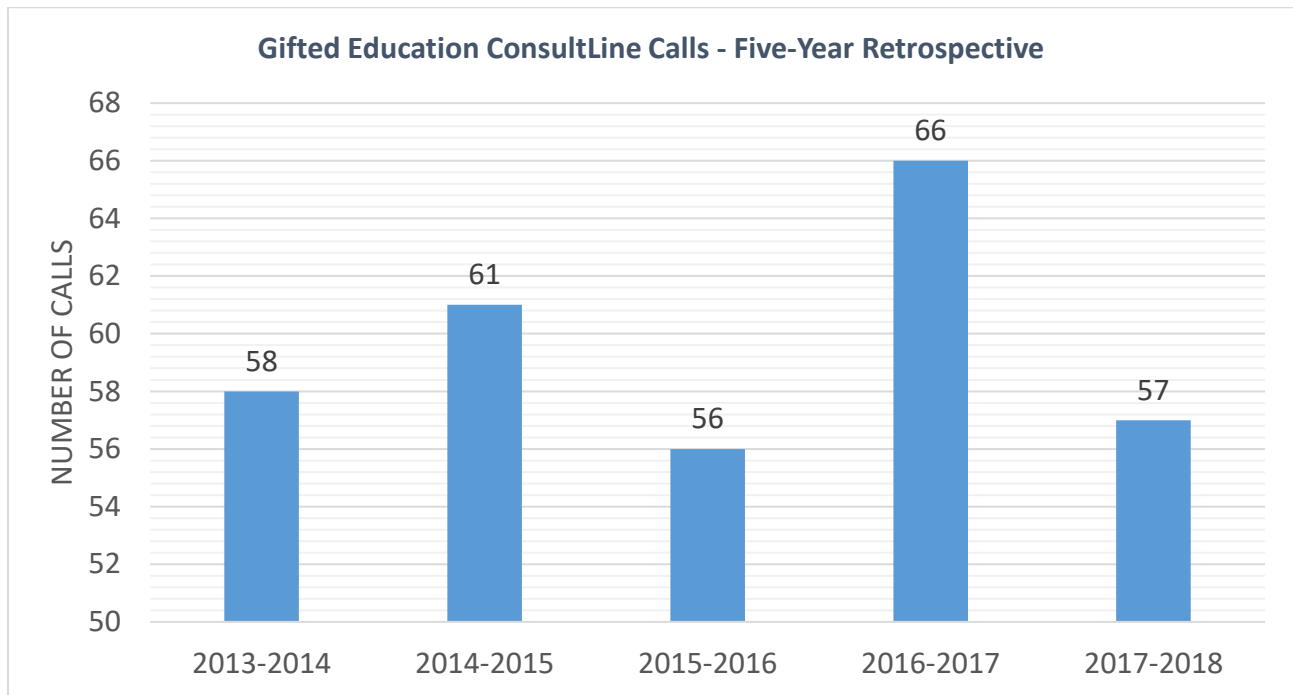
The CRP format and process includes an email summarizing the parent’s compliance-related concerns, and to the extent known, the parent’s proposed resolution. The email is prepared by the Specialist in consultation with the parent so that the message accurately reflects the nature of the issue. Once the message is drafted and reviewed with the parent, the parent provides verbal permission to send the message to the following recipients: LEA administrator responsible for special education; BSE division chief; and the regional BSE advisor. Once the email has been sent, the Specialist’s involvement in CRP has concluded. During FY 2017-2018, CRP was offered to 242 callers, and provided with the parent’s permission in 121 instances.

Information about the BSE complaint process and the state complaint form is sent to the parent when CRP has been implemented, but also when requested by the caller. During FY 2017-2018, 251 state complaint forms and information packets were distributed to callers.



Gifted Education

ConsultLine Specialists assist callers who have questions or concerns about Chapter 16/gifted education. Some of these callers allege compliance violations. When this occurs, the Specialist provides the caller with information about the procedural safeguards for gifted education including the option to file a written complaint. During FY 2017-2018, ConsultLine Specialists responded to 57 callers whose questions or concerns were specifically related to gifted education.



ConsultLine Feedback

When callers provide contact information, Specialists conclude service by mailing or emailing an evaluation survey to the caller. The survey is brief and it can be completed and returned anonymously. Survey participants are asked to provide comments and to answer several satisfaction-based questions.

During FY 2017-2018, 63 evaluation surveys were completed; the large majority were submitted electronically. Consistent with past years, survey results indicate satisfaction rates between 96.55% and 100%. Survey respondents assess the following areas: usefulness of information; identifying options for resolving concerns; timeliness of service; and general satisfaction. The following sample of comments received during FY 2017-2018 are consistent with past years.

"The consultant took as much time as I needed to answer my questions and concerns. It is very overwhelming as a parent to navigate the special education system and this resource is something I definitely plan to use again."

"I just want to thank you. I call your service often and am always treated with respect, honesty, and courtesy. It is greatly appreciated."

"I cannot say enough good things. For a parent this resource is extremely valuable. Thank you for being there to answer my questions."

"I felt like someone was finally hearing my concerns and I am grateful for the consideration and information. Thank you!"

Professional Development

ConsultLine staff continue to participate in high quality professional development opportunities to remain well informed and effective in conveying useful information and relevant resources to callers. During FY 2017-2018, professional development activities included topic discussions with ODR Hearing Officers; LRP National Institute; Lehigh Special Education Law Conference; Pennsylvania Bar Institute's Exceptional Children's Conference; and PDE's annual conference. Additionally, Specialists are involved in outreach activities and collaboration with cross-agency staff on various ODR, BSE, and CADRE initiatives.



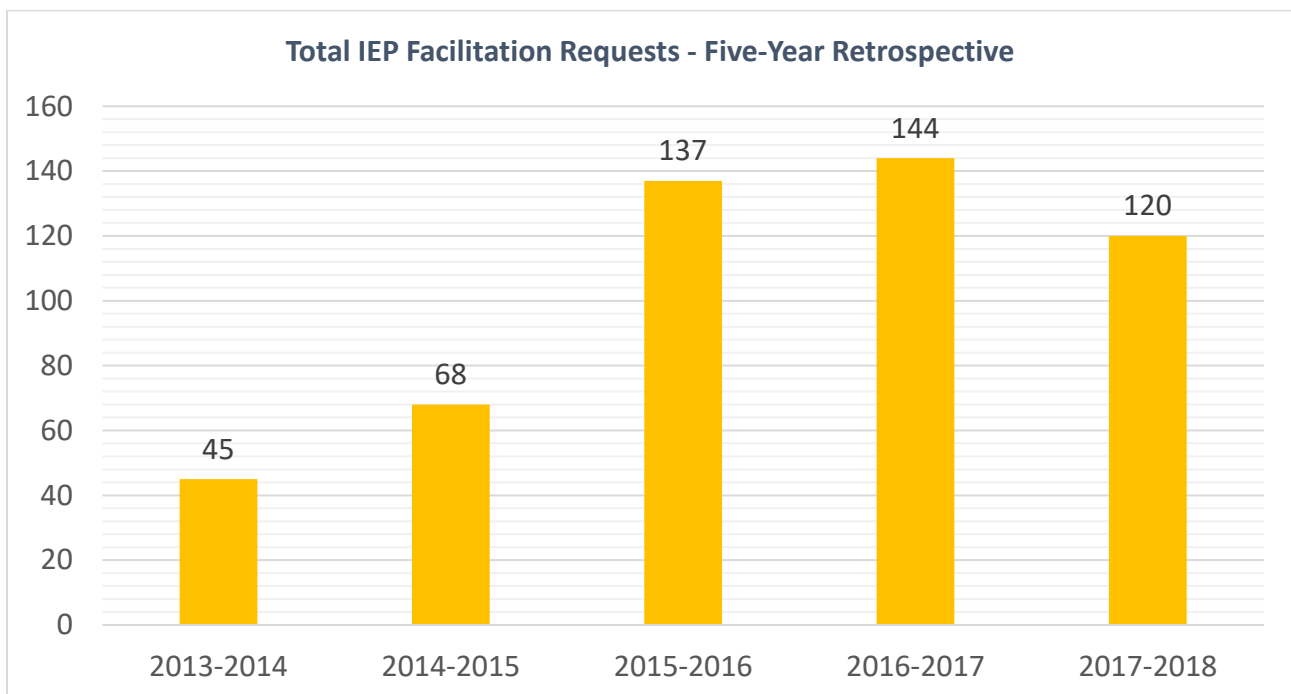
Resolution Meeting Facilitation

During FY 2017-2018, ODR received eight requests for RMF, with three moving forward. There was one active facilitation request at the time of this report. Of the three RMF that took place, one resulted in an agreement and two did not.

IEP/IFSP/GIEP Facilitation

IEP FACILITATION REQUESTS

The IEP Facilitation program saw a slight decrease in requests for facilitation services during FY 2017-2018. There were 120 requests for IEP Facilitation. There were 107 requests for IDEA school age cases; six requests for IDEA three-five cases; six requests for gifted education; and one request for Chapter 15/Section 504 issues.

There were no requests.

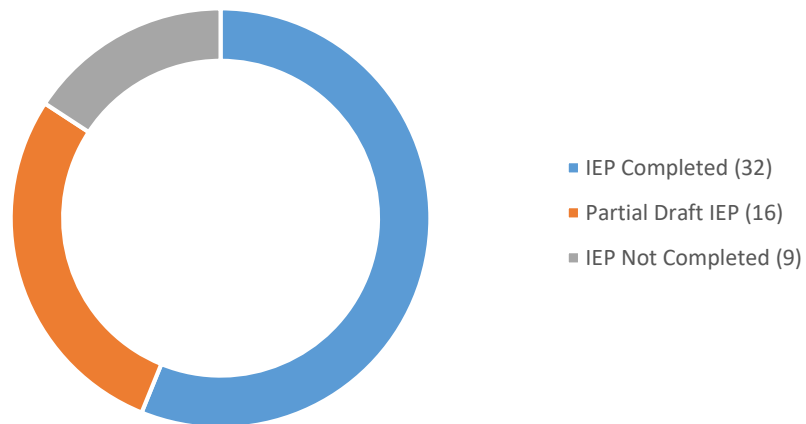
3-5 IDEA

There were six requests.

In one instance, an agreement was reached; in two instances, the non-requesting party declined to participate; there were two requests, which were subsequently withdrawn; and one request in which a facilitator was not able to be located.

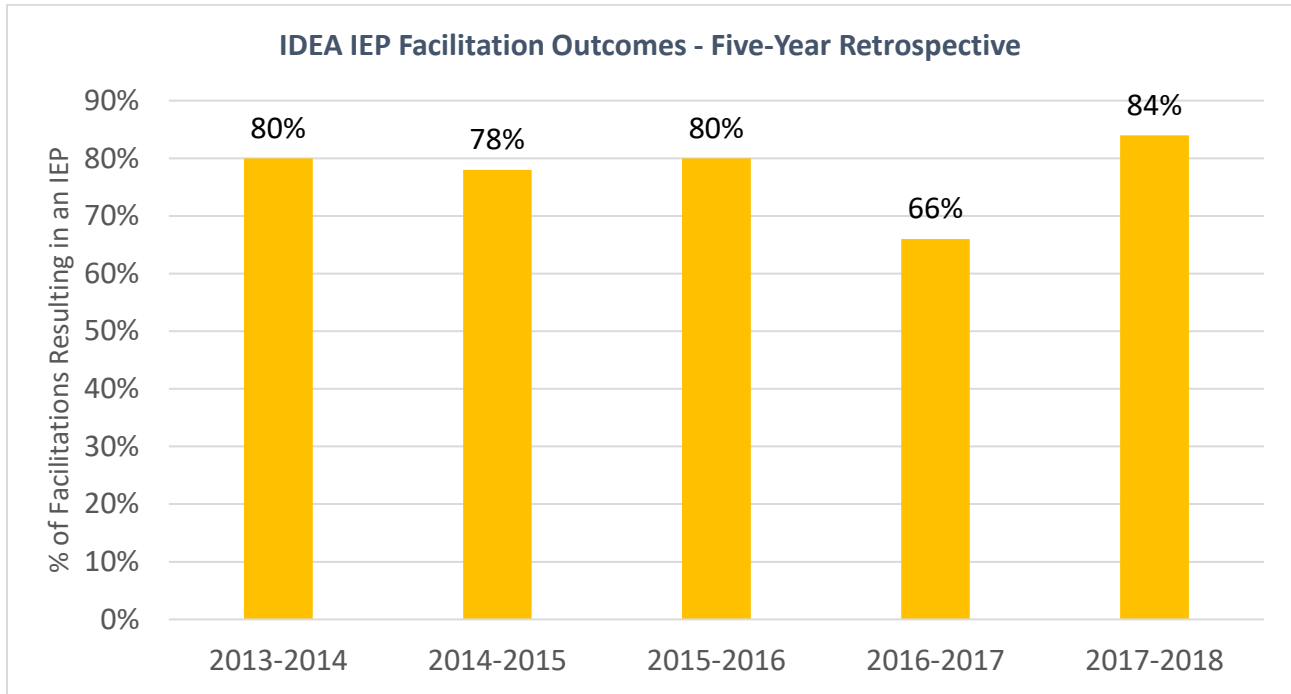
School Age IDEA

A facilitated IEP meeting occurred in 57 instances and resulted in the following:



IEP Facilitation is voluntary, so either party may decline to participate. This occurred with 46 instances. In 15 instances, the non-requesting party declined to use the service; in four instances, ODR received no response from the non-requesting party; in 25 instances, the request was withdrawn; and in two instances, ODR was unable to locate an available facilitator within the timeframe set for the IEP meeting. At the time of this report, four requests for IEP Facilitation remain active.

A five-year review of IDEA IEP Facilitation demonstrates that the agreement rate has increased for FY 2017-2018:



Chapter 15/Section 504

There was one request, which was subsequently withdrawn.

Gifted

There were six requests for GIEP Facilitation.

In one instance, there was a partial agreement; there was no IEP in one instance; one case was declined; and three cases were withdrawn.

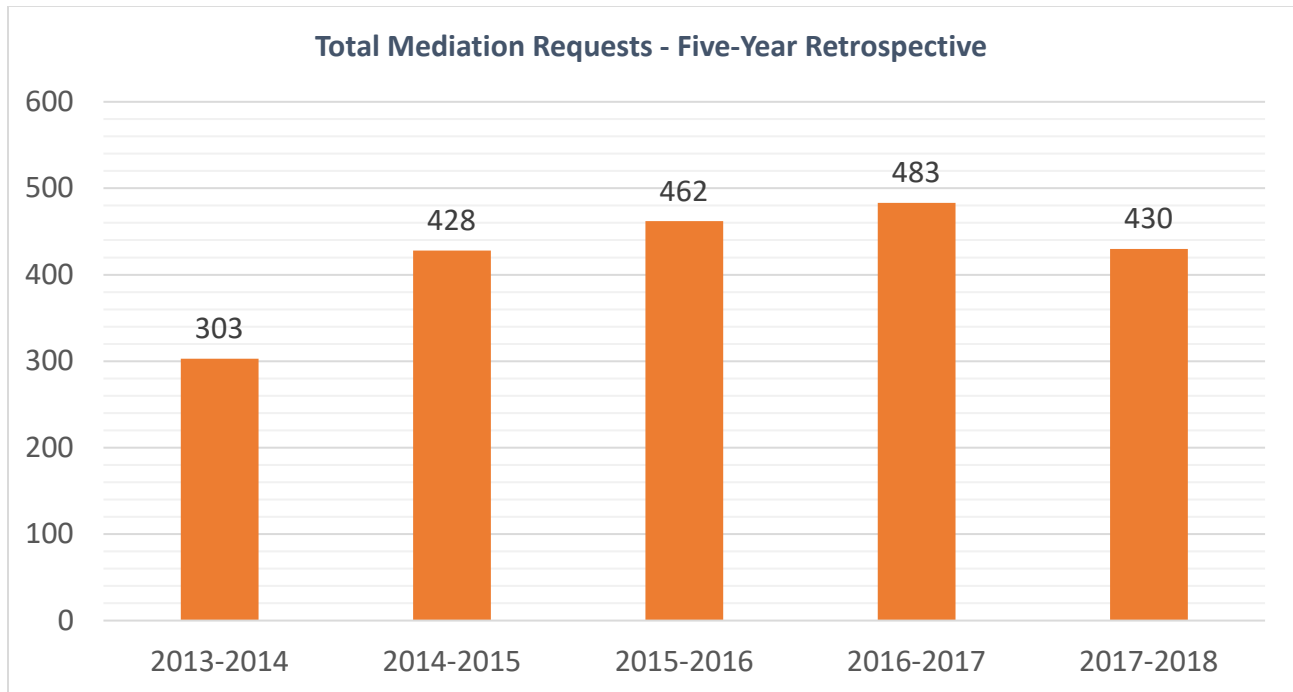

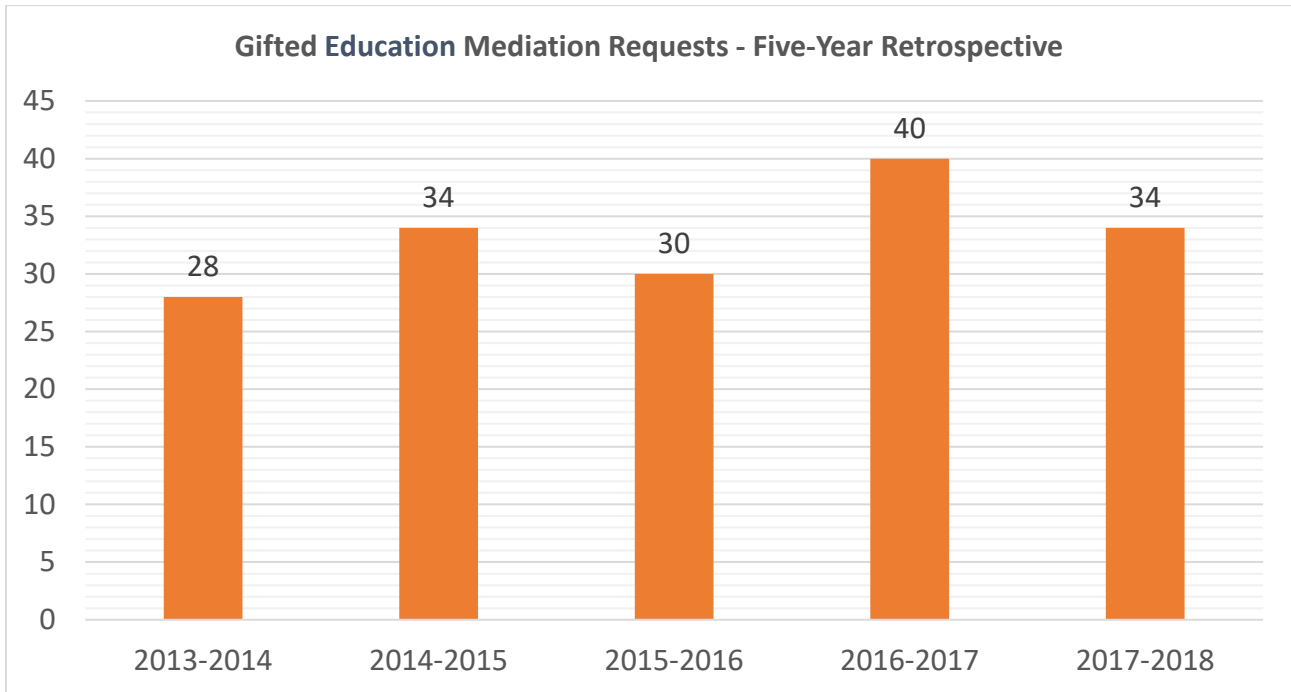
In FY 2017-2018, ODR contracted with 21 independent contractors to provide mediation services to parents and educators. Mediation is voluntary, and therefore, both the parent and LEA must agree to participate in mediation for it to be scheduled and held.

MEDIATION REQUESTS

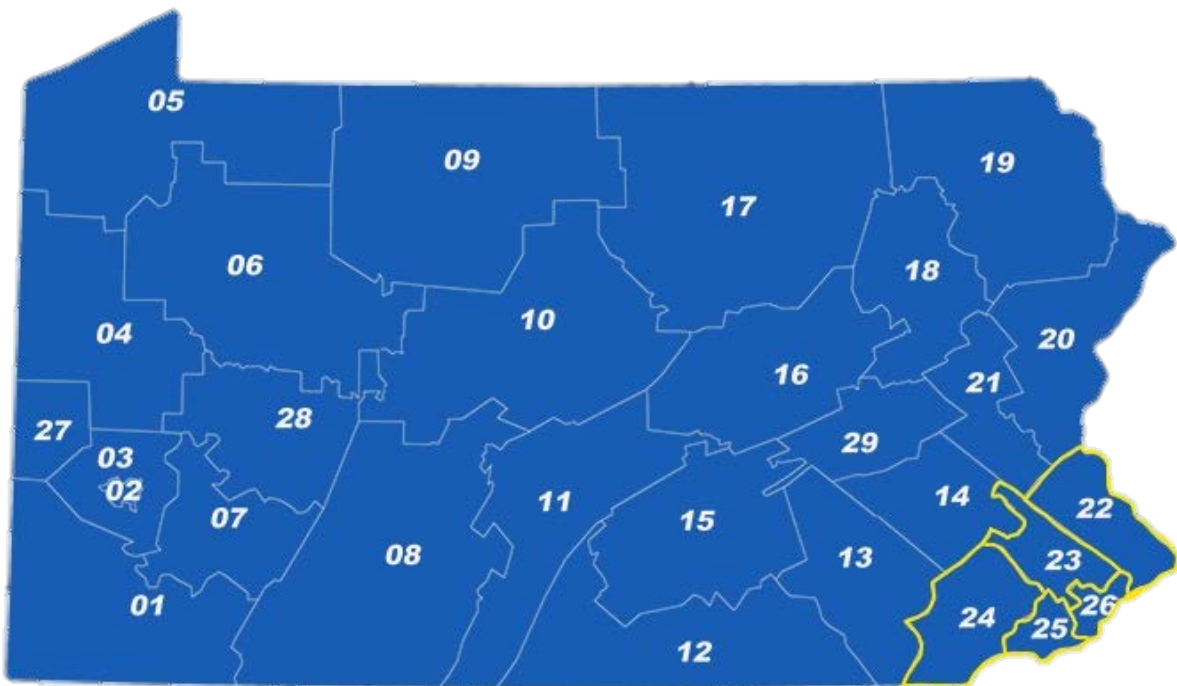
ODR received 430 requests for mediation during FY 2017-2018, which is slightly under from the previous reporting period, consistent with national trends governing mediation.



The requests for gifted education mediation has slightly decreased during this reporting period.



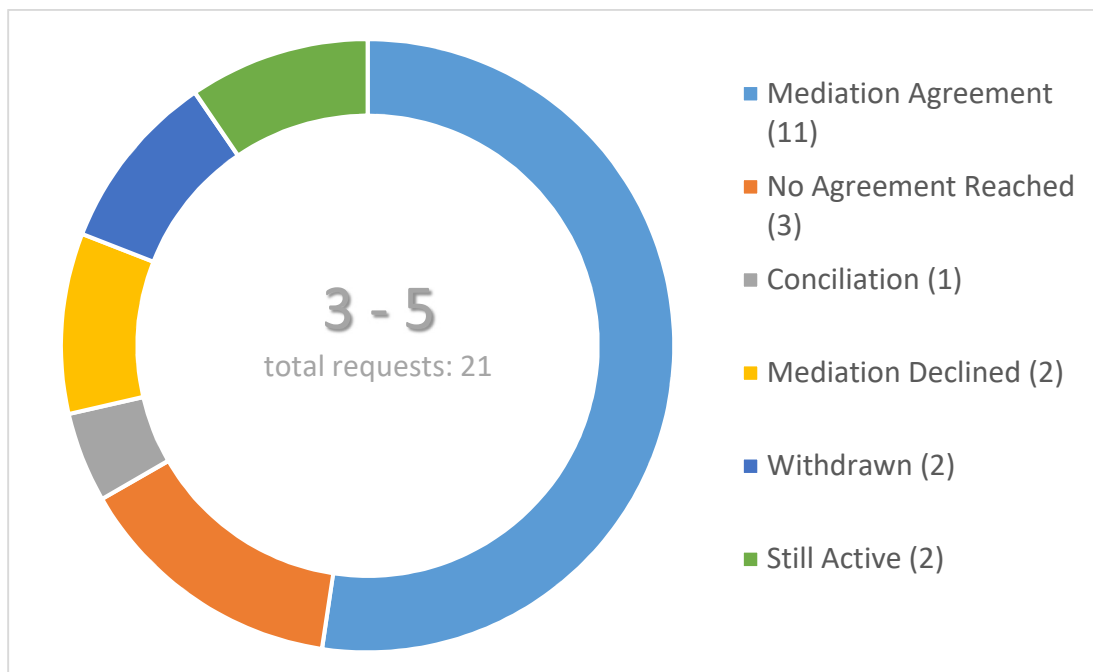
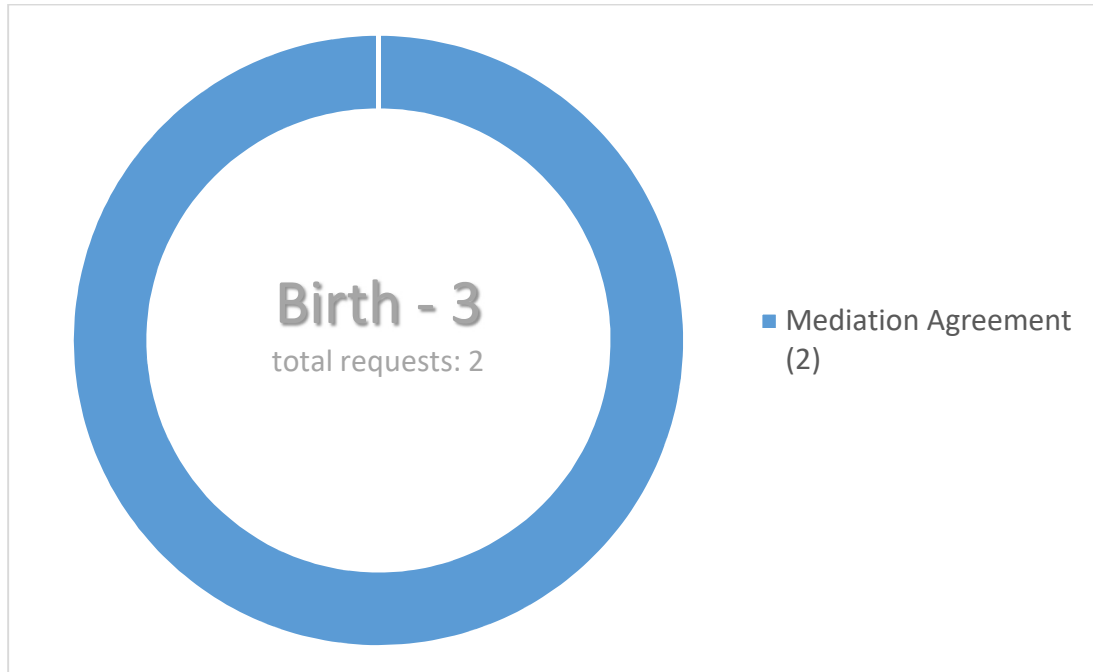

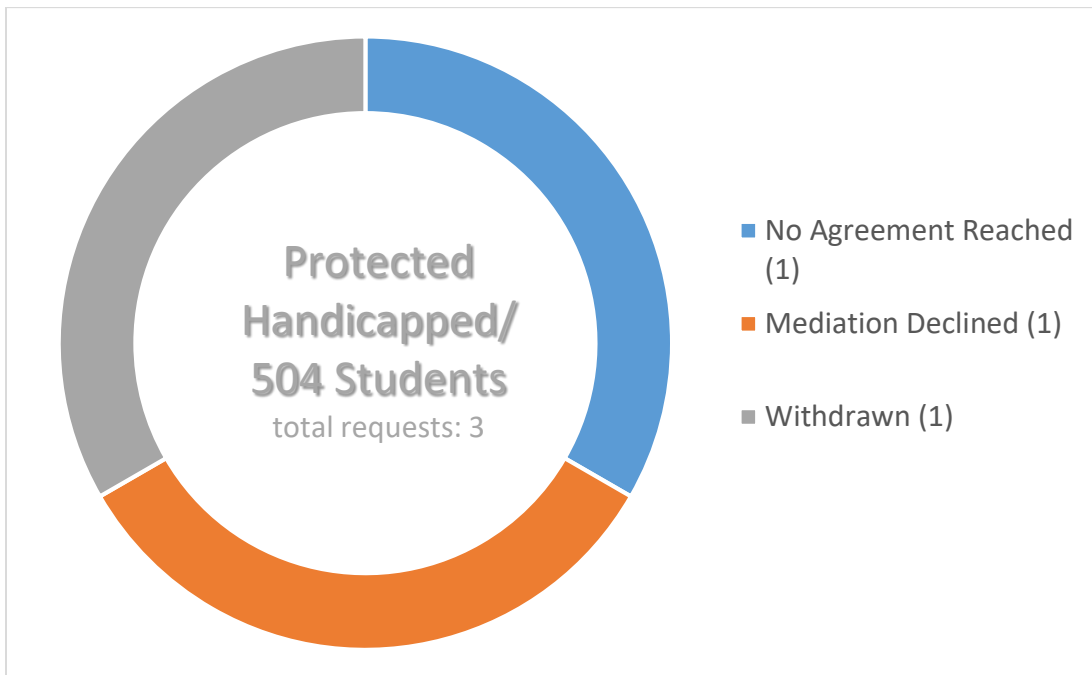
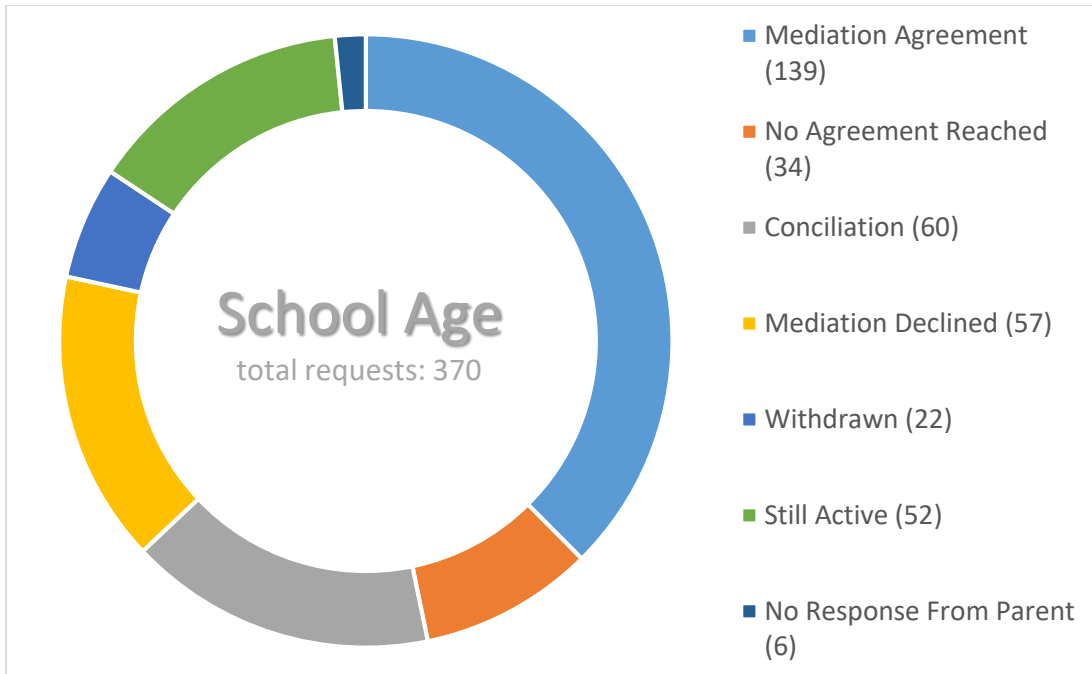


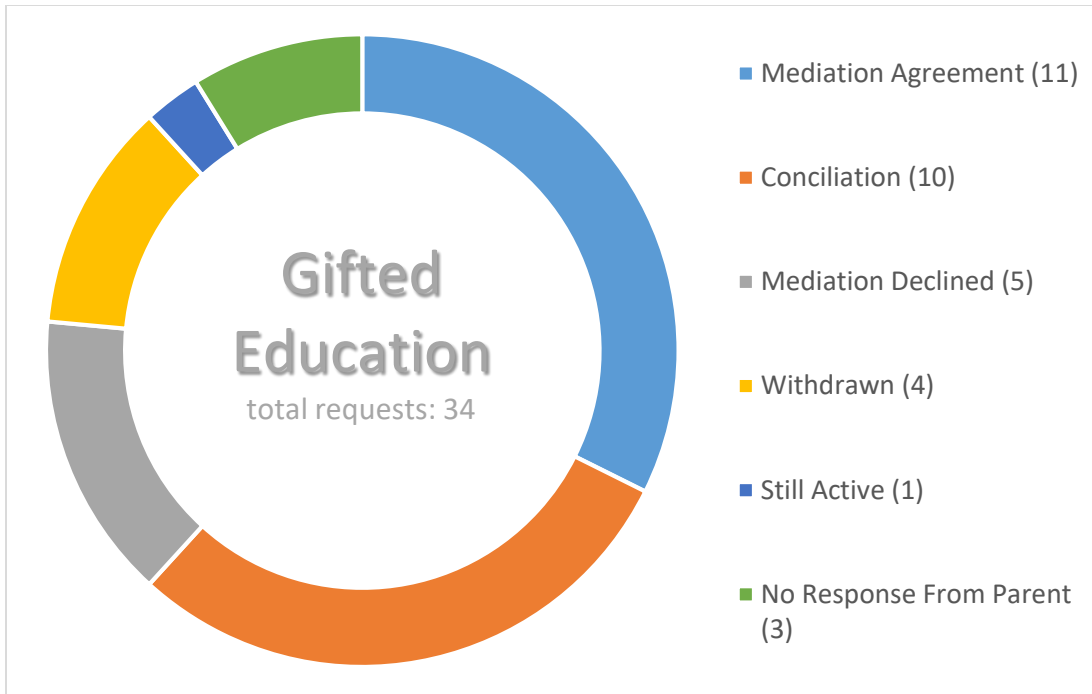
MEDIATION OUTCOMES

Of the 430 total requests, 174 did not result in a mediation because the parent did not respond to the request (9); the non-requesting party declined to participate (65); or the parties resolved (71) or otherwise withdrew the request for mediation (29).

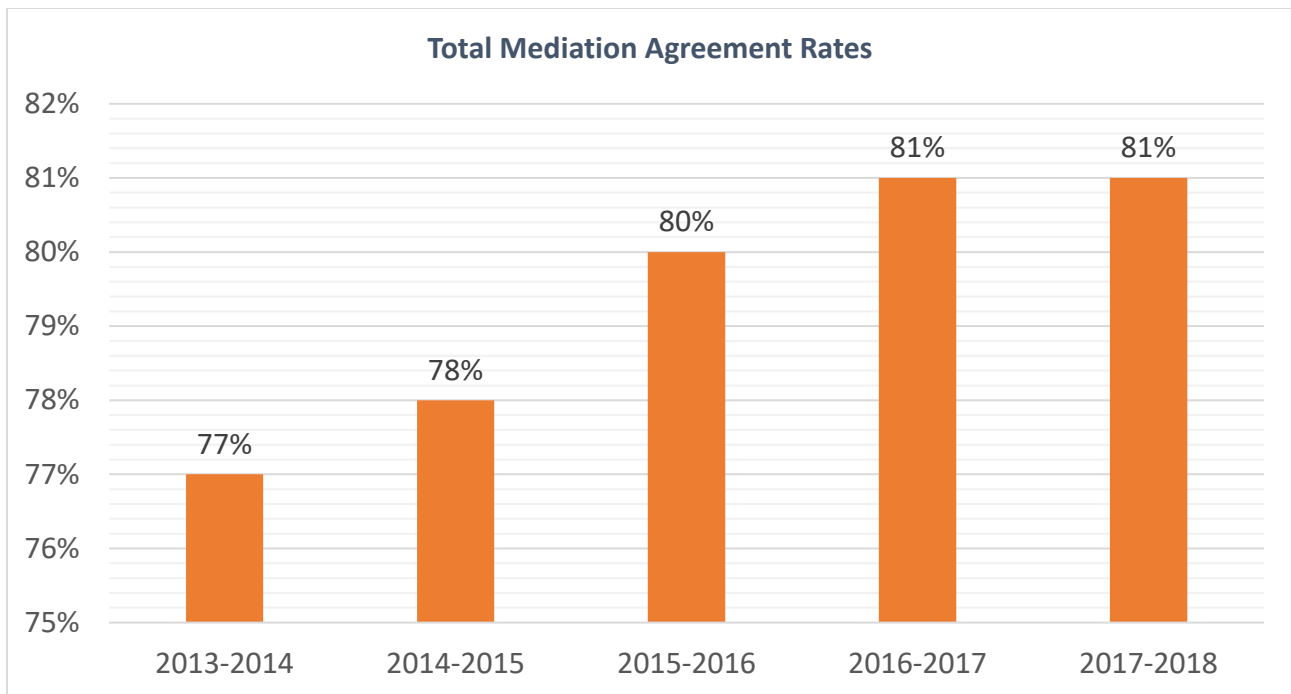
2017-2018 Mediation Results by Age and Exceptionality

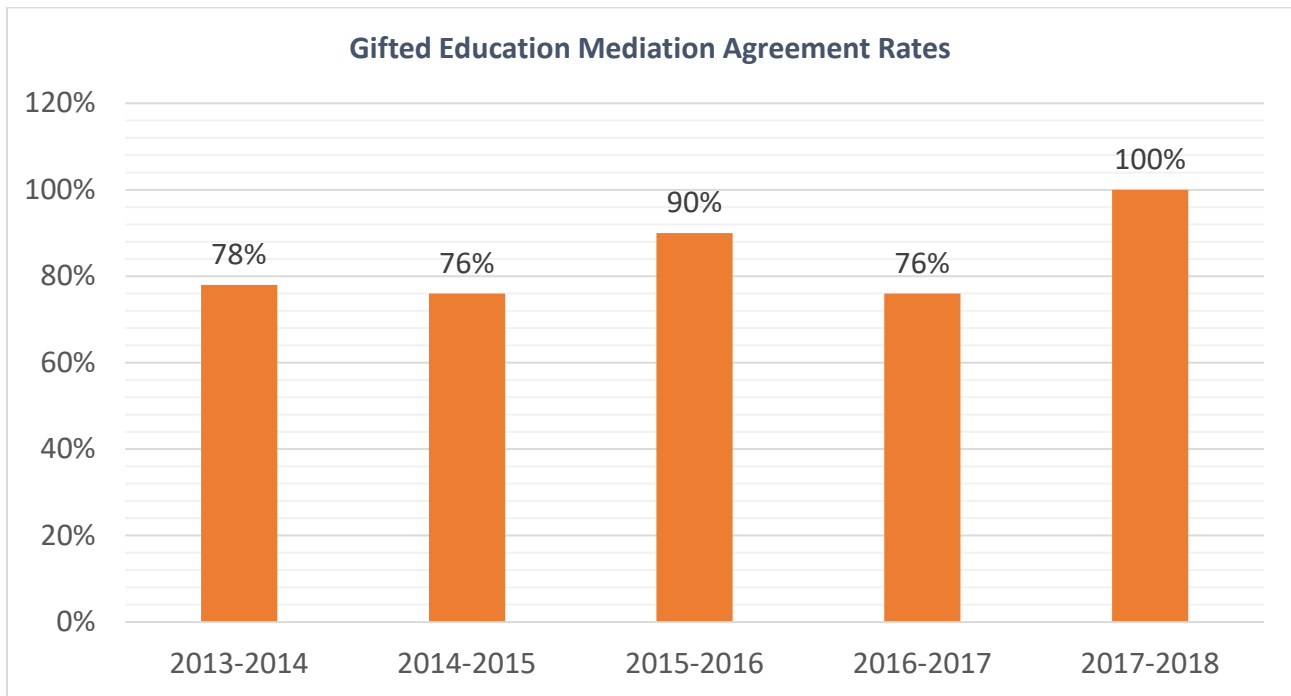






Five-Year Retrospective of Mediation Agreement Rates





MEDIATION ISSUES

The most prevalent and recurring issues addressed in mediation were divided among age groups and exceptionalities as follows:

For Birth – 3, related services was the prevalent issue.

For Children ages 3 – 5 and school-aged students, placement, related services and IEP issues were the prevalent issues.

For Protected Handicapped/504 Students, Chapter 15/Section 504 were the sole issues.

For Gifted Education cases, eligibility, GIEP issues and evaluation were the prevalent issues.

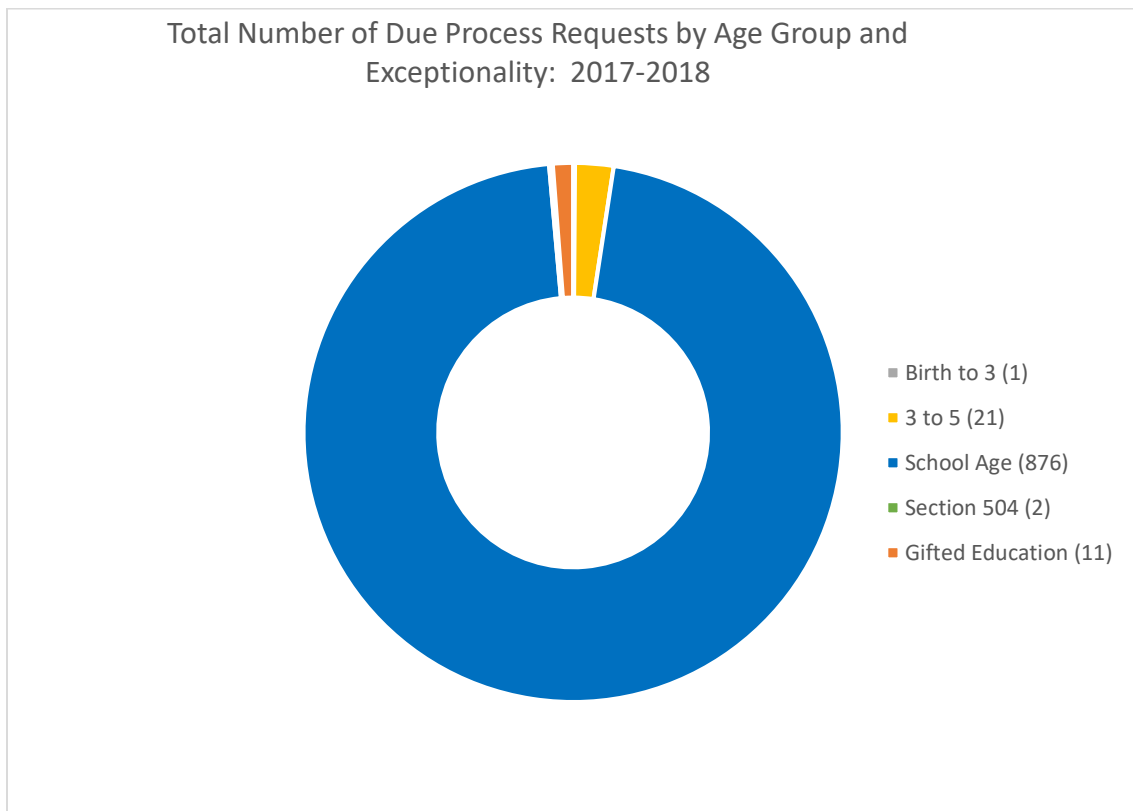

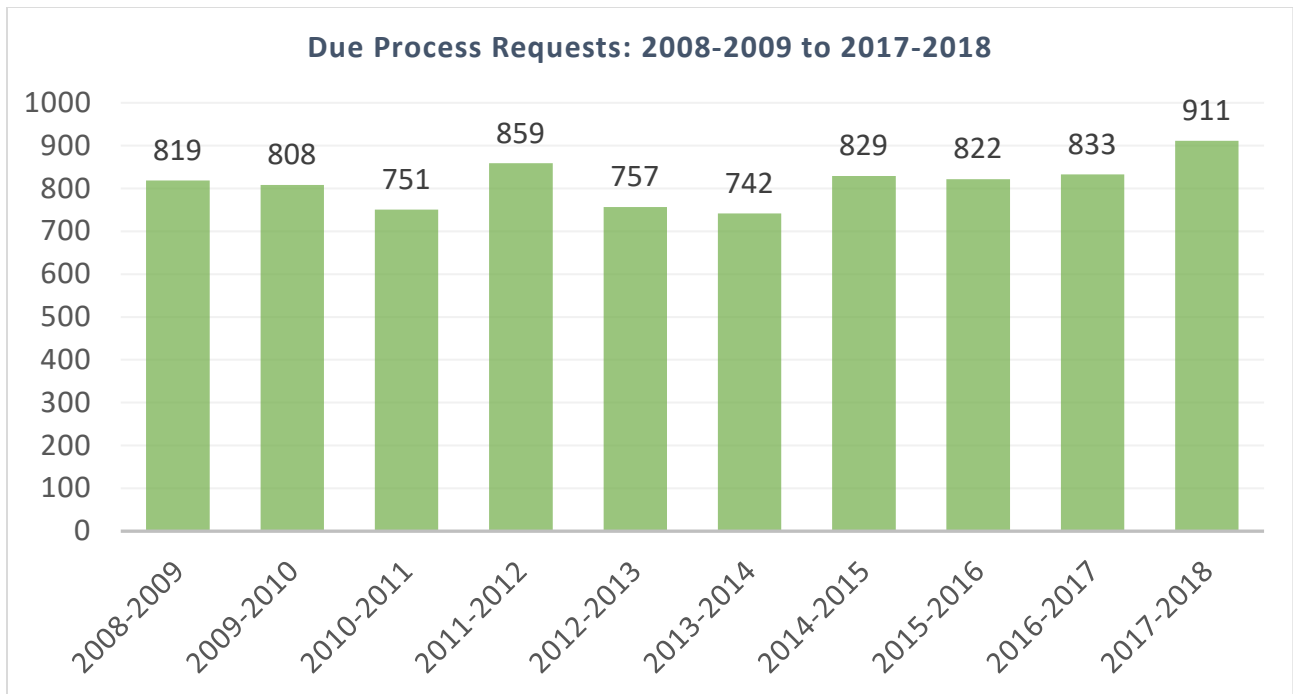

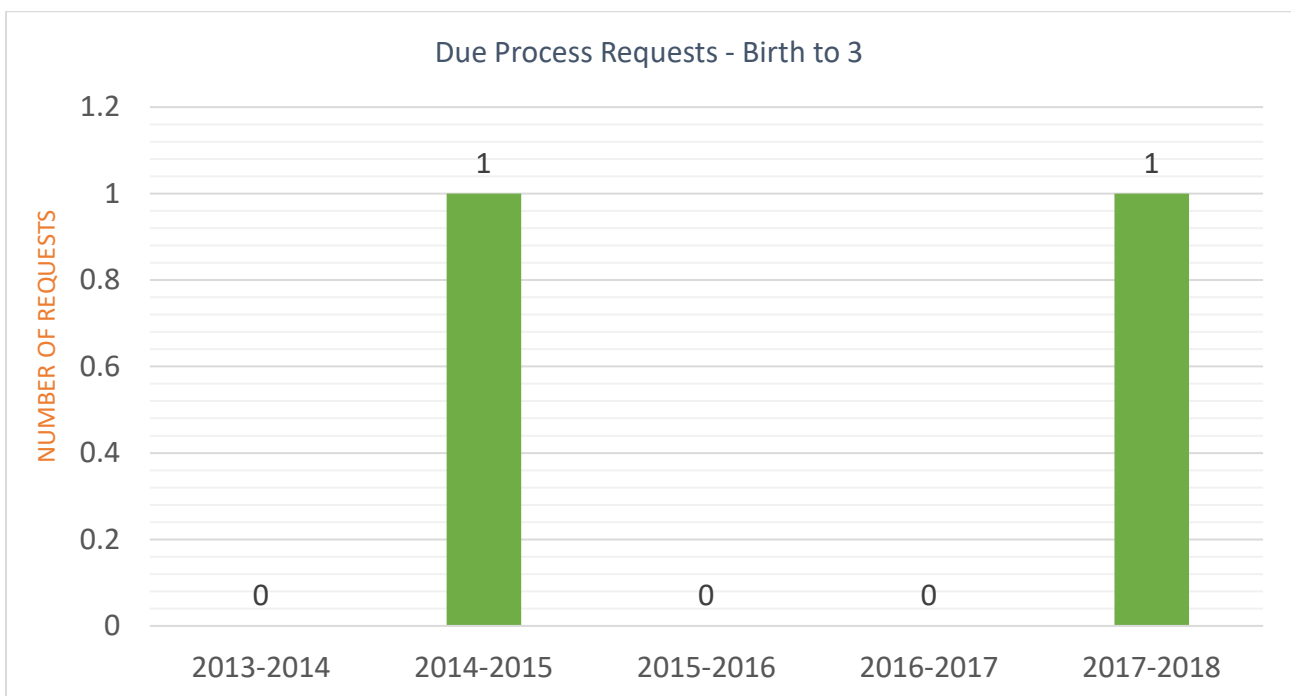
Due process was requested a total of 911 times during FY 2017-2018.

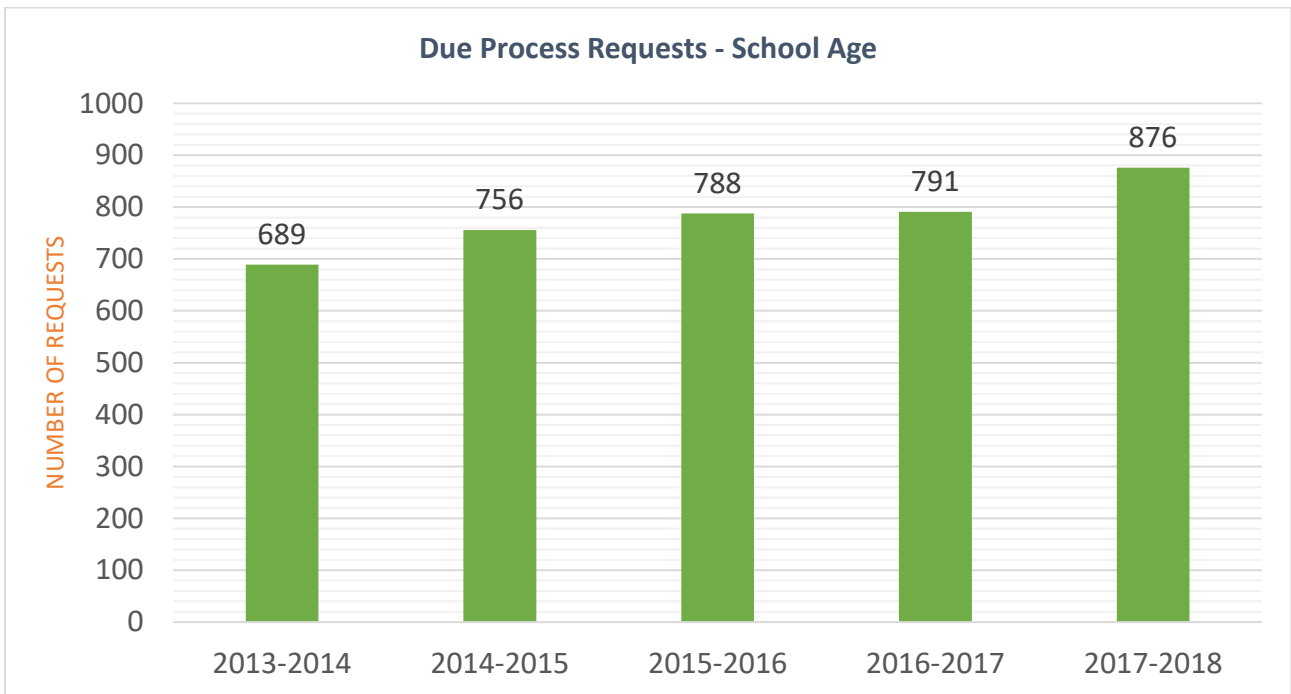
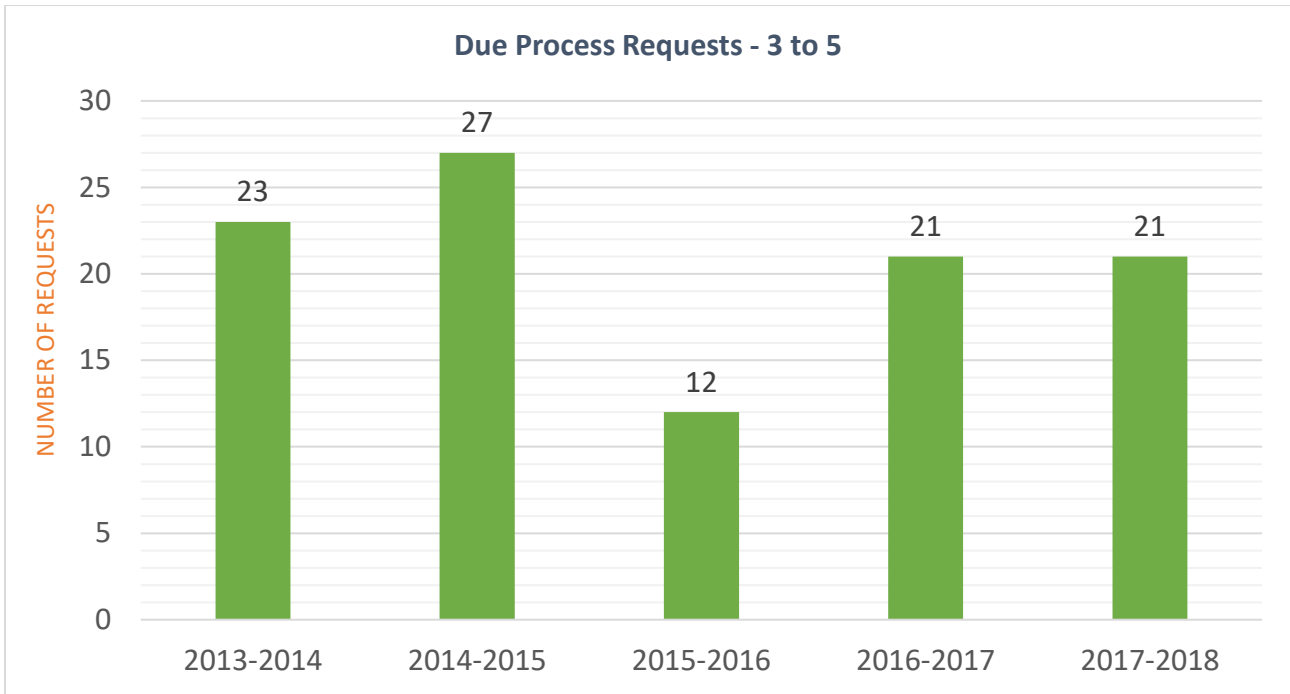


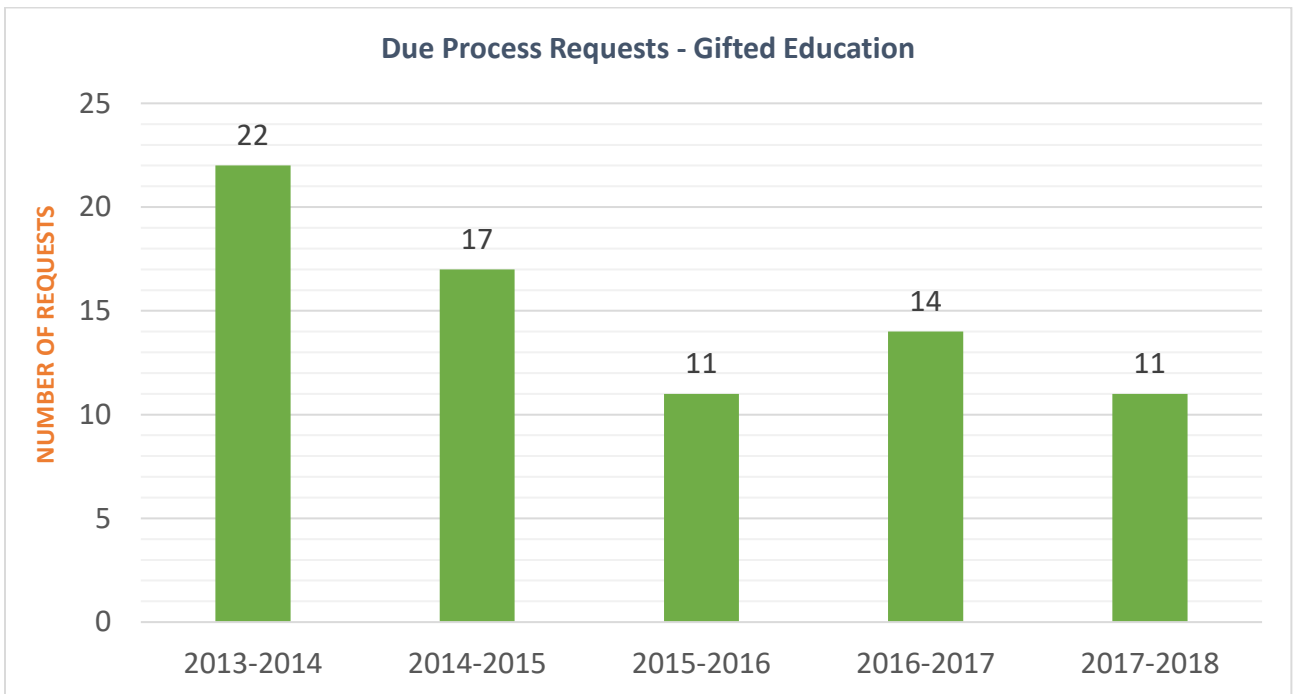
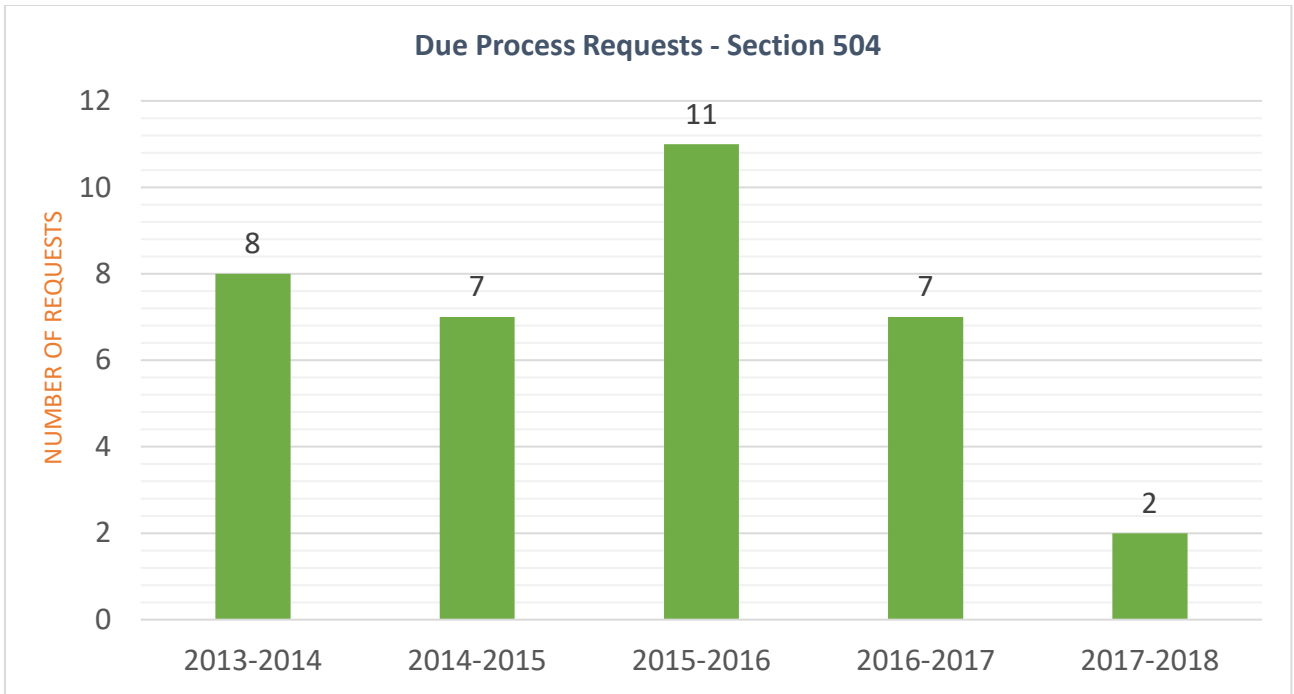
The number of requests has remained fairly stable in the last decade, with a slight increase during the reporting period.



Five-Year Retrospective of Due Process by Age Group







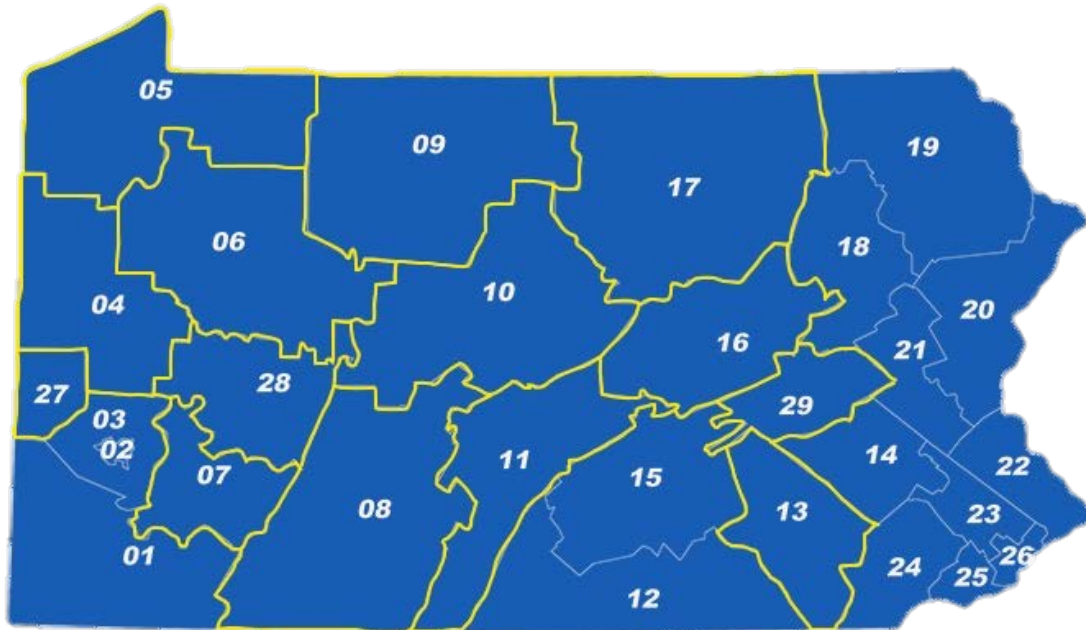
Frequency of Due Process Requests By Intermediate Unit

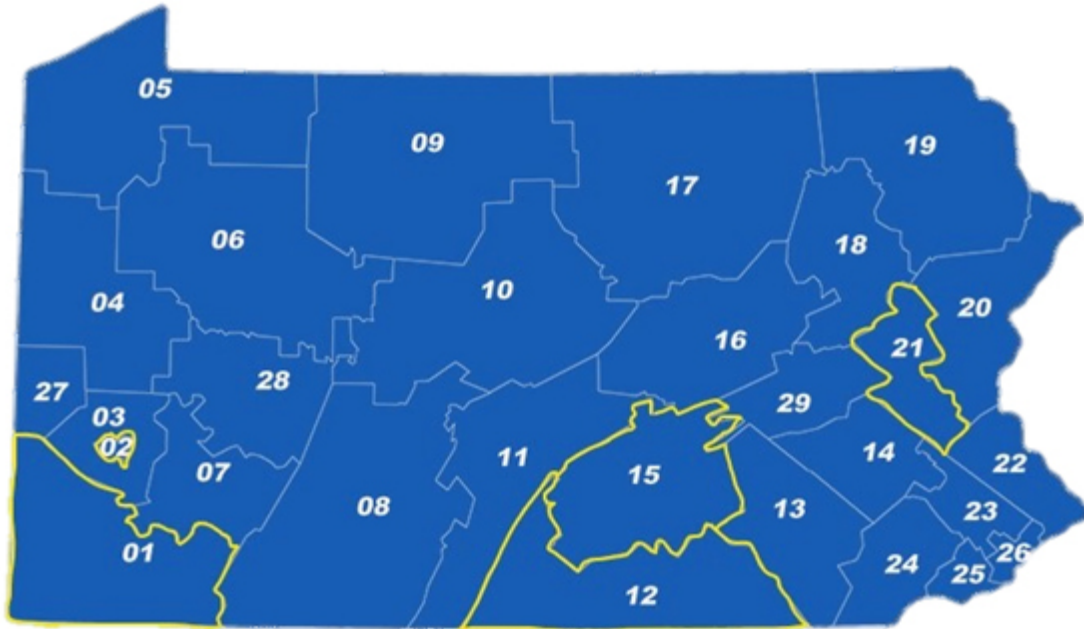

Five-Year Averages for All Intermediate Units

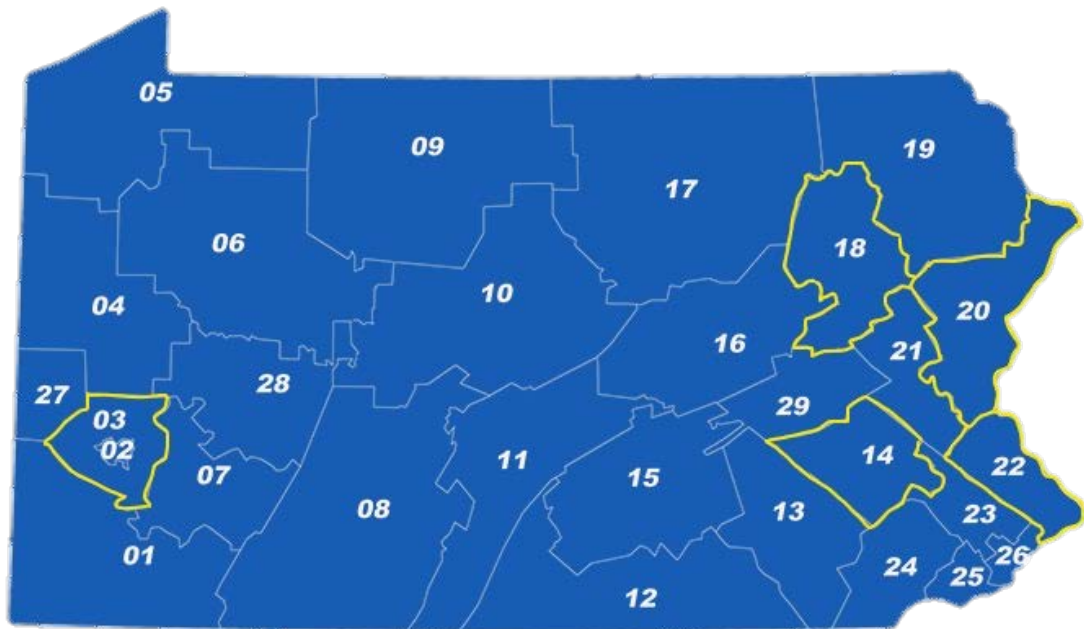
**Intermediate Units with an Average of Less Than 10 Due Process Requests
(2013-2018)**



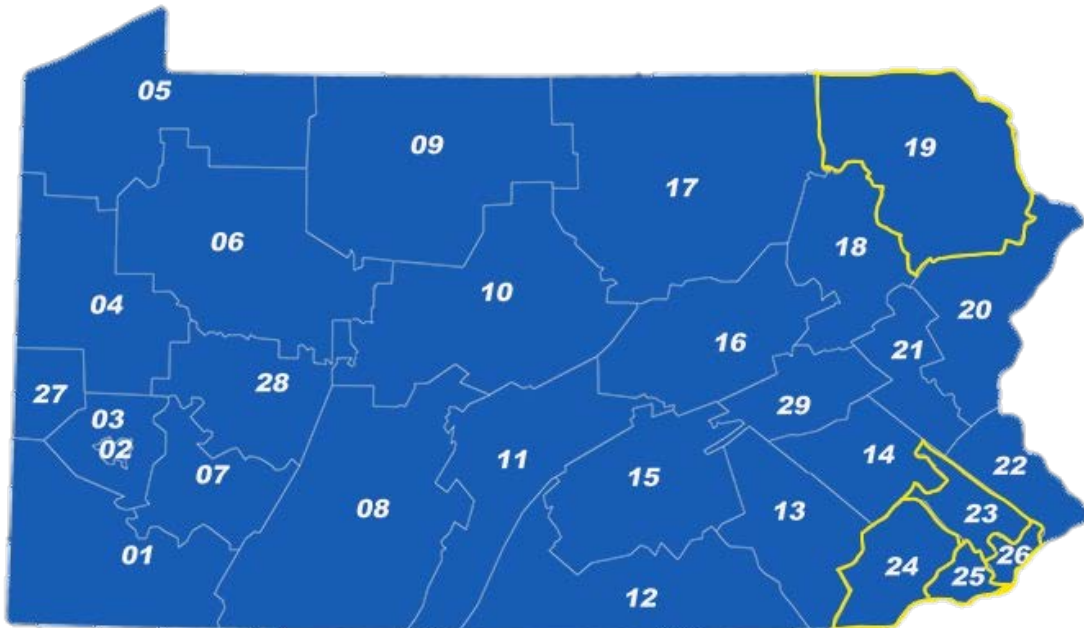
**Intermediate Units with an Average of 10-29 Due Process Requests

(2013-2018)**



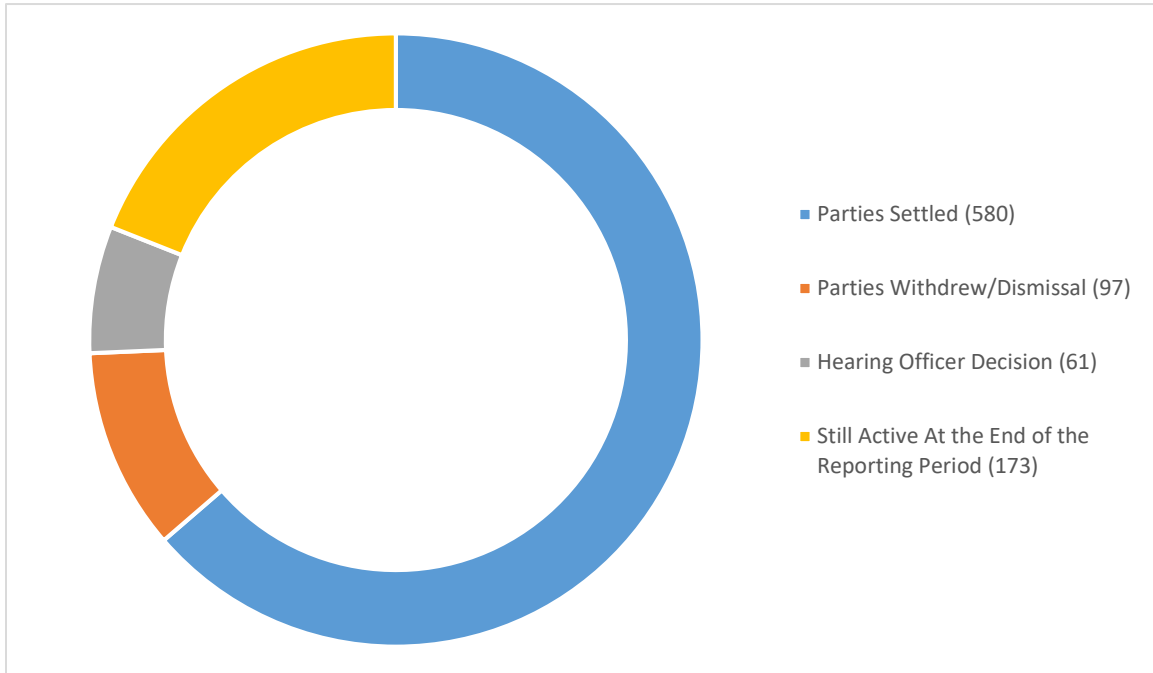
**Intermediate Units with an Average of 50 or More Due Process Requests
(2013-2018)**



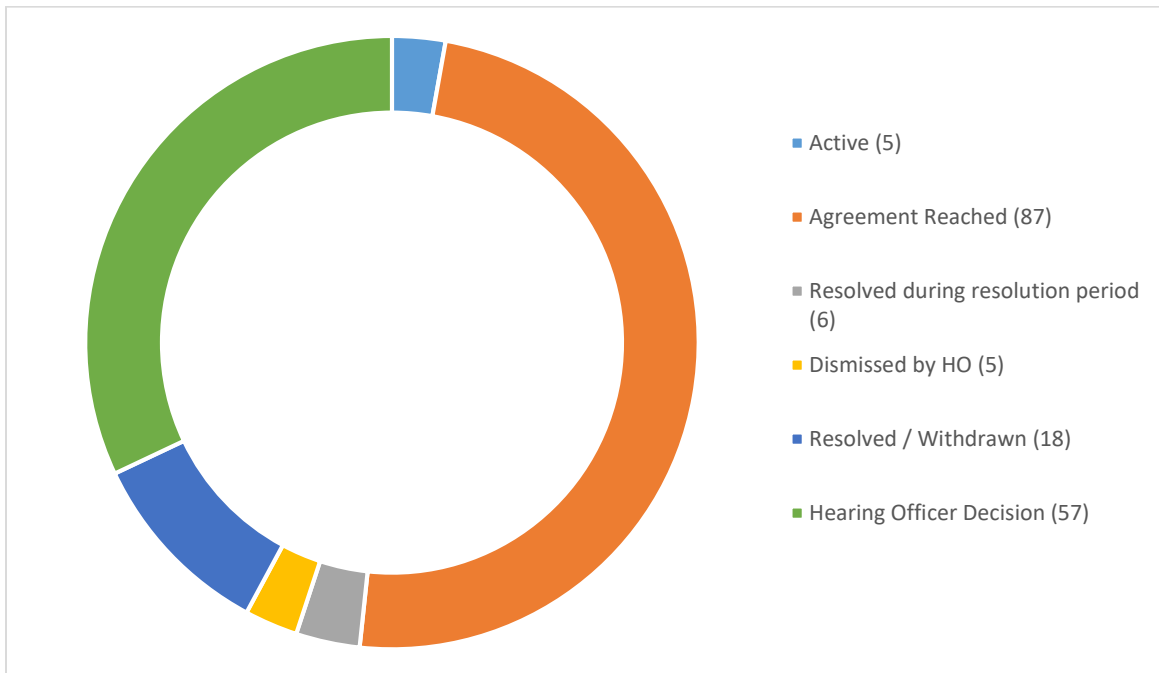

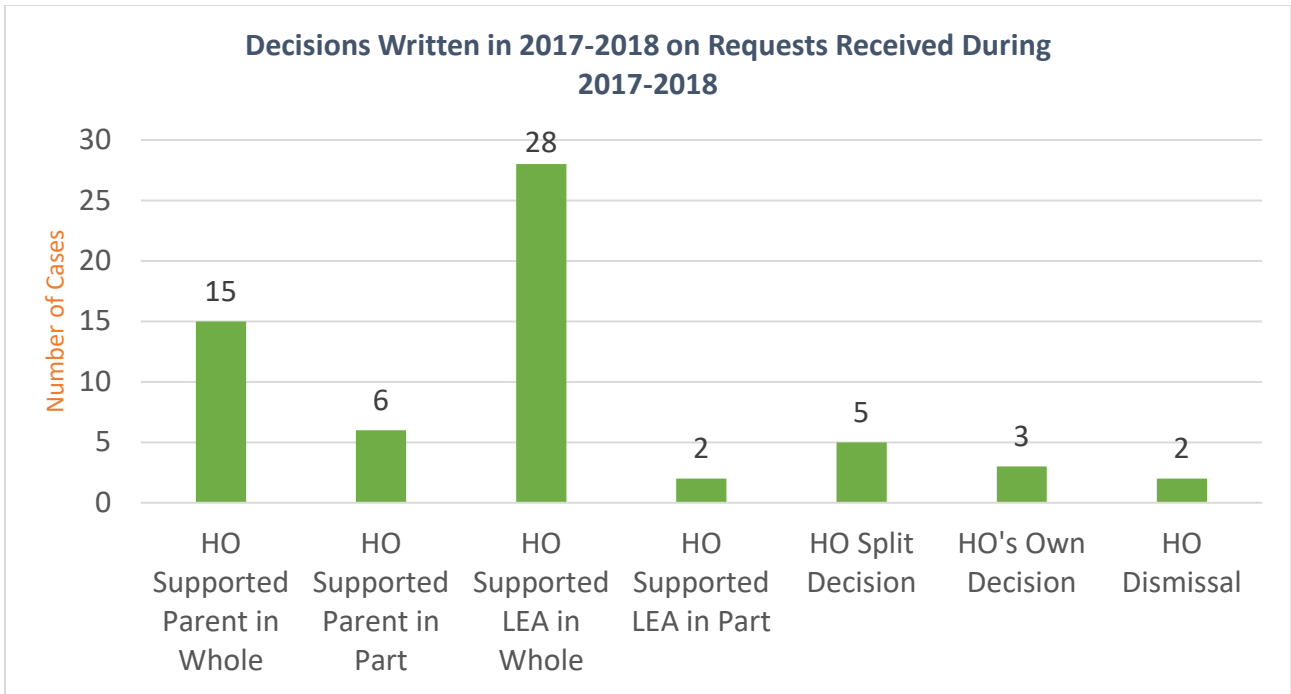

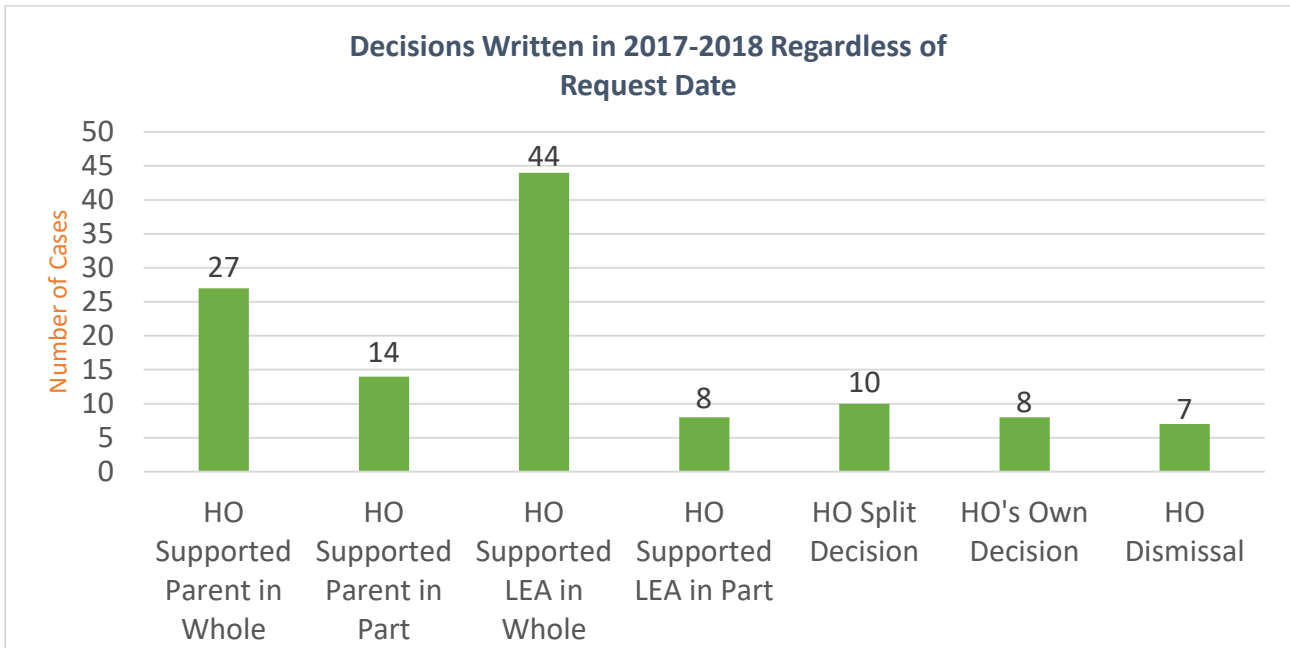

The hearing officers wrote a total of 118 decisions, including decisions pertaining to 2017-2018 requests, as well as requests received prior to FY 2017-2018.



Appeals to State and Federal Court

During FY 2017-2018, there were 24 appeals to state or federal court; only seven of these appeals pertained to 2017-2018 requests for hearing, with the balance pre-dating the reporting period. The appellant chose federal court in 88% of the appeals. Parents accounted for 75% of the total number of appeals received. As of the close of the reporting period, 20 cases were still in progress and one case was dismissed.
