Introduction

The Office for Dispute Resolution (ODR) provides the resources for parents and local educational agencies (LEAs) to resolve educational disputes involving children served by the early intervention system, and students with disabilities (or thought to have disabilities) and students who are gifted (or thought to be gifted). Pennsylvania's recognition as an "exemplar state" by the Office for Special Education Programs (OSEP) and the Center for Appropriate Dispute Resolution in Special Education (CADRE) is an acknowledgement of the array of quality services offered by ODR.

ODR Stakeholder Council

The ODR Stakeholder Council (SC) brings together representatives from a broad array of stakeholders to provide functional input and recommendations on the special education dispute resolution system. The membership consists of three parent advocates; a representative from a Parent Training Information Center; three attorneys (parent, school district, and ODR counsel); a school district representative; and one representative each from the following stakeholder groups: autism, mental health, gifted, and higher education. Detailed biographical information on each SC member is available on the ODR website. The Council is self-sustaining, i.e., the members themselves, not ODR staff, choose their replacements.

During FY 2013-14, the SC provided insight and feedback about a myriad of issues involving the dispute resolution system, including: Evaluative Conciliation Conferences; IEP Facilitation; and pilot projects regarding virtual due process hearings, and the electronic submission of due process hearing exhibits. Evaluative Conciliation Conference, or "ECC", is the newest service offered by ODR. Due process hearings are an important procedural safeguard for parents; however, most special education disputes settle without the need for a fully-adjudicated due process hearing. Many of these cases might benefit from the assistance of someone knowledgeable and impartial to offer an informed opinion toward reaching agreement. This is the basic concept of Evaluative Conciliation Conferences (ECC).

During the first phase, the ECC Consultant provides an assessment of the strengths and weaknesses of each party's position based on her understanding of the law and on her analysis of hearing decision and case law trends for similar types of issues. Often times, the ECC assessment is sufficient in assisting the parties in resolving the dispute without the need for a due process hearing. However, the parties also have the option of engaging in the second phase of ECC, where the ECC Consultant facilitates discussions with the parties in an effort to reach agreement on some or all of the issues. The parties then execute a settlement agreement. Attorney Rosemary Mullaly serves as the ECC Consultant, and her biographical information is available on the ODR website.

ODR has been offering IEP Facilitation since the early 2000s, long before most states developed such a program. Since the commencement of this service, IEP Facilitation theory and practice has become more refined, as more states continue to explore its use. In January 2014, the ODR Director was invited by the Center for Appropriate Dispute Resolution in Special Education (CADRE), the national technical assistance

center, to discuss Pennsylvania's program at a meeting convened to share information about different state's programs. In attendance at the meeting were representatives from states at various stages of developing IEP Facilitation programs. Each state's program had its unique features, and this information is being examined by ODR staff as part of the wholesale re-evaluation of Pennsylvania's program¹. A subcommittee of the SC has been formed to assist in examining the configuration of ODR's model, to assess its viability, and areas for refinement and improvement. The goal is to optimize the service and increase its use, thereby attempting to further reduce the number of due process hearings each year.

During FY 2013-2014, ODR explored the possibility of how technology could best be used in the due process hearing setting. The impetus for the pilot, spearheaded by Hearing Officers McElligott and Skidmore, was twofold: First, internet-based technology has changed, and continues to change most aspects of personal and professional lives. Over time, and not surprisingly, anecdotal considerations by due process participants surfaced concerning how technology could be incorporated into the hearing process; and 2) for varied reasons, school budgets have come under increasing pressure, and both government-related agencies (federal, state, and local), as well as private industries are increasingly looking for ways to improve efficiencies in challenging fiscal environments. Forward thinking participants in any system or organization are cognizant of the likelihood that the need to create such efficiencies is likely to increase, not decrease, in the future. For these reasons, not the least of which was stakeholder interest in the topic, HOs McElligott and Skidmore devised a detailed framework for approaching the topic, from extensive technology explorations and consultations, to solicitation of volunteers to participate in mock virtual hearings. A series of interim recommendations and conclusions have been compiled and reported to the SC. This pilot will continue into the next fiscal year.

Similarly, stakeholders have also raised the issue of electronic (versus paper) exhibits at due process hearings. This issue gains increasing importance, as more and more courts insist that parties submit appeal documents electronically. HO Brian Ford is spearheading this pilot, which is in the initial stages. This pilot will also continue into the next fiscal year.

Throughout the year, the SC has provided valuable feedback on these large initiatives, as well as smaller issues as they arose. One of the most critical roles of the SC is to interview prospective hearing officers and make selection recommendations. It is anticipated that the SC will be called upon to perform this function in the near future as one or more hearing officers announce retirement plans.

¹ The value of this cross-state sharing of information cannot be overstated. During the fiscal year, New Jersey Hearing Officers (HOs) asked to consult with ODR hearing officers on hearing procedures. The NJ HOs observed, with permission of the parties, a hearing conducted by HO McElligott. The District of Columbia and the Illinois Department of Education consulted with Suzanne McDougall, ODR Program Manager, to discuss ConsultLine and IEP Facilitation procedures respectively. ODR learned that its video *A Tale of Two Conversations* is not only posted on the CADRE website, but has also been used by USC's master's program in school leadership, and the Ohio Coalition for the Education of Children with Disabilities, and its parent advocacy training program.

During FY 2013-2014, ODR participated in a pilot project with Dr. Trish Jones of Temple University on conflict coaching. This pilot has continued into the next fiscal year. The pilot focuses on conflict resolution at the local level by training administrators, teachers, and parents to become conflict coaches. Trainings were held at Southeast Delco and Abington School Districts, and follow up is now underway on local implementation and evaluation.

Stakeholder Education and Presentations

Stakeholder education is a priority initiative for ODR. Throughout the year, ODR staff and hearing officers were frequent presenters on special education dispute resolution, and special education law at major conferences and other meetings. The ODR Director and Program Manager continued to provide *Creating Agreement*, a conflict resolution training, to various populations.

ConsultLine

The Special Education ConsultLine is a toll-free information helpline for parents and advocates who have questions or concerns about special education for school-age children. ConsultLine is staffed by three Specialists who provide information about special education, gifted education, and Section 504 of the *Rehabilitation Act of 1973*. During a ConsultLine call, Specialists assess the nature of the caller's concern and depending on the nature of the caller's inquiry, the Specialist will:

- Describe the processes involved in having a child evaluated, identified, and provided with special education, accommodations, and related services;
- Explain the procedural safeguards and educate parents about the regulations:
- Provide information, assistance and access to the state complaint process managed by the Department of Education's Bureau of Special Education (BSE);
- Discuss options to address the parent's concerns or disagreements about their child's special education program; and
- Refer callers to other resources, such as publications, websites and disabilityrelated organizations.


Call Activity

To the greatest extent possible, Specialists provide equitable service by responding to calls in the order in which they are received and, in accordance with contact instructions provided by the caller, i.e., date and times when the caller expects to be available. During FY 2013-14, ConsultLine received 3,243 calls, and provided service to 2,839 constituents. In 61 instances, the caller was provided service in Spanish. The difference between the number of calls received, and the number of callers served, is due to unavailability of the caller despite attempts to reach the caller at least three times over the course of three business days.

Caller Demographics

The following data is not inclusive of all callers served; it is limited to statistics which were volunteered by 1,681 of the 2,839 callers served during FY 2013-14. Based on information provided by callers, the following statistics provide a general impression of call activity across the state.

ConsultLine received the highest volume of calls (more than 100 calls) from the following Intermediate Unit areas: Philadelphia Intermediate Unit 26; Allegheny Intermediate Unit 3; Capital Area Intermediate Unit 15; and Montgomery County Intermediate Unit 23.



Statewide general call distribution is reflected in the chart below, with the caveat noted above:

Types of Inquiries

ConsultLine Specialists document the special education-related topics associated with a caller's question(s). During FY 2013-14, the most frequently reported issues concerned multidisciplinary evaluation; IEP implementation; educational placement; and the procedural safeguards notice. Specialists provided publications, forms, web resources and other materials related to special education to 1,341 callers; in 824 instances the caller preferred to receive this information electronically.

Call Resolution Process and Provision of BSE Complaint Packets

ConsultLine's Call Resolution Process (CRP) is an effective dispute resolution tool for compliance-related concerns for IDEA-related issues and certain types of concerns related to Section 504 of the *Rehabilitation Act of 1973*. During CRP, the Specialist acts as a conduit of information between the parent (as defined in 34 CFR 300.30) and the school; the Specialist does not serve as an advocate, decision-maker, mediator, or compliance advisor.

The format and process includes an emailed summary of the parent's compliancerelated concerns, and to the extent known, the parent's proposed resolution. The email is prepared by the Specialist in consultation with the parent so that the message accurately reflects the nature of the issue. Once the message is drafted and reviewed with the parent, the parent provides verbal permission to send the message to the following recipients: LEA administrator responsible for special education; BSE division chief; and the regional BSE advisor. Once the email has been sent, the Specialist's involvement in CRP has concluded. During FY 2013-14, CRP was offered to 272 callers, and provided in 104 instances. Information about the BSE complaint process and the state complaint form is sent to the parent every time CRP is utilized, but also when otherwise requested by a caller. During FY 2013-14, Specialists sent out 250 state complaint forms and information packets.

Gifted Education

ConsultLine Specialists assist callers who have questions or concerns about Chapter 16/Gifted Education. Some of these callers allege compliance violations. When this occurs, the Specialist provides the caller with information about the procedural safeguards for gifted education including the option to file a written complaint. Callers are also referred to the BSE advisor designated for management of Chapter 16 compliance issues. During FY 2013-2014, ConsultLine Specialists served 58 callers whose questions or concerns were specifically related to gifted education.

Evaluation Surveys

When callers provide contact information, Specialists conclude service by mailing or emailing an evaluation survey to the caller. The survey is brief and it can be completed and returned anonymously. Survey participants are asked to provide comments and to answer several satisfaction-based questions.

During FY 2013-14, constituents submitted 65 evaluation surveys; 50 of these were completed electronically using Survey Monkey. Consistent with past years, survey results indicate very high levels of satisfaction with the services provided by ConsultLine Specialists. The following is a sampling of typical comments provided during FY 2013-14:

- "Thank you for your support and guidance for my child and for providing me with the information needed to resolve conflicts in our situation."
- "Amazing! The follow-up email with links is a valuable tool as well. I recommend this service to others."
- *"It was helpful because we felt we were running out of options on what to do as nothing seemed to produce any results. The specialist was helpful and knowledgeable."*

IEP/IFSP/GIEP Facilitation

Although not required by the Individuals with Disabilities Education Act (IDEA), ODR provides a variety of facilitation services to stakeholders. Facilitation services are available to parents and educators when drafting the IEP, IFSP, or GIEP. Because facilitation is a voluntary process, both the parent(s) and provider or LEA must agree to the presence of a facilitator.

During FY 2013-2014, facilitation was requested a total of 45 times, divided among age groups and exceptionalities as follows:

<u> Birth – 3</u>

Not Applicable

<u>3 – 5</u>

There were five requests for this age group. In one instance an IEP was drafted, and a partial IEP was drafted in three instances. Only one IEP facilitation failed to result in an IEP, either in whole or part.

School Age

ODR received 39 requests for facilitation for this age group. Facilitation was declined in one instance, and in two other instances there was no response from the non-requesting party. Two requests were withdrawn. In 27 instances an IEP was drafted; a partial IEP was drafted in four instances. Only three IEP facilitations failed to result in an IEP, either in whole or part. There were no pending requests at the close of the reporting period.

Gifted

There was one request for GIEP Facilitation, which resulted in a completed GIEP.

Mediation

IDEA requires each state to offer mediation services to parents and educational agencies. In FY 2013-2014, ODR contracted with twenty-two independent contractors to provide mediation services to parents and educators. ODR received 303 total requests for mediation during the reporting period, with the highest request rates emanating from Chester County Intermediate Unit 24; Montgomery County Intermediate Unit 23; Delaware County Intermediate Unit 25; and Philadelphia Intermediate Unit 26 respectively. Detailed information about mediation results can be found in Exhibit 1, *Mediation Results by Intermediate Unit and School District*.

Of the 303 mediation requests received by ODR, there were 113 IDEA cases that went forward to a mediation session. The difference in number of requests versus number of sessions held is due to withdrawal of the request after it was made, almost always due to settlement, or, in 19 instances, the non-requesting party declined to participate in mediation or there was no response from the non-requesting party. At the end of the reporting period, there were 23 cases that remained active.

There were 18 gifted cases that went forward to a mediation session. The difference in number of requests versus number of sessions held is due to withdrawal of the request after it was made, almost always due to settlement, or, in one instance, the non-requesting party declined to participate in mediation or there was no response from the

non-requesting party. At the end of the reporting period, there was one case that remained active.

The mediation requests were divided among age groups and exceptionalities as follows:

<u>Birth - 3</u>

Not Applicable

<u>3 - 5</u>

There were 19 requests for mediation for the pre-school population. Of these, 13 went to a mediation session. There was one active case at the close of the reporting period.

School Age

There were 252 requests for mediation for the school-aged population. Sessions were held in 100 instances. There were 21 active cases at the close of the reporting period.

Protected Handicapped/504 Students

There were four requests for mediation pertaining to Chapter 15. A mediation session was held in one instance, and agreement was reached. There were no active cases at the close of the reporting period.

Gifted Education

There were 28 mediation requests pertaining to Chapter 16. Eighteen mediation sessions were held, with agreement reached in all but four instances. There was one active case at the close of the reporting period.

Mediation Issues

The issues most commonly addressed at mediation were as follows:

<u> Birth - 3</u>

<u>3 - 5</u>

Related services and placement were the predominant issues.

School Age

Placement was the most common issue addressed at mediation. IEP disputes and related services were also addressed with some regularity.

Protected Handicapped/504 Students

Chapter 15/Section 504 issues were addressed at mediation.

Gifted Education

GIEP disputes and eligibility were the most common issues addressed at mediation.

Evaluations

Sixty-three (63) post-mediation evaluations were returned during FY 2013-14. A vast majority indicated satisfaction with the services of ODR and the mediators, and the process itself. Examples of comments on the evaluation form:

"Staff was just lovely. They responded to my calls and emails promptly. They were very patient and kind when responding both ways. The scheduling happened quickly and it was appreciated as well."

"Mediator was very helpful and professional to the entire process. Mediator helped keep the meeting focused on the student and supported discussion between the both parties. I would be happy to work with the Mediator again and commend his expertise in facilitation towards helping our team to come to some agreements and focused conversations."

"Our mediator was thorough and did a commendable job explaining the mediation process to all parties. Mediator was respectful and neutral throughout the process, ensuring everyone comprehended the procedures each step of the way."

"The mediator was so kind and thoughtful throughout the entire process. Mediator knew exactly when to listen, and exactly when to talk. Mediator also picked up on the need for breaks and to regroup so we could all reflect on what was being said. Since this is an online cyber school, Mediator asked the appropriate questions to clarify if someone had said something they did not understand as to how my son does his schooling. Mediator also created a list of concerns on a drawing pad large enough for all of us to visually refer to at any time, and input the agreed resolution to the concerns along the way."

"No difficulties developing solution. I believe everyone went into this meeting with prepared ideas and solutions to the concerns. Mediator answered questions we had concerning the mediation document itself as we were developing and agreeing to it. Mediator really was exceptional in letting us just talk and knowing when to talk and ask questions. I also like the mediator 'out of the box' and thoroughness in asking if more detail needed to be put into the agreement document to satisfy anyone. The entire process was very nice."


Due Process

Due Process Requests

For FY 2013-14, ODR received 742 requests for due process, a reduction of 15 from the prior fiscal year². The total numbers of requests are broken down into the following categories:

The most frequently occurring issues at due process were compensatory education; IEP disputes; placement; and evaluation. Detailed information about due process requests/issues can be found in Exhibit 2, *Due Process Requests/Issues by Intermediate Unit and School District.* The 742 due process requests were resolved as follows:

Hearing Officer Decisions

The hearing officers wrote 63 decisions on FY 2013-14 requests with the following results:

Birth - 3 Not Applicable

<u>3 - 5</u> Not Applicable

School Age

Fifty-five decisions were written. The hearing officer found in favor of parents in seven instances, and in favor of LEAs in 31 instances. In eight instances, the hearing officer found partially in favor of the parent, and partially in favor of the LEA. In addition, four decisions favored the parent with modification; four favored the LEA with modifications; and the remaining decision was the Hearing Officer's own decision.

Protected Handicapped/504 Students

Two decisions were written with one decision in favor of the LEA and one decision partially in favor of the parent and partially in favor of the LEA.

<u>Gifted</u>

Six decisions were written, two in support of the parent, three in support of the LEA and one supported the LEA with modifications.

Detailed information about due process results can be found in Exhibit 3, *Due Process Results by Intermediate Units and School Districts.*

<u>Timelines</u>

In 65% of the fully-adjudicated cases, the parties requested an extension of the decision due date pursuant to 34 CFR §300.515(c). The balance of decisions were written during the statutory period.

Appeals to State and Federal Court

During FY 2013-2014, there were 23 appeals to state or federal court; only 5 of these appeals pertained to 2013-2014 requests for hearing, with the balance pre-dating the reporting period. There were 22 appeals brought under the Individuals with Disabilities Education Act (IDEA) and one appeal brought under Chapter 16. In IDEA cases, the appellant chose federal court in 86% of the appeals. Parents accounted for 74% of the total number of appeals received.

As of the close of the reporting period, 16 cases were still in progress; 3 were dismissed, voluntary or otherwise. A judge ruled on the substantive aspect of the case in only four instances, upholding the hearing officer in whole.

<u>Costs</u>

IEP Facilitators billed a total of \$18,754 for services rendered during the fiscal year.

Resolution Meeting Facilitators billed a total of \$3,000 for services rendered during the fiscal year.

Mediators billed a total of \$68,450 for services rendered during the fiscal year.

Court Reporting fees totaled \$420,723 with one-third billed to the respective LEA (\$140,241).
