Introducción

La Oficina para la Resolución de Disputas (ODR por sus siglas en inglés) provee recursos para los padres y las agencias educativas locales (LEA por sus siglas en inglés) para resolver las disputas educativas que involucran a los niños que reciben servicios del sistema de intervención temprana, a estudiantes con discapacidades (o que se cree que tienen discapacidades), y a estudiantes dotados (o que se cree que son dotados). El nombramiento de Pennsylvania como "estado ejemplar" por la Oficina de los Programas de Educación Especial (OSEP por sus siglas en inglés) y el Centro para la Resolución Apropiada de Disputas de Educación Especial (CADRE por sus siglas en inglés) es un reconocimiento de la amplia gama de servicios de calidad provistos por la ODR.

Consejo de Partes Interesadas de la ODR

El Consejo de Partes Interesadas (SC por sus siglas en inglés) de la ODR reúne a representantes de una amplia gama de partes interesadas para proporcionar información funcional y recomendaciones sobre el sistema de resolución de disputas de especial educación. Los miembros se componen de tres defensores de los padres; un representante del Centro de Información sobre los Entrenamientos para Padres; tres abogados (un abogado para los padres, uno para los distritos escolares, y uno para la ODR); un representante de un distrito escolar; y un representante de cada uno de los siguientes grupos de partes interesadas: salud mental, estudiantes dotados y educación superior. Hay información biográfica detallada sobre cada miembro del SC disponible en el sitio web de la ODR (<u>http://odr-pa.org/wp-content/uploads/pdf/Stakeholder-Council-Bios.pdf</u>). El Consejo es autosuficiente, es decir, los mismos miembros, no el personal de la ODR, eligen a sus reemplazos.

Durante el año fiscal 2014-2015, el SC aportó conocimientos y comentarios sobre una variedad de asuntos relacionados al sistema de resolución de disputas incluyendo: los programas pilotos de la ODR sobre el uso de las pruebas documentales electrónicas y las audiencias virtuales. Una de las funciones más críticas del SC es entrevistar a posibles oficiales de audiencia y hacer recomendaciones de selección. El Consejo fue llamado para ayudar en la búsqueda de un oficial de audiencia para sustituir a un oficial de audiencia que se retiró durante este período de informe.

Presentaciones

La educación de las partes interesadas sigue siendo una iniciativa prioritaria. El director, el personal y los oficiales de audiencia participaron en una variedad de presentaciones dentro del estado, tales como la Academia de Liderazgo de Educación Especial; la Conferencia Nacional de Autismo; diversos programas de intervención temprana; la Conferencia Anual de Administradores de Educación Especial de Pennsylvania del Este (EPASEA, por sus siglas en inglés); el Programa de *Fellows* de Educación Especial; y la Conferencia de la Ley de Educación Especial de la Universidad de Lehigh, así como también con grupos de padres y los distritos escolares. Además, como parte de la reciprocidad profesional con otros estados, el personal y los oficiales de audiencia en ocasiones ayudaron a otros estados con el desarrollo de su programa de resolución de disputas.

Entrenamientos para oficiales de audiencia

Los oficiales de audiencia participan cada año en un desarrollo profesional riguroso, tanto internamente como a través de asociaciones profesionales de gran prestigio. Ellos son miembros de la Asociación Nacional de Oficiales de Audiencia (NAHO, por sus siglas en inglés), y participan

en el proceso de certificación. Los oficiales de audiencia asisten regularmente a la conferencia NAHO, y/o la Academia de Oficiales de Audiencia y Jueces de Derecho Administrativo en la Escuela de Derecho de la Universidad de Seattle.

Proyectos pilotos de la ODR

Reuniones con los Oficiales de Audiencia para Acuerdos

La ODR se encuentra en el proceso de transformar las Conferencias Evaluativas de Conciliación (ECC, por sus siglas en inglés) a algo más simplificado: "Reuniones con los Oficiales de Audiencias para Acuerdos". Tanto el Consejo de Partes Interesadas como los miembros de la barra de abogados de los padres y los distritos escolares han hecho aportaciones para estos cambios. Se publicará información detallada sobre las Reuniones con los Oficiales de Audiencias para Acuerdos en el sitio web de la ODR.

Programa piloto de audiencias virtuales

Dos de los oficiales de audiencia han estado trabajando para finalizar la plataforma de la segunda fase del Programa piloto de audiencias virtuales. Esta fase se centrará en las necesidades de los taquígrafos judiciales para producir un registro preciso, así como diversos escenarios para la ubicación de todos los participantes que utilizan combinaciones de presencia virtual y física de las partes, el abogado, el taquígrafo judicial y el oficial de audiencia. Los líderes del programa piloto también seguirán considerando los usos adecuados para iniciar la tecnología virtual de forma limitada pero regular en las audiencias reales. Ellos están coordinando con la ODR respecto a la forma en que las audiencias virtuales podrían afectar los contratos con estas agencias en el futuro.

Programa piloto de pruebas documentales electrónicas

El Programa piloto de pruebas documentales electrónicas es un sistema que permitirá a las partes presentar pruebas documentales por vía electrónica. En la primera fase, se llevaron a cabo de forma interna pruebas limitadas y con ayuda de la barra de abogados. En la segunda fase, los voluntarios participaron en el programa piloto. Los próximos pasos para este piloto son continuar recopilando datos y obtener experiencia a medida que surgen los casos, y en base a los resultados, discutir la expansión del piloto más allá de un solo oficial de audiencia.

La ConsultLine

La ConsultLine de Educación Especial es una línea de asistencia gratuita que provee información a los padres y defensores que tienen preguntas o inquietudes sobre la educación especial de niños en edad escolar. La ConsultLine está formada por tres especialistas quienes brindan información sobre educación especial, la educación para niños dotados y el Artículo 504 de la *Ley de Rehabilitación de 1973*. Los especialistas evalúan la naturaleza de la pregunta o preocupación de la persona que llama y responden con explicaciones claras sobre:

- Los procesos para evaluar, identificar y proveer educación especial, acomodaciones y servicios relacionados para un niño;
- Los derechos de los padres y las garantías procesales, incluyendo explicaciones sobre las regulaciones relacionadas;

- Información, asistencia y acceso a los procesos estatales de quejas administrados por la Oficina de Educación Especial (BSE por sus siglas en inglés) del Departamento de Educación;
- Servicios de resolución de disputas y opciones para resolver desacuerdos respecto al programa de educación especial de su niño; y
- Otros recursos, publicaciones, páginas web y organizaciones relacionadas a las discapacidades.

Actividad de llamadas


En la medida de lo posible, los especialistas proveen un servicio equitativo, respondiendo a las llamadas en el orden en que son recibidas y de acuerdo con las instrucciones de contacto provistas por la persona que llama, es decir, la fecha y las horas en las que la persona que llama estará disponible. Durante el año fiscal 2014-15, la ConsultLine recibió 3,373 llamadas y brindó servicios a 3,052 personas que llamaron. En 32 casos, se prestaron servicios en español a la persona que llamó y en 2 casos se le proporcionó servicios en ruso a la persona que llamó. La diferencia entre la cantidad de llamadas recibidas y la cantidad de llamadas atendidas se atribuye a la falta de disponibilidad de personas que llamaron, a pesar de los intentos de los especialistas para contactarlos al menos tres veces durante el curso de tres días laborales.

Datos demográficos de las personas que llaman

La siguiente información no incluye a todas las personas que llamaron y que fueron atendidas; se limita a los datos estadísticos que fueron proporcionados de forma voluntaria por 1,161 de las 3,052 que llamaron durante el año fiscal 2014-2015. Basado en la información provista por las personas que llamaron, los siguientes datos estadísticos proveen una impresión general de la actividad de llamadas a través del estado.

La ConsultLine recibió el mayor volumen de llamadas (más de 100 llamadas) de las siguientes unidades intermedias: Unidad Intermedia 26 de Philadelphia; Unidad Intermedia 15 de Área Metropolitana; Unidad Intermedia 23 del Condado de Montgomery y Unidad Intermedia 3 de Allegheny.

La distribución de llamadas en general de todo el estado se refleja en el siguiente cuadro, con la excepción antes mencionada:



<u>Tipos de consultas</u>

Los especialistas de la ConsultLine documentan los temas de educación especial asociados con la(s) pregunta(s) de la persona que llama. Durante el año fiscal 2014-15, los problemas reportados con mayor frecuencia fueron los siguientes: la evaluación multidisciplinaria, el contenido del IEP, la implementación del IEP, la colocación educativa y la mediación. Los especialistas proporcionaron publicaciones, formularios, recursos de internet y otros materiales relacionados a la educación especial a 1,489 personas que llamaron; la mayoría de esta información fue entregada electrónicamente.

Proceso de resolución de llamadas y entrega de paquetes de quejas de la BSE

El Proceso de Resolución de Llamadas (CRP por sus siglas en inglés) de ConsultLine es una herramienta eficaz para la resolución de conflictos relacionados con el cumplimiento de la Sección 504 de la *Ley de Rehabilitación de 1973*. Durante el CRP, el especialista actúa como un canal de información entre el padre (según lo define el Título 34 del Código de Regulaciones Federales, CFR 300.30.) y la escuela; el especialista no se desempeña como defensor, tomador de decisiones, mediador ni asesor de cumplimiento.

El formato y el proceso incluye un breve resumen enviado por correo electrónico con las inquietudes de los padres sobre el cumplimiento y, según se conozca, la resolución propuesta por el padre. El correo electrónico es preparado por el especialista con quien el padre hace la consulta para que el mensaje refleje con precisión la naturaleza del asunto. Una vez que el mensaje es redactado y revisado con el padre, el padre provee su autorización verbal para enviar el mensaje a los siguientes destinatarios: al administrador de la LEA responsable de la educación especial, al jefe de división de la BSE y al asesor regional de la BSE. Una vez que se envía el correo electrónico, la participación del especialista en CRP ha terminado. Durante el año fiscal 2014-15, el CRP se ofreció a 320 personas que llamaron y fue implementado en 171 casos, lo cual es un aumento significativo durante los últimos años.

La información sobre el proceso de queja de la BSE y el formulario de queja estatal se envía a los padres cada vez que se utiliza el CRP, y también cuando una persona que llama lo solicita. Durante el año fiscal 2014-2015, los especialistas enviaron 229 formularios de queja estatal y paquetes de información.

Educación para estudiantes dotados

Los especialistas de la ConsultLine asisten a personas que llaman con preguntas o inquietudes acerca del Capítulo 16/Educación para estudiantes dotados. Algunas de esas personas alegan violaciones de cumplimiento. Cuando esto sucede, los especialistas proveen a la persona que llama información sobre las garantías procesales para la educación de estudiantes dotados incluyendo la opción de presentar una queja escrita. Las personas que llaman también son referidas directamente al asesor designado de la BSE, quien maneja las quejas sobre asuntos de cumplimiento del Capítulo 16. Durante el año fiscal 2014-2015, los especialistas de la ConsultLine atendieron a 61 personas cuyas preguntas o inquietudes estuvieron relacionadas específicamente a la educación para estudiantes dotados.

Encuestas de evaluación

Cuando las personas que llaman proveen información de contacto, los especialistas concluyen el servicio enviándoles una encuesta de evaluación por correo o por correo electrónico. La encuesta es breve y puede ser completada y devuelta de forma anónima. Se pide a los participantes de la encuesta que provean comentarios y que respondan a diversas preguntas sobre su satisfacción.

Durante el año fiscal 2014-2015, las personas que llamaron luego llenaron 90 encuestas de evaluación. Al igual que en años anteriores, los resultados de las encuestas indicaron un alto nivel de satisfacción con los servicios provistos por los especialistas de la ConsultLine. A continuación se encuentran unas muestras de los comentarios provistos durante el año fiscal 2014-2015:

- Estoy absolutamente encantado con la rápida respuesta de la ConsultLine, y también con la increíble comprensión que el consultor mostró. Esto demuestra que las personas que trabajan en la línea se preocupan y saben hacer su trabajo. GRACIAS
- Yo aprecio los servicios de la ConsultLine de Educación Especial. Su personal me ayuda a encontrar las regulaciones y los detalles de la ley que son difíciles de encontrar. ¡Gracias!
- ¡El consultor fue excelente! Ella me dio exactamente lo que necesitaba y envió copias impresas como respaldo. El material que ella envió por correo fue muy útil. Tuve la oportunidad de seguir adelante con un plan adecuado para mi hijo.

El personal de la ConsultLine continúa ampliando el alcance de su ayuda para los padres. El personal de la ConsultLine ayuda a los padres a completar el formulario de petición en línea para el IEP/ECC/la mediación cuando es necesario, y, a petición de la BSE, ayudan con las encuestas de los padres.

La facilitación del IEP/IFSP/GIEP

La ODR ha estado ofreciendo la Facilitación del IEP desde principios del 2000, mucho antes de que la mayoría de los estados habían desarrollado un programa de este tipo. Desde el inicio de este servicio, la teoría y la práctica de Facilitación del IEP se ha vuelto más refinada, a medida que más estados continúan explorando su uso. Un subcomité de la SC se formó para ayudar en el análisis de la configuración del modelo de la ODR, para evaluar su viabilidad, y las áreas de refinamiento y mejora. Además, los facilitadores de la ODR fueron entrenados por Trisha Bergin-Lytton, una facilitadora experimentada de Nuevo México, con el objetivo de instituir un proceso más uniforme de facilitación. Se requirió que los facilitadores participaran en un entrenamiento de dos días, y recibieron un certificado de la entrenadora. Los Miembros del Comité de Partes Interesadas y un representante de la BSE asistieron al entrenamiento para aprender más sobre el formato, así como para proporcionar información a los mediadores y al personal de la ODR. Varios miembros del Comité de Partes Interesadas fueron grabados en un video hablando sobre la Facilitación del IEP, para ser usado en un video que actualmente está en producción.

Durante el año fiscal 2014-2015, la facilitación del IEP fue solicitada un total de 68 veces, divididas entre grupos y excepcionalidades de la siguiente forma:

Desde el nacimiento hasta los 3 años de edad

Ninguna.

De 3 a 5 años de edad

Hubo 2 solicitudes, y ambas resultaron en la creación de un IEP.

<u>Edad escolar</u>

Hubo 65 solicitudes para la facilitación del IEP para este grupo de edad. En tres casos, la parte que no hizo la solicitud rechazó usar un facilitador del IEP. En 10 casos, la solicitud para la facilitación fue luego retirada. Para esas reuniones en las que no hubo un facilitador, se obtuvieron los siguientes resultados:

Estudiantes dotados

Hubo una facilitación del GIEP, la cual resultó en un IEP.

Evaluaciones

Veinticinco (25) evaluaciones fueron llenadas y devueltas después de la reunión de facilitación del IEP durante el año fiscal 2014-2015. A continuación se encuentran algunos ejemplos de los comentarios incluidos en los formularios de evaluación:

- Mi facilitador del IEP fue excelente. El facilitador en realidad no tuvo la oportunidad de intervenir o ayudar porque comenzamos a trabajar de inmediato. Sin embargo, su presencia fue clave para el éxito de la reunión. El facilitador hizo un gran trabajo y estoy satisfecho con el resultado.
- [Nombre redactado], ser un participante objetivo ayudó con el ambiente en la sala. Estuvo mucho más relajado que las reuniones anteriores.
- [El facilitador] se aseguró de que las dos partes se entendían y de que ninguna información se perdiera.
- Fui muy afortunado de que [nombre redactado] viniera a mi reunión del IEP. Tan pronto como lo vi, supe que tenía experiencia y que se comunicaba bien. Él ayudó a calmar a algunas personas en la sala, y la conclusión de la reunión fue mejor de lo que podía haber esperado. Sólo su presencia hizo a todos cooperar, pero [nombre redactado] a menudo interrumpió la conversación para preguntarme si había entendido lo que se estaba explicando, etc. Él fue muy valioso para mi resultado.
- Tener un participante imparcial proporciona un ambiente de calma. Esto ayudó a mantener a todos los participantes más positivos y amigables.

La mediación

La Ley IDEA requiere que cada estado ofrezca los servicios de mediación a los padres y a las agencias educativas. En el año fiscal 2014-2015 la ODR celebró acuerdos con 21 contratistas independientes para brindar servicios de mediación a padres y educadores. La ODR recibió un total de 428 solicitudes de mediación durante el período de informe, de las cuales la mayoría provinieron de la Unidad Intermedia del Condado de Montgomery (54), la Unidad Intermedia de Allegheny (50), la Unidad Intermedia del Condado de Delaware (45), y la Unidad Intermedia del Condado de Chester (44). Puede encontrar información detallada sobre los resultados de las mediaciones en el Anexo 1, *Resultados de las mediaciones por Unidad Intermedia y Distrito Escolar.*

De las 428 solicitudes de mediación recibidas por la ODR, 391 solicitudes fueron de casos de IDEA. La diferencia entre la cantidad de solicitudes y la cantidad de sesiones realizadas se debe al retiro de la solicitud luego de haberla hecho, casi siempre debido a un acuerdo, o, en 75 casos, la parte no solicitante se rehusó a participar en la mediación o no se recibió una respuesta de la parte no solicitante. Al final del período de informe, 61 casos permanecían activos.

Evaluaciones

Sesenta y dos (62) evaluaciones post-mediación fueron devueltas durante el año fiscal 2014-2015. A continuación se encuentran ejemplos de comentarios de los formularios de evaluación:

- El mediador estableció un alto tono positivo y profesional. El mediador dio una amplia explicación sobre el proceso y los roles individuales de cada participante. El mediador fue excelente y trató de establecer una relación cordial con todas las partes. Como resultado de los esfuerzos del mediador, nadie se expresó con enojo. Aunque las preocupaciones de los padres fueron bien definidas antes de la reunión, creo que el mediador nos ayudó a llegar un mutuo acuerdo razonable.
- Todo fue explicado muy bien así que yo estaba preparado para la reunión. El mediador fue muy bueno y paciente con la explicación. El mediador se detuvo y explicó todos los puntos un par de veces para asegurarse de que estábamos todos de acuerdo. Fuimos capaces de mantener una reunión calmada y profesional. Cuando lo necesitábamos, el mediador salió con la otra parte para ayudar a llegar a un mutuo acuerdo.
- El mediador tenía claro cuál era su papel y el papel de cada parte. El mediador obviamente tiene una gran cantidad de experiencia y escuchó lo que cada persona tenía que decir. El mediador alentó a ambas partes a continuar la comunicación y a trabajar hacia una solución hasta que se hizo evidente que estábamos en el camino correcto. El mediador intentó ayudarnos a encontrar diferentes soluciones, pero cuando fue evidente que no había una solución ella pasó al siguiente punto. Siento que la mediación ha sido útil para promover el debate y explicar la evaluación. Una vez que llegamos al punto en el que no estábamos de acuerdo, el mediador hizo un fantástico trabajo para concluir la sesión.
- La mediadora fue minuciosa y clara. La mediadora dio tiempo a cada parte para hablar y tuvimos varias oportunidades para hablar acerca de los problemas, las preocupaciones y nuestras opiniones. Ella mantuvo la conversación positiva y organizada. La mediadora dio a cada parte un plazo para reunirse y discutir sobre lo que se había hablado y nos sentimos como si no había prisa para tomar una decisión. La mediadora reformuló cada solución y nos ayudó, como un equipo, a determinar lo que sería mejor para el estudiante. La reunión se celebró y salió muy bien. Había una sensación de comunicación abierta otra vez, un nivel de comodidad para todos.

<u>El proceso legal debido¹</u>

Solicitudes del proceso legal debido

Durante el año fiscal 2014-2015, la ODR recibió 829 solicitudes para el proceso legal debido. El número total de solicitudes es dividido en las siguientes categorías:

En ocho casos, el oficial de la audiencia estuvo parcialmente a favor del padre y parcialmente a favor de la LEA. Además, cinco decisiones favorecieron a los padres con modificaciones; tres favorecieron a la LEA con modificaciones; en uno de los casos, el oficial de la audiencia fue despedido.

<u>Plazos de tiempo</u>

En el 68% de los casos que llegaron a una decisión final, las partes solicitaron una extensión de la fecha límite para la decisión, conforme al Título 34 del Código de Regulaciones Federales §300.515(c). El resto de las decisiones fueron escritas dentro del período establecido por ley sin conceder extensiones de tiempo.

Apelaciones ante tribunales estatales y federales

Durante el año fiscal 2014-2015, se realizaron 20 apelaciones ante tribunales estatales o federales; sólo tres de ellas estuvieron relacionadas a solicitudes de audiencia del 2014-2015, el resto correspondió a períodos anteriores. Todas las apelaciones fueron presentadas en virtud de la Ley de Educación para Personas con Discapacidades (IDEA por sus siglas en inglés). El apelante escogió al tribunal federal en 95% de las apelaciones. Al momento del cierre del período de informe, 12 casos estaban aún en proceso; cuatro casos fueron desestimados, de forma voluntaria o no voluntaria.

Un juez emitió un fallo en el aspecto sustantivo del caso sólo en cuatro ocasiones, y sostuvo la decisión del oficial de audiencia en tres casos. En el caso restante el juez anuló la decisión del oficial de la audiencia y remitió el caso a otros procedimientos.

<u>Costos</u>

Los facilitadores del IEP facturaron un total de \$22,060 por servicios prestados durante el año fiscal.

Los facilitadores de las reuniones de resolución facturaron un total de \$6,050 por servicios prestados durante el año fiscal.

Los mediadores facturaron un total de \$95,163 por servicios prestados durante el año fiscal.

Los costos por servicios de taquigrafía judicial fueron de \$402,642 con un tercio facturado a la LEA respectiva (\$134,214).
