Through the Office for Dispute Resolution (ODR), the Pennsylvania Department of Education (PDE) fulfills its statutory mandate to maintain a special education due process system. PDE contracts with the Central Susquehanna Intermediate Unit (CSIU) to provide fiscal and certain management support for that office, without becoming involved in substantive operations. The hearing officers and mediators are free from interference or influence on any matters affecting the outcome of individual mediations and due process hearings. This includes, without limitation, interference, or influence from any entity, individual, or group, such as parents, advocacy groups, school districts, intermediate units including CSIU, ODR staff, and PDE. At the same time, those hearing officers and mediators are provided with administrative support, as well as training delivered in a manner preserving their impartiality through ODR, which itself is also free of such interference or influence.

The Central Susquehanna Intermediate Unit will not discriminate in educational programs, activities or employment practices based on race, color, national origin, gender, disability, marital status, age, religion, sexual orientation, ancestry, union membership or other legally protected classifications. Announcement of this policy is in accord with Title VI of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, and the Americans with Disabilities Act of 1990. # INTRODUCTION



## **The Office for Dispute Resolution (ODR) provides the resources for parents' and local educational agencies (LEAs) to resolve educational disputes involving children served by the early intervention system, students with disabilities (or thought to have disabilities) and students who are gifted (or thought to be gifted).**

Pennsylvania's recognition as an "exemplar state" by the Office for Special Education Programs (OSEP) and the Center for Appropriate Dispute Resolution in Special Education (CADRE) is an acknowledgement of the experience, education, and training of ODR staff<sup>2</sup> and the quality of ODR services provided.<sup>3</sup> In addition to its website, publications, and videos, ODR remains in contact with its stakeholders through a listserv. ODR's listserv is available at <https://odr-pa.org/subscribe-to-odr/>.

Due to the COVID-19 pandemic, ODR began providing all its services virtually as of March 16, 2020, when the shutdown occurred. As circumstances with the pandemic evolved, there was a return to in-person facilitations, mediations, and due process to some degree; however, approximately 90% of all ODR services remain virtual, as requested and preferred by the parties. In all instances, in-person ODR services are available to parents and LEAs.

A five-year comparison of ODR services demonstrates fairly consistent use of

facilitation and mediation, with a not unexpected fluctuation in due process requests during the period pre-dating March 2020 and continuing to the present time. The pandemic initially raised a myriad of school issues including the challenges of remote learning and virtual instruction, masking, social distancing, contingency plans, and health and safety plans. More recently, where due process complaints have COVID-19 related issues, fewer complaints are centered on the school closure of the spring and summer of 2020. Instead, more of these issues centered on the return to school in FY 2020 and programming provided during that time. By then, most school districts had health and safety plans and return-to-school protocols in place. The hearing officers report that complaints appear to be centered on those plans and protocols in light of the students' individualized education programs.

There continues to be very few cases where COVID Compensatory Services (CCS) are explicitly placed at issue in the hearing. The issue of CCS continues to surface in some complaints, and, at times, is made part of the evidence though rarely if ever the driving issue. But CCS has not been a focus of due process hearings, and even where evidence is introduced on the issue, it is not very voluminous or deep. It remains to be seen how due process activity will be affected by CCS, if at all, in the coming school years.

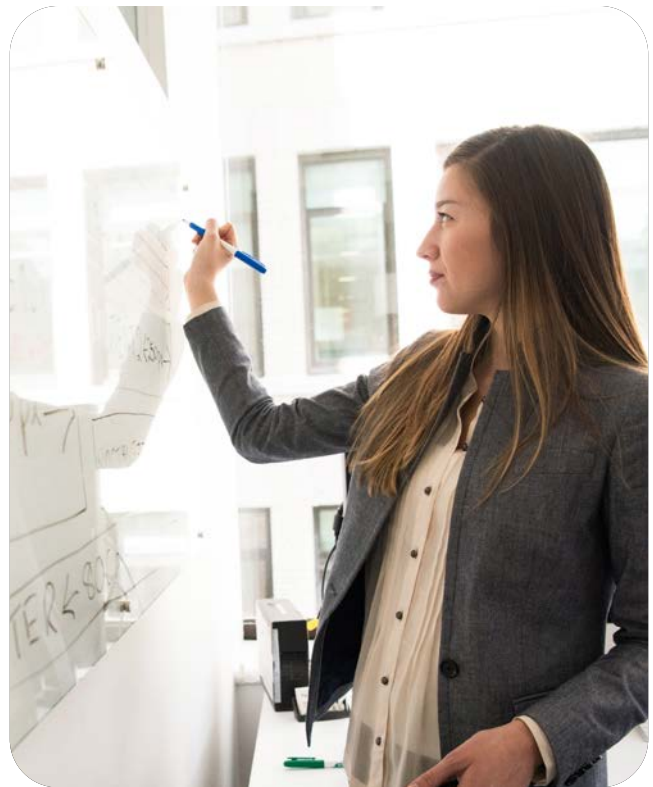
## ODR Stakeholder Council

The ODR Stakeholder Council brings together representatives from a broad array of stakeholders to provide functional input and recommendations on the special education dispute resolution system. Detailed biographical information on each member is available on the ODR website.<sup>4</sup> ODR, with its Stakeholder Council, remains committed to encouraging IEP facilitation and mediation as effective dispute resolution tools, while continuing to recognize due process as an important procedural safeguard for parents.

## Outreach

Virtual presentations by ODR staff and hearing officers included: Special Education Leadership Academy; Pennsylvania Department of Education Conference; Center for Schools and Communities; Arc Alliance; Special Education Advisory Panel; Pennsylvania Association of Intermediate Units; Pennsylvania State Education Association; Pennsylvania Council for Exceptional Children; Center for Appropriate Dispute Resolution in Special Education (CADRE); National Association of Hearing Officials; Hispanos Unidos para Niños Excepcionales; Pennsylvania Training and Technical Assistance Network; Practicing Law Institute; Arcs of Lehigh County, Northampton County, and Dauphin County; and various Intermediate Units, Early Intervention programs, and Local Task Force groups.

This year, ODR and CADRE co-sponsored a national Hearing Officer Academy. ODR hearing officers presented multiple sessions,



among other nationally recognized experts, in special education law, hearing officer ethics, and implicit bias. The ODR-CADRE collaboration will continue in the next fiscal year.

The ODR staff produces videos, webinars, and podcasts on topics relevant to both parents and educators. Development of training products is an ongoing process and based upon identified stakeholder needs. During FY 2021, ODR produced the following video shorts: requesting ODR services; asking an LEA for an evaluation; explaining the resolution meeting; and the difference between the Bureau of Special Education and the Office for Dispute Resolution. Additionally, ODR updated the Special Education Due Process Hearing Guide for Parents and Families<sup>5</sup>.

## Hearing Officer Training

The hearing officers engage in rigorous professional development each year, both in-house and through highly regarded professional associations. Hearing officers attended the following virtual trainings: LRP Institute; LRP Special Education School Attorneys Conference; Pennsylvania Department of Education Conference; Council of Parent Attorneys and Advocates Conference; National Association of Hearing Officials; National Association of Administrative Law Judiciary Conference; CADRE National Symposium; Special Education Law Symposium; as well as several trainings and webinars sponsored by the Pennsylvania Bar Institute and Council of Administrators of Special Education. Additionally, during the COVID pandemic, hearing officers have also participated in webinars and trainings from various organizations related to special education.

## ODR Projects

### Local Level Facilitated IEP Training

ODR identified those areas of the state with the most due process activity, and, during the second half of the year, began offering those LEAs free local level facilitated IEP training through Key2Ed<sup>6</sup>. The Delaware County Intermediate Unit graciously agreed to pilot the training before it was offered to other LEAs and IUs. As we move forward, a companion training for parents will also be provided. Due to the newness of the initiative, further information and outcomes will be provided in the FY 2022 Annual Report.

## Hearing Officer Settlement Conferences

Since March 2017, Hearing Officer Settlement Conferences (HOSCs) have been a regularly offered service to parents and educators. ODR maintains a randomized list of HOSC hearing officer assignments. When parties request a HOSC, the next hearing officer on the list is assigned, after confirming that she or he does not have an ongoing case with the parent or the LEA. Each hearing officer has a slightly different approach to the details of a HOSC, but the same general framework applies—a three-sided conversation between the settlement hearing officer and the attorneys (or LEA attorney and pro se parent) takes place.

Thereafter, the settlement hearing officer typically has an individual conversation with each party. At that point, each HOSC moves in its own unique direction—sometimes resolution has been achieved, sometimes further three-sided conversations are held, and sometimes further individual conversations are held. The HOSC can continue until the parties feel it has met its goals, or the parties can continue without the settlement hearing officer. For this reporting period, there were 21 HOSC processes (17 completed and four ongoing), resulting in an 81% settlement rate for completed processes. This mirrors the overall 82% settlement rate since the inception of the program. Additional information about HOSCs is available on the ODR website.<sup>7</sup>

# CONSULTLINE

**The Special Education ConsultLine is a toll-free information helpline for parents and advocates who have questions or concerns about special education for school-age children. ConsultLine specialists also handle ODR's Parent & Family Engagement Project services and technical assistance to parents who are preparing to participate in mediation and IEP facilitation, and/or represent themselves in a due process hearing. ConsultLine is staffed by three specialists who provide information about special education, gifted education, and Section 504 of the Rehabilitation Act of 1973. Specialists assess the nature of the caller's inquiry or concern and provide information and assistance.**

The types of information provided include:

- ✓ The process involved in having a child evaluated, identified, and provided with special education, accommodations, and related services;
- ✓ Parents' rights and procedural safeguards, including information about regulations;
- ✓ Dispute resolution services and options for resolving disagreements about a child's special education program;
- ✓ The process and procedures of a caller's active case related to IEP Facilitation, Mediation, and Due Process Hearing;
- ✓ Information, assistance, and access to the state complaint process managed by the Pennsylvania Department of Education's Bureau of Special Education; and
- ✓ Resources, publications, websites, and referrals to disability-related organizations.





Specialists respond to requests for information by calling a constituent directly. In an attempt to speak with everyone who has requested information, Specialists call individuals at least three times over the course of three business days. This has been an effective protocol for providing service in an equitable and timely manner.

Furthermore, ODR operates a Live Chat feature that is handled by the ConsultLine Specialists. Live Chat allows constituents to ask questions in real time Monday through Friday, from 8:30am to 4pm, regarding any ODR service. After hours, constituents can fill out a ticket to request a follow-up phone call the next business day (or at a specific date and time requested) Live Chat has been operational since July 15, 2021.

ConsultLine Specialists work diligently behind the scenes to ensure that all constituents have access to the most updated and accurate information and resources. They also:

- ✓ Ensure that Hearing Officer decisions have all personally identifiable information removed and that the decisions meet accessibility standards prior to posting on ODR's website;
- ✓ Maintain the Parent Resource Library section of ODR's website;
- ✓ Conduct group presentations for interested stakeholders via in-person or virtual sessions on the function, purpose, and services of ODR. This includes an ODR Overview training specific to Early Intervention dispute resolution;
- ✓ Collaborate with PaTTAN Consultants to ensure the OSEP Policy Letter database remains up-to-date; and
- ✓ Collaborate with the Center for Schools and Communities on Family Engagement activities.



## Call Activity

During FY 2021, ConsultLine Specialists served 2,509 constituents. The services provided include:

- ConsultLine calls, where Specialists answer questions and provide information to parents and advocates related to special education concerns;
- Family Engagement outreach, where Specialists provide assistance to parents who have an active mediation or an active due process hearing in which they are representing themselves; and

- ODR Live Chat, where Specialists respond to questions and provide information to individuals who reach out to ODR via the chat function on the website.

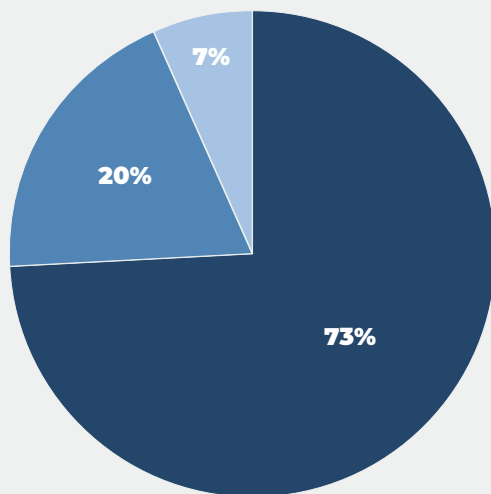
As shown in Figure 1, out of the 2,509 constituents served, 510 were specific to Family Engagement services and 159 were specific to Live Chat.

ConsultLine Specialists serve constituents who speak a language other than English through a third-party interpretation service. During FY 2021, the interpretation service was used 33 times to provide service in Spanish, two times to provide service in Arabic, and one time each to provide service in Nepali and Vietnamese.

ConsultLine continues to administer several outreach initiatives during the reporting period, including Family Engagement outreach and Live Chat. Additionally, Specialists reach out to parties when their recent mediation resulted in no agreement. This oftentimes provides more detailed feedback as to why parties thought an agreement could not be reached and informs mediation training moving forward. In several instances, ConsultLine staff learned that the dispute was resolved following the mediation session. Similarly, to improve upon ODR's stakeholder responsibilities, ConsultLine specialists follow up with respondents from the Dispute Resolution Survey to further discuss any comments, suggestions, and/or concerns about their recent facilitation, mediation, or due process.

## Regional Representation of Inquiries

Regional information was volunteered during 1,334 calls during FY 2021. ConsultLine received the highest volume of identified calls from the following regions:

## Types of Inquiries

ConsultLine Specialists document the main topics associated with a caller's question(s). During FY 2021, the most regularly recurring topics, in order of frequency, pertained to the following:

Other high interest topics included IEP implementation, evaluation, discipline, Chapter 15/Section 504, and transportation.

Specialists provided publications, forms, web resources and other materials related to the caller's interests in 1118 instances. The majority of this information was electronically delivered.



## **Call Resolution Process and Provision of BSE Complaint Packets**

ConsultLine’s Call Resolution Process (CRP) is an effective dispute resolution tool for compliance-related concerns for IDEA-related issues and certain types of concerns related to Section 504 of the Rehabilitation Act of 1973. During CRP, the Specialist acts as a conduit of information between the parent (as defined in 34 CFR 16 § 300.30) and the school; the Specialist does not serve as an advocate, decision maker, mediator, or compliance advisor.

The CRP format and process includes an email summarizing the parent’s compliance-related concerns, and to the extent known, the parent’s proposed resolution. The email is prepared by the Specialist in consultation with the parent so that the message accurately reflects the parent’s concern. Once the message is drafted and reviewed with the parent, the parent provides verbal consent to send the message to the LEA administrator responsible for special education; BSE division chief; and the regional BSE advisor. Once this email has been sent, the Specialist’s involvement in CRP has concluded.

During FY 2021, CRP was offered to 65 callers, and distributed with the parent’s permission in 36 instances. Common reasons for declining the distribution of the CRP were the parent wanting to speak/meet with the school one more time to try to resolve the issue before sending the CRP, or the parent wanting to

talk with another parent/advocate before agreeing to send the CRP. The most frequent issue in a CRP was IEP implementation.

Information about the BSE complaint process and the state complaint form is sent to the parent when CRP has been offered, and also when specifically requested by the caller. During FY 2021, 127 state complaint forms and information packets were distributed to callers.

## **Gifted Education**

ConsultLine Specialists assist callers who have questions or concerns about Chapter 16/ gifted education. Some of these callers allege compliance violations. When this occurs, the Specialist provides the caller with information about the procedural safeguards for gifted education, including the option to file a written complaint. During FY 2021, ConsultLine responded to 53 callers whose questions or concerns were specifically related to gifted education.

## **ConsultLine Feedback**

When callers provide contact information, Specialists conclude service by mailing or emailing an evaluation survey to the caller. The survey is brief, and it can be completed and returned anonymously. Survey participants are asked to provide comments and to answer several satisfaction-based questions. Survey respondents assess the following areas: usefulness of information; identifying options for resolving concerns; timeliness of service;

and general satisfaction. For FY 2021, survey results show that ConsultLine continues to maintain a high level of satisfaction from constituents.

## Professional Development

ConsultLine staff continue to participate in high quality professional development opportunities to remain well informed and effective in conveying useful information and relevant

resources to callers. During FY 2021, professional development activities included the LRP National Institute; Pennsylvania Bar Institute’s Exceptional Children Conference; and Lehigh University’s Special Education Law Symposium.

Additionally, specialists are involved in outreach activities and collaboration with cross-agency staff on various ODR, BSE, and CADRE initiatives.

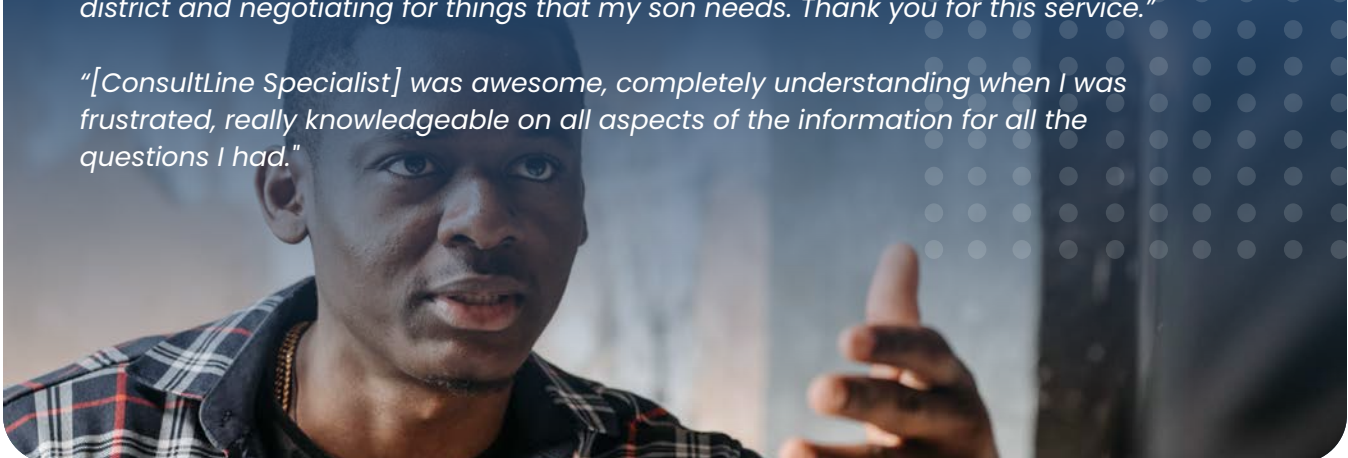

# FACILITATION





**ODR provides two types of facilitation: IEP/IFSP/GIEP/Section 504 facilitation and resolution meeting facilitation. Both types of facilitation are voluntary, meaning it can only be used when all parties agree that the presence of a neutral third party would help facilitate communication and the successful drafting of the student's IEP/GIEP or a resolution agreement (in the case of resolution meeting facilitation).**

### **IEP Facilitation**

Typically, this process is not necessary for most IEP meetings or resolution meetings. Rather, it is most often utilized when there is a sense from any of the participants that the issues at the meeting are creating an impasse or acrimonious climate.

### **Resolution Meeting Facilitation**

During FY 2021, ODR received eight requests for a facilitator to attend a resolution meeting. Four facilitated resolution meetings were held, and the parties reached an agreement in all four of the facilitated meetings: three reached full agreement and one reached partial agreement. The request for facilitation was declined in two instances and withdrawn in one instance. One request for facilitation remains active.

### **IFSP Facilitation (Birth-3)**

There were no requests for IFSP facilitation during FY 2021.

### **IEP/GIEP/Section 504 Facilitation Requests**

In FY 2021, there were 68 requests for IEP/GIEP/504 Facilitation. There were two IEP facilitation requests that were carried over from FY 2020, bringing the total number of facilitation requests being reported to 70. Consistent with prior years, the overwhelming majority of these cases (64) pertained to school aged students and their IEPs. Of the six remaining requests, four requests were for the IEP of a child aged 3-5 and two requests were for GIEP facilitation. There were no requests for 504 plan facilitation this fiscal year.

### **IEP Facilitation Outcomes – IDEA**

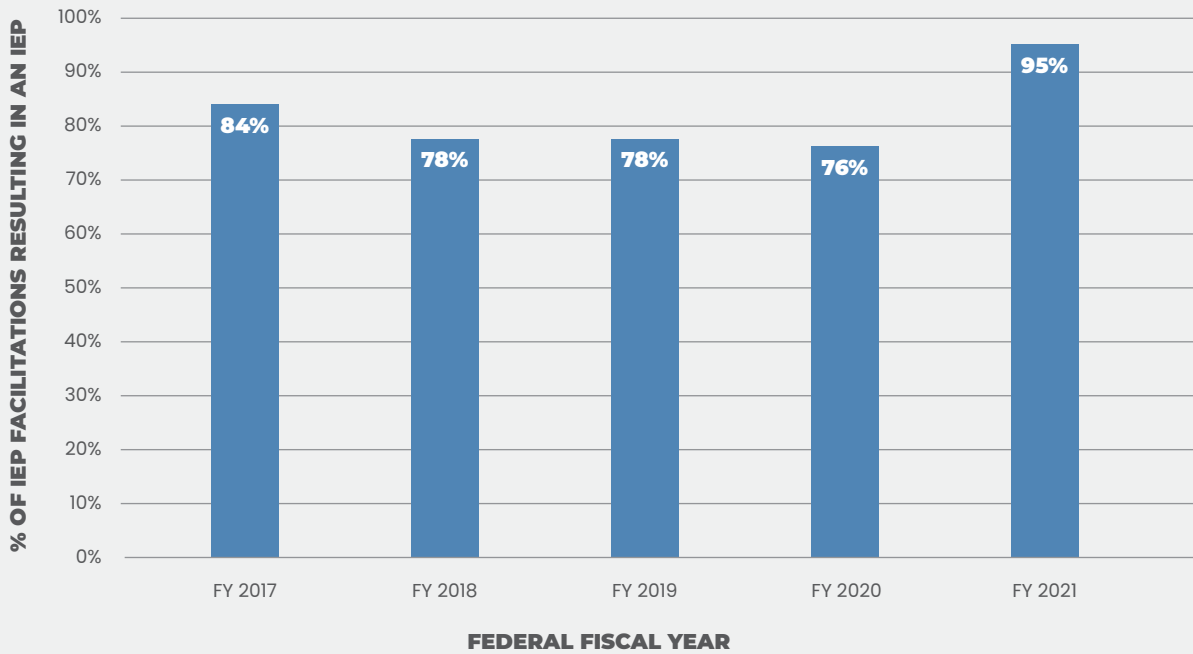
Out of the four facilitation requests in FY 2021 for ages 3-5, two facilitated IEP meetings were held, one of which resulted in a completed IEP and one which did not result in a completed IEP. One request for a facilitated IEP was declined and one was withdrawn.

Out of the 64 school aged IEP facilitations requested in FY 2021, 41 facilitated IEP meetings were held. An IEP was written during 25 of the facilitated IEP meetings and a partial IEP was written in 15 of the facilitated IEP meetings. In one case, the IEP was not agreed upon even with the assistance and support of a facilitator. In nine instances, parties declined to participate in IEP Facilitation. In 10 cases, the request for facilitation was withdrawn. In three instances, the LEA did not respond to the request for facilitation. In one instance, the request for a facilitator was made one day prior to the scheduled IEP meeting and a facilitator was not available.

Figure 2 displays the most recent five-year history of results of IEP Facilitations held. This year, 95% of IEP Facilitations resulted in a full or partial written IEP.

**GIEP – Outcomes**

There were two requests for GIEP facilitation. Neither moved forward to a facilitated GIEP meeting. In one case, the request for facilitation was withdrawn and in the other case there was no response from the LEA.



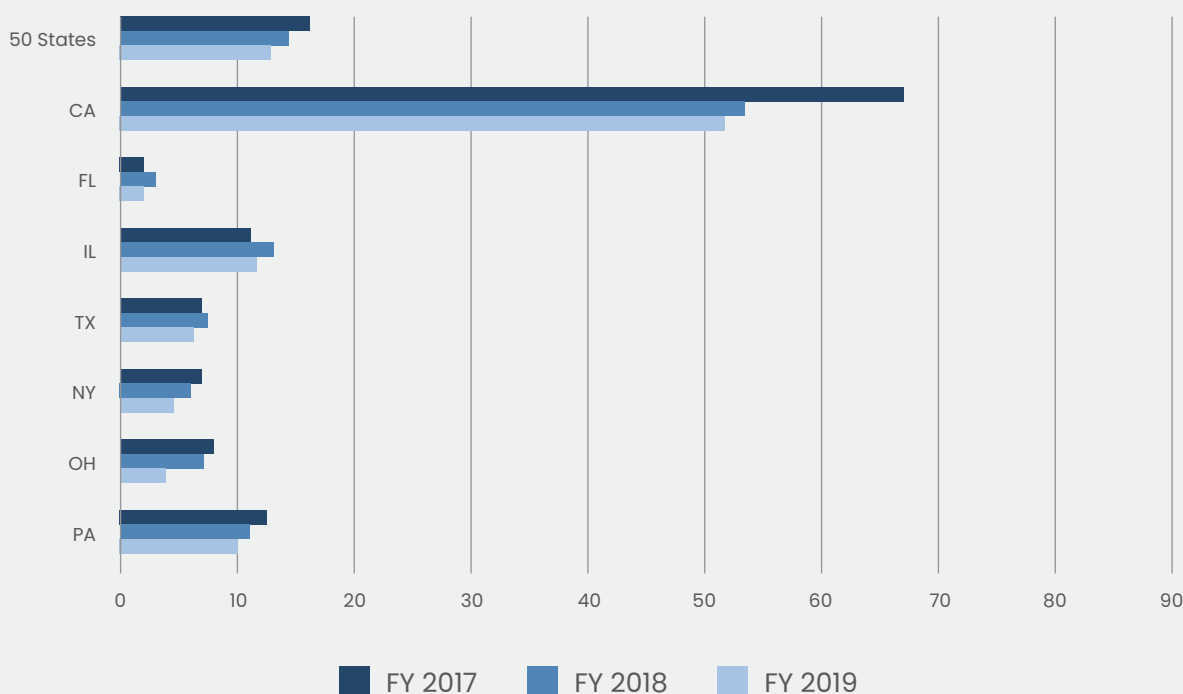

# MEDIATION

**Pennsylvania is a member of the 7-PAK Consortium of Large States<sup>8</sup> – those states with the largest number of children and students receiving special education services. While strict comparisons cannot be made among all states in the country, looking at states with similar characteristics to Pennsylvania provides some insight. When comparing Pennsylvania to the 7-PAK, our rate of dispute resolution activity is comparable and is evident in the following three comparison charts<sup>9</sup>:**

**FIGURE 3: MEDIATION REQUESTS PER 10K, FY 2017 THRU FY 2019**



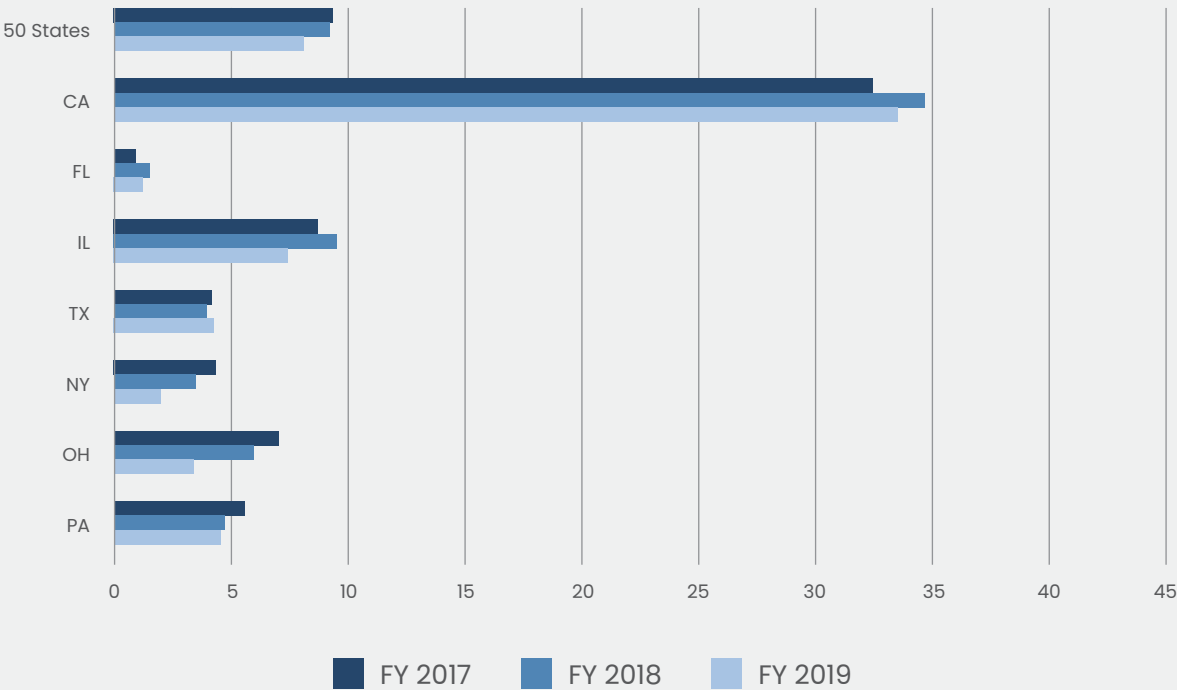
Pennsylvania ranks third among 7-PAK states in the number of mediation requests per 10,000 students with disabilities over the past three years. California leads this group by a very wide margin.

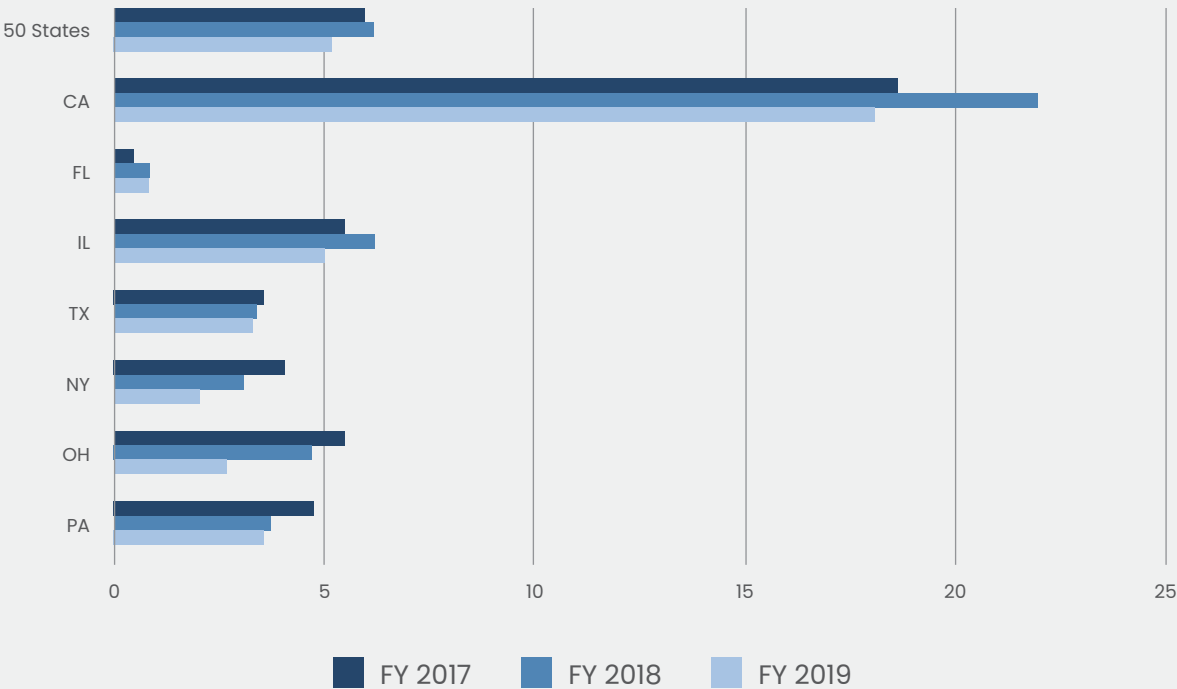

Pennsylvania ranks third among 7-PAK states in the number of mediations held per 10,000 students with disabilities over the past three years. Again, California leads this group by a very wide margin, which is expected since the number of requests far surpasses the remaining 7-PAK states.

Pennsylvania ranks third among 7-PAK states in the number of mediation agreements per 10,000 students with disabilities over the past three years. Again, it is not unexpected that California leads this group since it held the most mediations.

Pennsylvania lands solidly in the middle of the 7-PAK states for these three mediation measures. Efforts to encourage mediations as a vehicle for dispute resolution between parents and LEAs have led to encouraging outcomes.

Over the last several years, Pennsylvania's special education mediation process has undergone several changes. These changes include attorney participation in mediation, the use of pre-mediation outreach prior to some mediation sessions, the inclusion of evaluative mediation, and the option for parties to choose if they would like the mediation to be held virtually or in-person. While at first some of these changes were a necessary change in response to the global pandemic, all of these changes provide parties with expanded mediation options.

## **Mediation Outreach and Training**

Over the last several years, including FY 2021, ODR has been actively engaged in activities to promote the use of mediation. To raise awareness about mediation and share the benefits of the service, ODR has provided virtual and in-person trainings throughout FY 2021. These have included trainings to several LEA groups and special education administrators

about mediation and other alternative dispute resolution options. ODR has also reached out to Local Task Force groups and other organizations to offer presentations about available ODR services. ODR has presented to eight of these groups in FY 2021. ODR has presented to the Pennsylvania Virtual Fellowship Academy to share information about mediation and other dispute resolution options with special education leaders.

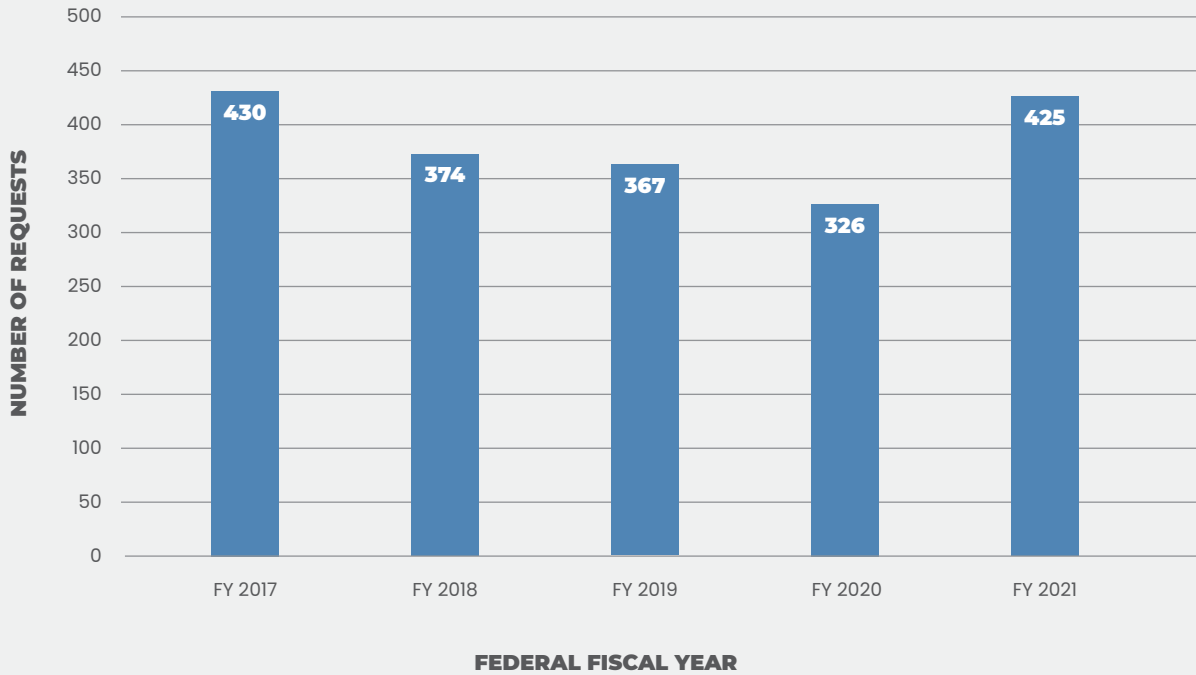
To ensure ODR is offering high-quality mediation services, ODR's contracted mediators participate in professional development activities throughout the year, related to both special education and mediation practices. In FY 2021, an ODR hearing officer presented a special education law training for all ODR mediators. Mediators also participated in the Pennsylvania Council of Mediators pre-conference session; the Pennsylvania Bar Institute's Snapshots of Special Education Law webinar and Exceptional Children Conference; the Pennsylvania Department of Education Conference; various webinars through CADRE, CASE, and LRP; and bi-monthly Community of Practice calls with peers.

## **Summary of Mediation Data**

During FY 2021, there were 425 requests for mediation. This is an increase of 99 requests from FY 2020.

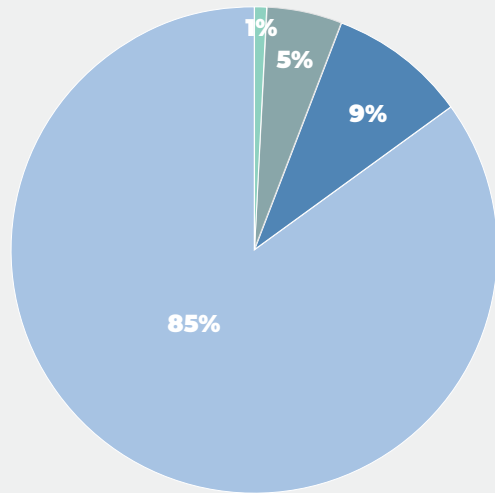
Eighty-five percent of mediation requests this year involved school age students with disabilities, and 9% involved children aged 3-5. Requests for students participating in gifted education programs comprised 5% of all mediation requests. This is similar with the distribution of requests from the previous year when 83% of requests involved school age students and 10% of requests involved children aged 3-5.

A total of 483 mediation outcomes were reported for this fiscal year, 58 of which were carried forward from the previous year. The vast majority of these requests were related to school age issues. As can be seen in Figure 8, more than half of mediation outcomes were reported as agreements (29%) or resolved outside of mediation (27%).

### Evaluative Mediation

In FY 2021, ODR introduced the option for parties to choose between a facilitative mediation or an evaluative mediation. In facilitative mediation, the mediator will guide the parties to common ground without interjecting feedback and will not offer any opinion about the strength or weakness of a party’s position. An evaluative mediator will use facilitative mediation techniques but may step in to ask directive questions and offer feedback and suggestions for the parties’ consideration. An evaluative mediator may also brainstorm about potential outcomes of the issues and talk about what a hearing officer might decide.

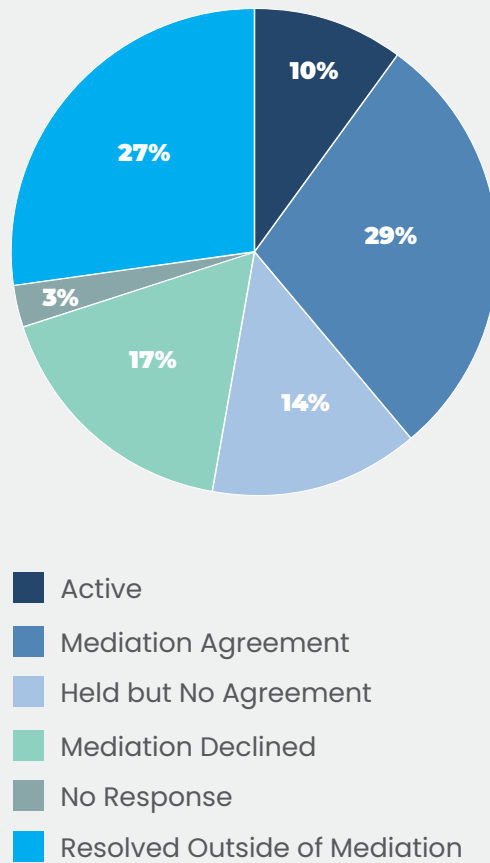
The first evaluative mediation was held in January 2022. In total, there have been five evaluative mediations held, all virtual. Four of five of the evaluative mediations held have resulted in a signed mediation agreement.

### Mediation Requests by Intermediate Unit

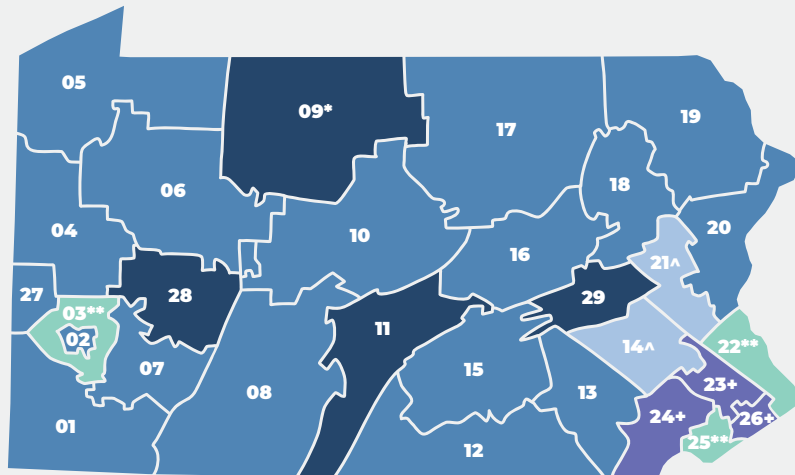
**FIGURE 9: PA MAP OF MEDIATION REQUESTS BY INTERMEDIATE UNIT FOR FY 2019**

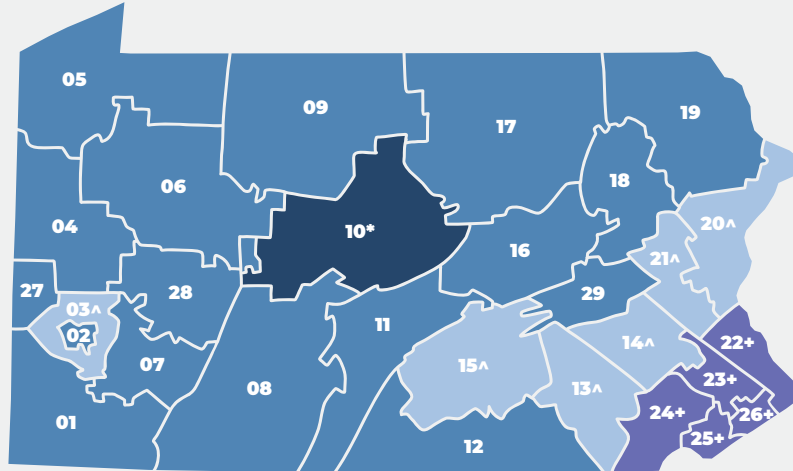
**FIGURE 10: PA MAP OF MEDIATION REQUESTS BY INTERMEDIATE UNIT FOR FY 2020**

There were few changes in the distribution of mediation requests by intermediate unit from the previous fiscal years. The three maps of the Commonwealth below (Figures 9, 10 and 11) demonstrate the consistency in statistics

in requests from FY 2019, when the pandemic occurred, to the present time.<sup>10</sup>

**FIGURE 8: TOTAL MEDIATION REQUEST OUTCOMES**



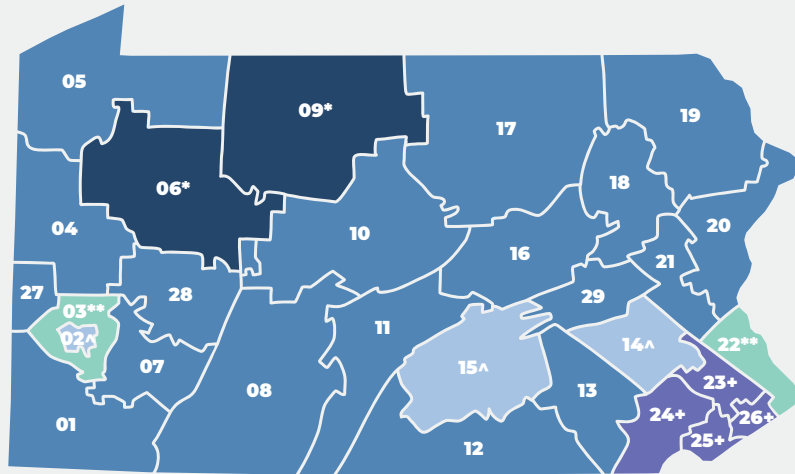

## Mediation Outcomes by Age and Category

Mediation is a voluntary process, and therefore, neither families nor LEAs are obligated to agree to participate, nor are they required to report the reason for their refusal to participate. This makes it challenging to assess why mediation is utilized in some instances and not others. Over the years ODR has implemented numerous strategies aimed at increasing participation in mediation. As to mediation agreement rates, mediation participants are encouraged to complete post mediation surveys in order to provide useful information to ODR on training needs.

The following charts show the breakdown in requests by age and outcome:

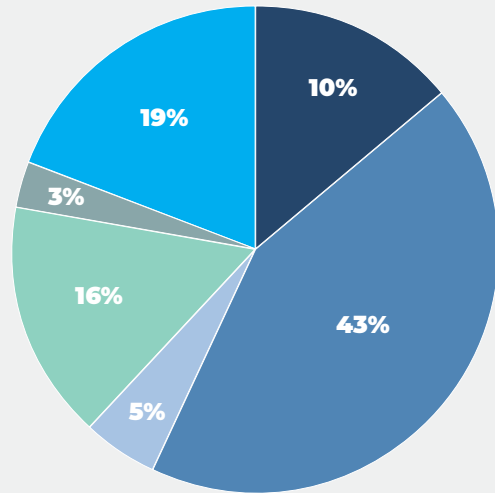

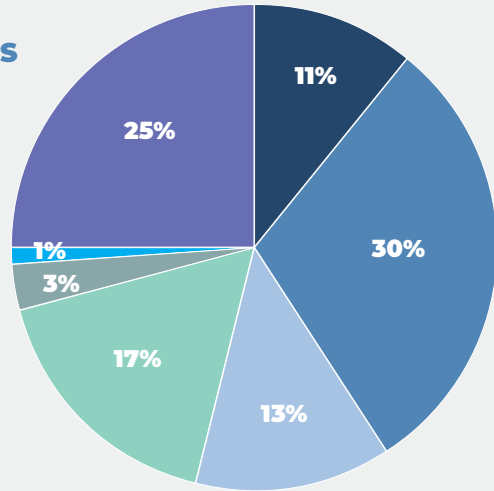

Overall, 29% of mediations held for gifted education disputes were resolved outside of mediation and 19% resulted in an agreement between parties.

### Mediation Agreement Rates

The overall mediation agreement rate for mediations held in FY 2020 was 67% and in FY 2021 the mediation agreement rate was 68%.

When a mediation is held but does not result in a written agreement, ConsultLine staff reach out to participants to learn more about why the mediation did not achieve its goals, as well as to provide additional information on dispute resolution options. The majority of respondents indicated the reason for not reaching a signed mediation agreement was that parties couldn't agree. Several respondents indicated that an agreement was reached shortly after the mediation. These responses support what mediators report, which is that even when parties did not agree to a written mediation agreement, there was often some movement toward agreement made during the

mediation session. While these smaller forms of agreement may not have been documented in a mediation agreement, they demonstrate that while a mediation looks "unsuccessful" on paper, it has oftentimes moved the dispute forward toward resolution.

In FY 2021, there were eight mediations with a related due process complaint that were held but did not result in a mediation agreement. Only one of these eight mediations resulted in a fully adjudicated due process hearing. The other due process complaints were resolved after the mediation was held.

### Virtual Mediation

ODR continues to provide virtual mediation as an option. Parties can choose whether they would like the mediation to take place virtually via Zoom or in-person. The virtual mediation option was a necessity when schools were closed during the pandemic and, even though schools have reopened to in-person learning, virtual mediation continues to be a popular option. Out of the 205 mediations held,

78% were held virtually. The virtual option allows more flexibility in scheduling for the parties and can be more convenient for families who may otherwise be unable to attend an in-person mediation.

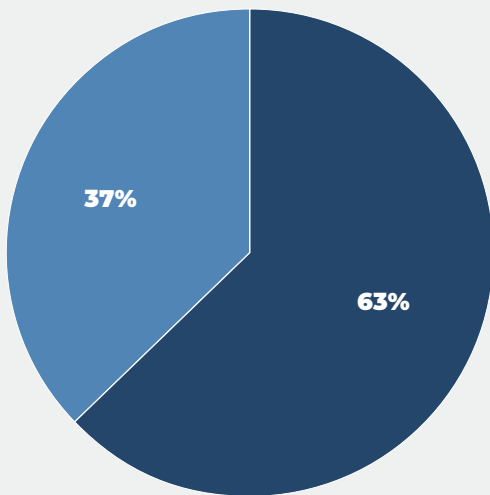
Of the 160 mediations held virtually during FY 2021, 63% resulted in a signed mediation agreement. Of the 45 mediations held in-person during this same time period, 89% resulted in a signed mediation agreement. ODR has noticed that parties sometimes allot a shorter period of time to mediations conducted virtually via Zoom. ODR encourages parties to allow sufficient time for a mediation session to ensure ample time for all steps of the mediation process.

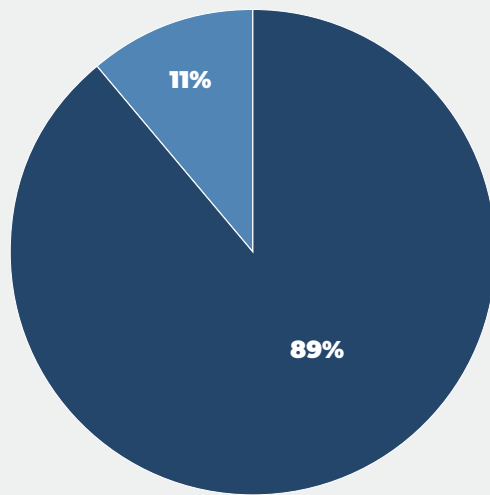
**FIGURE 14: MEDIATIONS HELD VIRTUALLY VS. IN-PERSON**

## Attorney Participation

Mediation in Pennsylvania underwent a significant change in March 2021, with the addition of attorney participation under certain circumstances. Since the inception of Pennsylvania's special education mediation program in 1986, attorneys had not been permitted to attend or participate in mediation in any way. During FY 2020, the Special Education Advisory Panel endorsed a change in this long-standing policy, recommending that the Commonwealth follow the process for attorney participation at resolution meetings. As of March 1, 2021, if the family chooses to bring an attorney to mediation, the LEA may also bring counsel. If the family chooses not to have counsel, the LEA likewise does not bring counsel. It is noteworthy that prior to this change, Pennsylvania was one of only four states that did not allow attorneys at mediation.

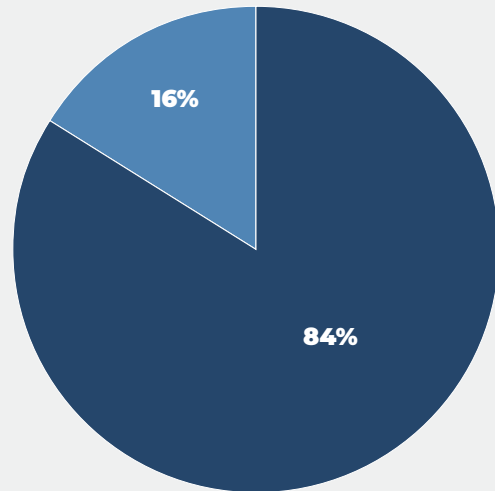

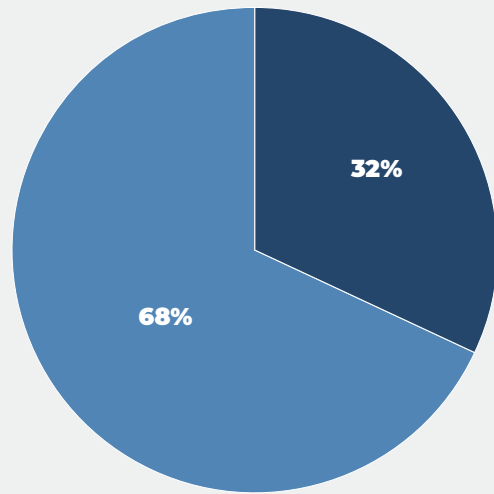
**FIGURE 16: MEDIATION OUTCOMES WITH NO ATTORNEYS PRESENT VS. ATTORNEYS PRESENT**

As shown in Figure 15, 16% (69) of 425 mediation requests submitted in FY 2021 involved parties who were represented by an attorney, and 84% (356) were unrepresented.

Of the 205 mediations that were held, 85% (174) did not include attorneys as participants and 31 (15%) were held with attorney participation.

Seventy-five percent (130) of the mediations held without attorneys resulted in a signed mediation agreement, compared to an agreement rate of 32% (10) for mediations held with attorney participation. When conducting research with the 7-PAK states on the potential addition of attorneys to mediation, ODR staff were advised to expect an initial reduction in mediation agreement rates with attorneys present. At times, disputes where attorneys attended the mediation do not resolve at the mediation session itself, but thereafter.

**Requests in FY 2021**



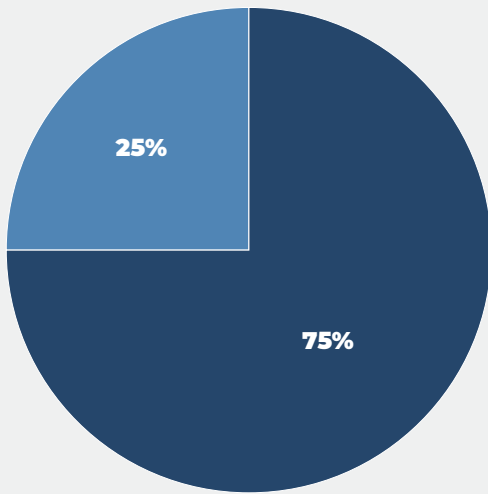

## Pre-Mediation Outreach

In March 2021, when attorneys were first permitted to participate in mediation, ODR began to require pre-mediation outreach when parties in a mediation were represented. This addition to the process was made to address a concern that attorney fees would be a barrier when writing a mediation agreement. Mediators were asked to discuss with attorneys how they plan on handling attorney fees, with the hope that the issue would be resolved prior to the mediation session. For mediations with unrepresented parties, pre-mediation outreach is optional.

When comparing outcomes of mediations held without attorneys, a higher rate of agreement was observed when pre-mediation outreach occurred. In mediations without attorneys, a signed agreement was reached when pre-mediation outreach was completed in 86% of the mediations. Without pre-mediation outreach, a signed agreement was reached in 70% of the mediations held without attorneys.

## Mediation Feedback

After each mediation, a survey is sent to parties to gather feedback about their experience with the process. Ninety percent of respondents rated their overall experience with the mediation process to be good, very good, or excellent. When asked to rate the ability of the mediator to promote a positive relationship between the family and school,

86% of respondents provided a rating of good, very good, or excellent. Ninety-four percent of respondents provided a good, very good, or excellent rating on the mediator's ability to allow both parties to feel heard. When asked to rate how well the mediator was able to help build relationships among parties, 81% of respondents provided a rating of good, very good, or excellent.

# DUE PROCESS





**Parents or educational agencies may also resolve educational disputes through a mechanism called due process. Due process differs from other dispute resolution opportunities in that a Hearing Officer decides the dispute for the parties. Throughout the due process proceedings, resolution through mediation—both facilitative and evaluative—remains available to the parties, as does Hearing Officer Settlement Conferences. In addition, during the proceedings, the parties may settle some or all of the issues among themselves at any time, and in most instances, do so.**

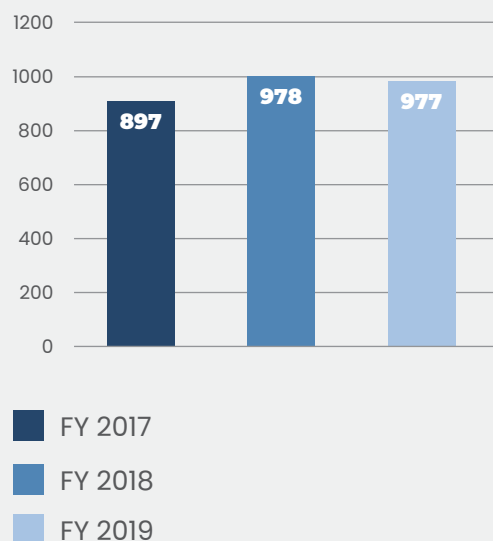
### **Due Process Requests**

As of June 2022, and the end of the FY 2021, most Pennsylvania schools had returned to in-person learning. In Pennsylvania, as is the case nationwide, the number of special education due process complaints continue to rise and resume a trajectory more in line with the number of complaints filed prior to the pandemic.

Beginning with the Annual Report for FY 2020, ODR began reporting data from CADRE<sup>11</sup>, the national technical assistance center on special education dispute resolution, in order to deepen the understanding of dispute resolution

across the country and Pennsylvania's standing in the national picture. CADRE's national data collection—which is current through FY 2019—demonstrates that special education dispute resolution activity nationwide is not monolithic. There are vast differences between and among all states based on both child count and activity. Despite Pennsylvania's size, the Commonwealth's rate of due process is comparable to the nation's average and not an outlier.<sup>12</sup>

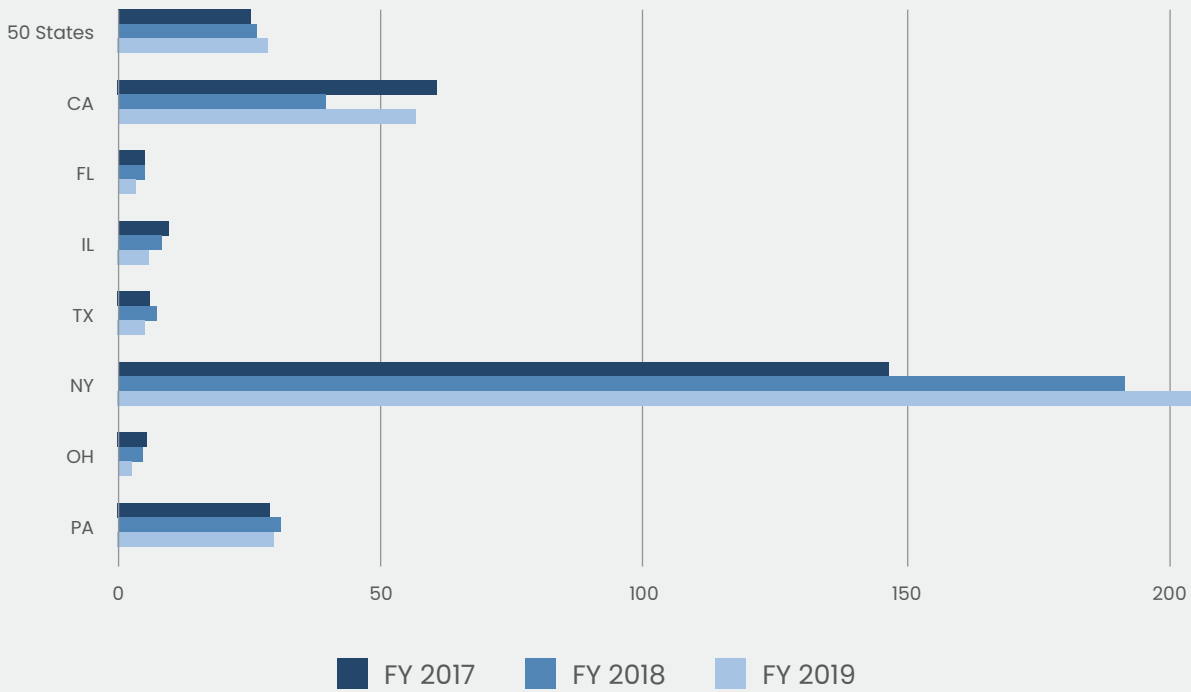
**FIGURE 17: DUE PROCESS COMPLAINTS IN PA, FY 2017 THRU FY 2019**



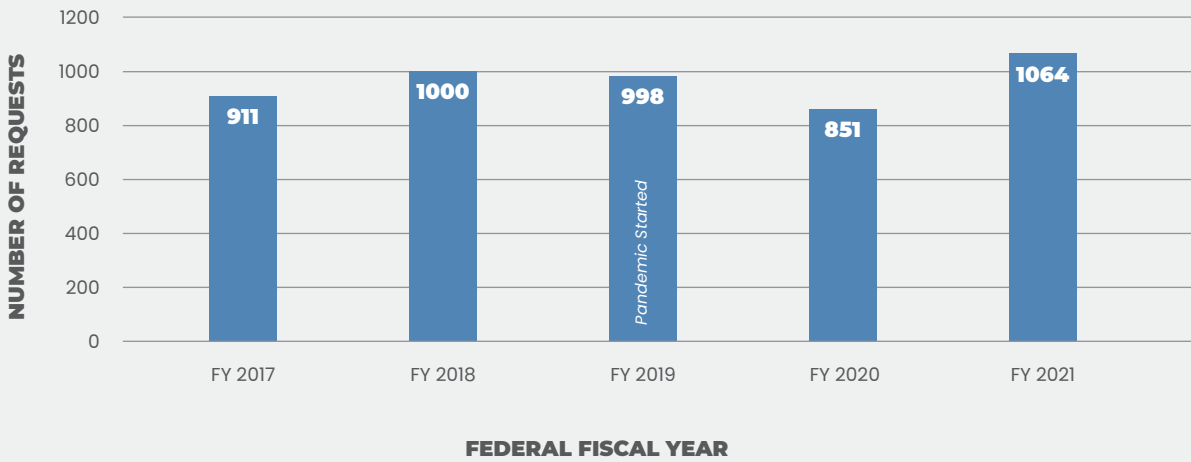

### Pro Se Parents

The overwhelming number of due process requests come from an attorney representing the parent. In a minority of cases, parents requested ODR services on their own, without being represented by counsel (i.e., “pro se”). The following table lists the age group or category; the number of requests received; and how many requests came from pro se parents. The number of pro se parent requests are a subset of the total number of requests received. Results of pro se parent cases appear in the Due Process Outcomes section below.

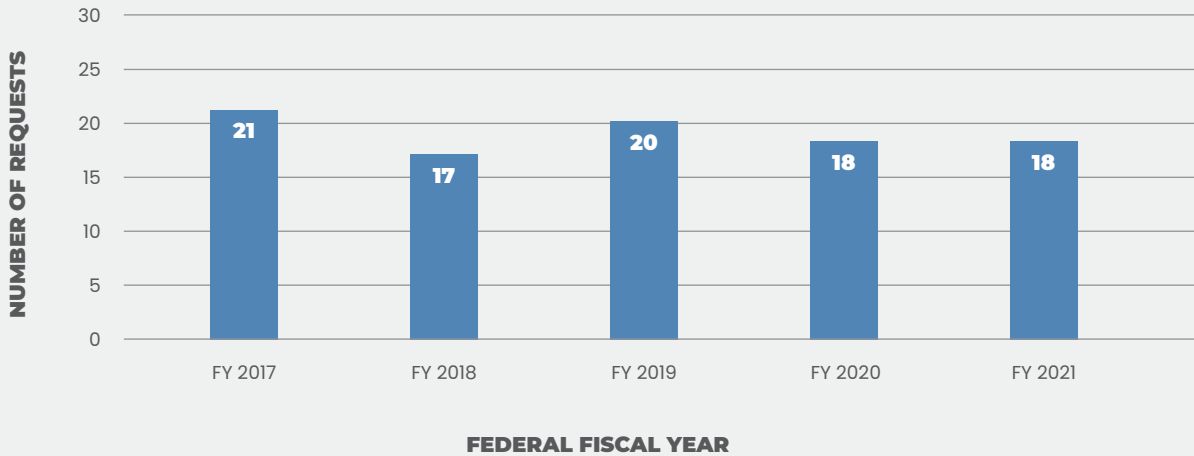

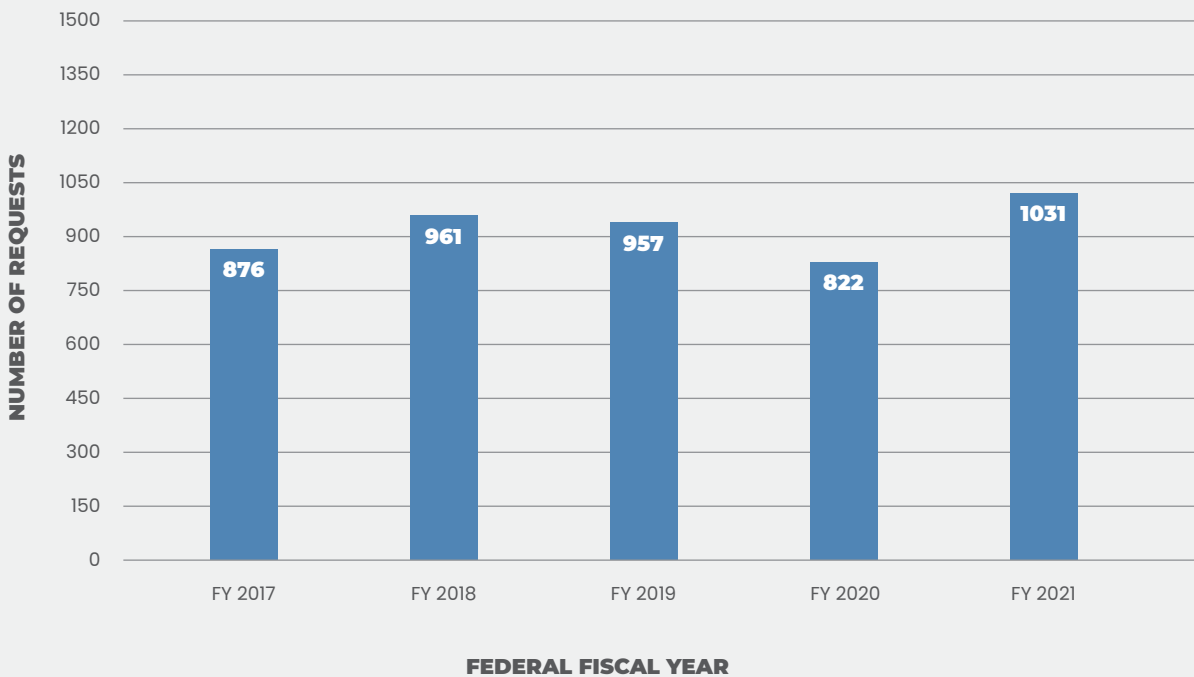
### Five-Year Retrospective of Due Process by Age Group

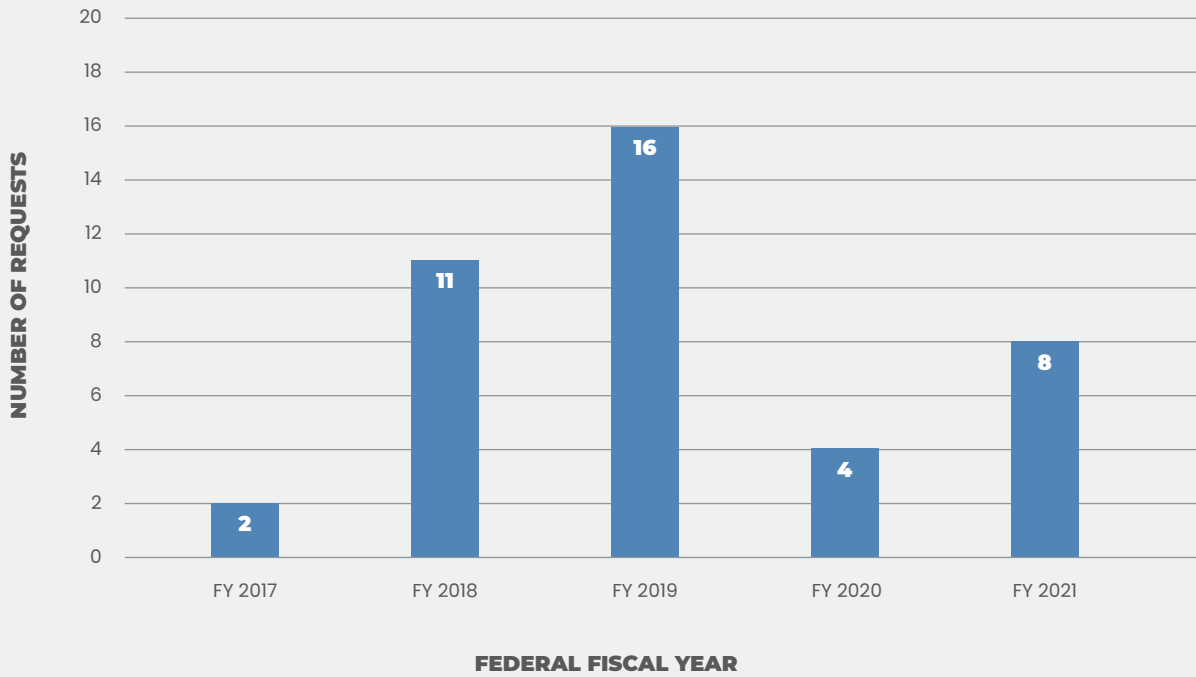
**FIGURE 20: DUE PROCESS REQUESTS – 3-5**



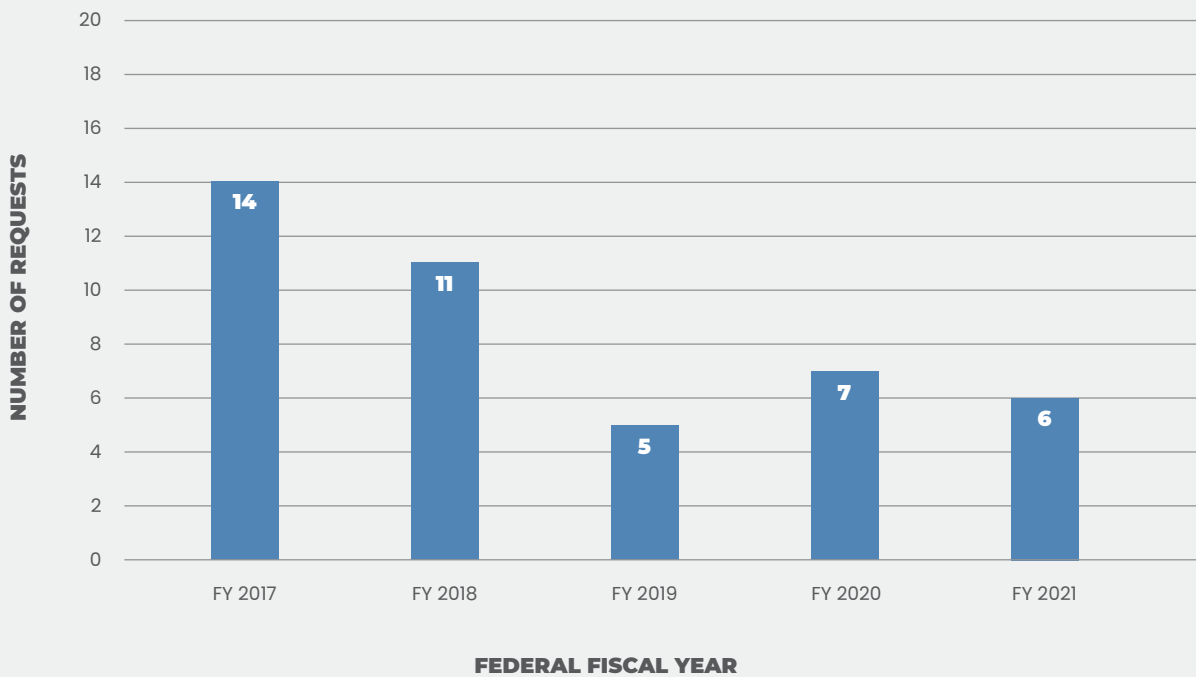
**FIGURE 21: DUE PROCESS REQUESTS – SCHOOL AGE**

**FIGURE 23: DUE PROCESS REQUESTS – GIFTED EDUCATION**

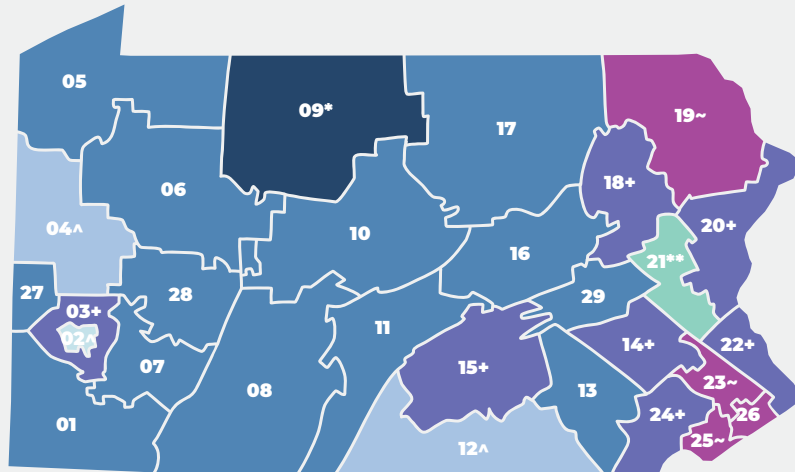
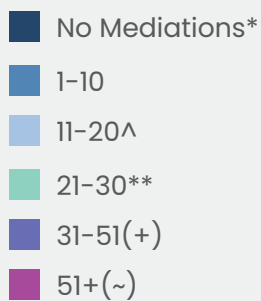




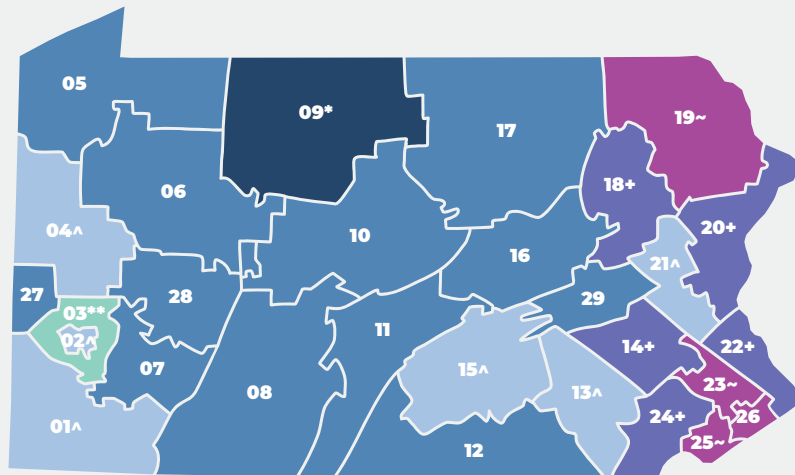
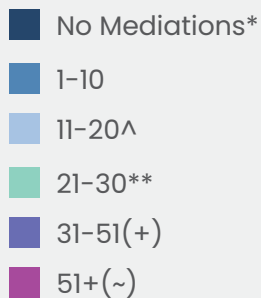
## Frequency of Due Process Across the Commonwealth

**FIGURE 24: PA MAP OF DUE PROCESS REQUESTS BY INTERMEDIATE UNIT FY 2019**

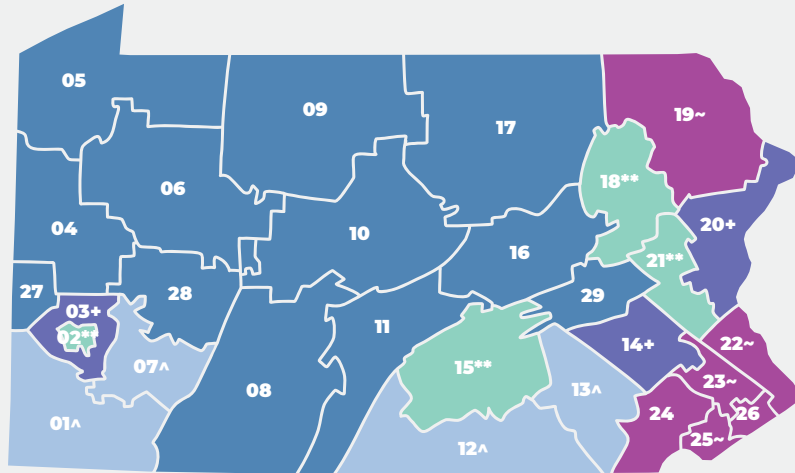
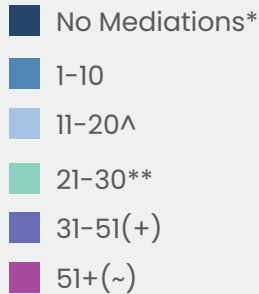


**FIGURE 25: PA MAP OF DUE PROCESS REQUESTS BY INTERMEDIATE UNIT FY 2020**

## Due Process Outcomes

### Requests

A total of 1064 requests were received during FY 2021. A total of 148 requests from FY 2020 carried over into the current fiscal year. The outcomes of these cases are as follows:

### Settlement or Withdrawal

#### ***FY 2021 cases***

In 725 cases (68%), the parties reached agreement without the need for a fully adjudicated hearing. This is similar to the settlement rate of 70% observed last year. Only 19 cases went to at least one hearing before settling. In 84 cases, the parties reported a withdrawal of the request without specifying the reason for the withdrawal (e.g., settlement, dropping of the request, etc.).

#### ***FY 2020 cases***

In 101 cases, the parties reached agreement without the need for a fully adjudicated hearing. Only three cases went to at least one hearing before settling. In nine cases, the parties reported a withdrawal of the request without specifying the reason for the withdrawal.

### Hearing Officer Dismissal

#### ***FY 2021 cases***

The hearing officer dismissed the case in 22 instances because there was no response from the parent; the filing was untimely; the complaint was insufficient; the hearing officer lacked jurisdiction; the wrong party was named; the issue was rendered moot;

and res judicata applied because the issues raised had been previously decided.

#### ***FY 2020 cases***

The hearing officer dismissed the case in three instances because the parent didn't respond, or the due process complaint was not filed timely.

### Hearing Officer Decisions

#### ***FY 2021 cases***

The hearing officers wrote 51 decisions on requests received during FY 2021, an increase of 33 over the number written the prior year. After a decision is issued, the hearing officer categorizes the result for purposes of the Annual Report. This is not a precise calculation; the hearing officer has to use his or her best judgment in assessing whether the decision supports the parent or the LEA. The hearing officers categorized their decision outcomes as follows:

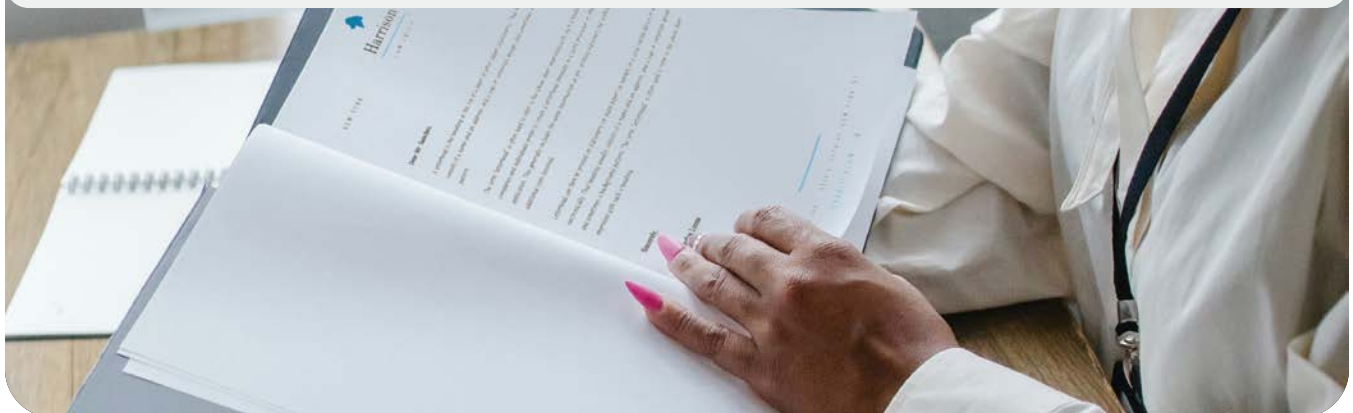

## Appeals to the State and Federal Court

During FY 2021, there were 24 appeals to federal court; there were no appeals to state court. Only two of these appeals pertained to FY 2021 requests for hearing, with the balance pre-dating the reporting period. Parents accounted for 87% of the total number of appeals filed. Three of the appeals were limited to attorneys fees. As of the close of the reporting period, 21 cases were still in progress. Parties settled in the remaining three cases.


