Through the Office for Dispute Resolution (ODR), the Pennsylvania Department of Education (PDE) fulfills its statutory mandate to maintain a special education due process system. PDE contracts with the Central Susquehanna Intermediate Unit (CSIU) to provide fiscal and certain management support for that office, without becoming involved in substantive operations. The hearing officers and mediators are free from interference or influence on any matters affecting the outcome of individual mediations and due process hearings. This includes, without limitation, interference, or influence from any entity, individual, or group, such as parents, advocacy groups, school districts, intermediate units including CSIU, ODR staff, and PDE. At the same time, those hearing officers and mediators are provided with administrative support, as well as training delivered in a manner preserving their impartiality through ODR, which itself is also free of such interference or influence.

The Central Susquehanna Intermediate Unit will not discriminate in educational programs, activities or employment practices based on race, color, national origin, gender, disability, marital status, age, religion, sexual orientation, ancestry, union membership or other legally protected classifications. Announcement of this policy is in accord with Title VI of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, and the Americans with Disabilities Act of 1990. 

The Office for Dispute Resolution (ODR) provides the resources for parents and local educational agencies (LEAs) to resolve educational disputes involving children served by the early intervention system, students with disabilities (or thought to have disabilities) and students who are gifted (or thought to be gifted).1

Pennsylvania's recognition as an "exemplar state" by the Office for Special Education Programs (OSEP) and the Center for Appropriate Dispute Resolution in Special Education (CADRE) is an acknowledgement of the experience, education, and training of ODR staff² and the quality of ODR services provided.³ In addition to its website, publications, and videos, ODR remains in contact with its stakeholders through a listserv. ODR's listsery is available at https://odr-pa.org/subscribe-to-odr/.

During the COVID-19 shutdown, ODR provided all its services in a virtual format. There has now been a return to in-person facilitations, mediations, and due process, but at nowhere near pre-pandemic levels. In due process in particular, the hearing officer and parties may meet in person for one session, and meet virtually for another. The option also exists for one or more parties to meet in person, while others participate virtually. The virtual option continues to be a popular, frequently used choice by both parents and LEAs, as it accommodates the parties' unique needs.



Fiscal year (FY) 20194 is when the pandemic and resulting shutdown occurred, and pandemic-related school closures continued into FY 2020. The statistics from those years are outliers, and difficult to reconcile within a five year comparison of ODR services. What is clear, however, is that mediation is on the rise, excluding the FY 2019 and FY 2020 numbers. In FY 2018, there were 374 mediation requests and in FY 2022, there were 479 requests. IEP facilitation jumped from 68 in FY 2021 to 101 in this reporting period. Due process dropped from 1064 in FY 2021 to 953 during this reporting period. ODR continues to work with a research and evaluation consultant in evaluating the statistical data.

ODR Stakeholder Council

The ODR Stakeholder Council brings together representatives from a broad array of stakeholders to provide functional input and recommendations on the special education dispute resolution system. Detailed biographical information on each member is available on the ODR website⁵. ODR, with its Stakeholder Council, remains committed to encouraging IEP facilitation and mediation as effective dispute resolution tools, while continuing to recognize due process as an important procedural safeguard for parents.

Outreach

Presentations by ODR staff and hearing officers included: Arc Alliance; Pennsylvania Bar Institute; Special Education Advisory Panel (SEAP); Hispanos Unidos para Niños Excepcionales (HUNE); The Arc of Lancaster Lebanon and The Arc of Northeastern

Pennsylvania; Fellowship for Leadership; Universities, including East Stroudsburg, Pittsburgh, and West Chester; Pennsylvania Department of Corrections; and various Intermediate Units and Local Task Force groups.

Again this year, ODR, CADRE, and the State of Oklahoma co-sponsored a national Hearing Officer Academy. The ODR-CADRE collaboration will continue in the next fiscal year.

The ODR staff produces videos, webinars, and podcasts on topics relevant to both parents and educators. Development of training products is an ongoing process and based upon identified stakeholder needs. During FY 2022, ODR produced the following video shorts: What is the Timeline for an Evaluation; and What is a Resolution Meeting. Additionally, the following webinars were created: Disputes in Education: Why Attorneys Choose Mediation over Litigation; and Evaluative Mediation Overview.

Hearing Officer Training

The hearing officers engage in rigorous professional development each year, both in-house and through highly regarded professional associations. Hearing officers attended trainings held by the following groups: LRP Institute; National Association of Hearing Officials (NAHO); Center for Appropriate Dispute Resolution in Special Education (CADRE) National Symposium and Hearing Officer Academy; as well as several trainings and webinars sponsored by the Pennsylvania Bar Institute and Council of Administrators of Special Education (CASE). Additionally, hearing officers have also participated in webinars and trainings from various organizations related to special education.

ODR Projects

Local Level Facilitated IEP Training

ODR continued to offer local level facilitated IEP training through Key2Ed to those LEAs with the most due process activity. Elwyn (the largest state-approved private school in Pennsylvania), the School District of Philadelphia, and Bucks County Intermediate Unit participated in additional training opportunities. Feedback for Key2Ed was consistently positive. ODR is working with Key2Ed to determine if there is a consultative role Key2Ed could perform for some of these LEA.

Hearing Officer Settlement Conferences

Since March 2017, Hearing Officer Settlement Conferences (HOSCs) have been a regularly offered service to parents and educators. ODR maintains a randomized list of HOSC hearing officer assignments. When parties request a HOSC, the next hearing officer on the list is assigned, after confirming that she or he does not have an ongoing case with the parent or the LEA. Each hearing officer has a slightly different approach to the details of a HOSC, but the same general framework applies a three-sided conversation between the settlement hearing officer and the attorneys (or LEA attorney and pro se parent) takes place. Thereafter, the settlement hearing officer typically has an individual conversation with each party. At that point, each HOSC moves in its own unique direction—sometimes resolution has been achieved, sometimes further three-sided conversations are held. and sometimes further individual conversations are held. The HOSC can continue until the parties feel it has met its goals, or the parties can continue without the settlement hearing officer. For this reporting period, there were 15 HOSC processes (11 completed, three still ongoing, and one settled prior to the HOSC taking place), resulting in an 82% settlement rate for completed processes. This mirrors the overall 82% settlement rate since the inception of the program. Additional information about HOSCs is available on the ODR website.6

The Special Education ConsultLine is an information helpline for parents and advocates who have questions or concerns about special education for school-age children. ConsultLine is staffed by three specialists who provide information about special education, gifted education, and Section 504 of the Rehabilitation Act of 1973. Specialists assess the nature of the caller's inquiry or concern and provide information and assistance.

ConsultLine specialists also handle ODR's parent engagement services, providing technical assistance to parents who are preparing to participate in mediation and IEP facilitation, and/or represent themselves in a due process hearing, and conduct outreach efforts to participants who participated in ODR services.


The types of information provided include:



ConsultLine can be reached via phone, email, online contact form, or ODR's Live Chat website feature. Specialists respond to requests for information by directly calling a constituent. In an attempt to speak with everyone who has requested information, specialists call individuals at least three times over the course of three business days. This has been an effective protocol for providing service in an equitable and timely manner.

Live Chat allows constituents to ask questions in real time Monday through Friday, from 8:30am to 3:30pm, regarding any ODR service. After hours, constituents can fill out a ticket to request a follow-up phone call the next business day.

ConsultLine specialists work diligently behind the scenes to ensure that all constituents have access to the most updated and accurate information and resources. This includes the following activities:




- Ensuring that Hearing Officer decisions have all personally identifiable information removed and that the decisions meet accessibility standards prior to posting on ODR's website;
- Maintaining the Hearing Officer Decisions and Parent Resource Library sections of ODR's website;
- Conducting group presentations for interested stakeholders via in-person or virtual sessions on the function, purpose, and services of ODR;
- Managing ODR's publications to ensure they remain up-to-date and meet accessibility standards; and
- Developing informational short videos on topics that are frequently discussed during ConsultLine calls

Call Activity

During FY 2022, ConsultLine specialists served 2,538 constituents. The services provided include:

- ConsultLine calls, where specialists answer questions and provide information to parents and advocates related to special education concerns:
- Family engagement outreach, where specialists provide assistance to parents who have an active facilitation, mediation, or due process hearing in which they are representing themselves;
- Outreach to parties involved in a mediation session that did not result in a written agreement in order to gather feedback;
- Follow-up calls to respondents from the Dispute Resolution survey to further discuss any comments, suggestions, and/or concerns about their recent ODR service; and
- ODR Live Chat, where specialists respond to questions and provide information to individuals who reach out to ODR via the chat function on the website.

ConsultLine specialists are able to serve constituents who speak a language other than English through a third-party interpretation service. During FY 2022, the interpretation service was used 16 times to provide service in Spanish.



Regional Representation of Inquiries

Regional information was volunteered during 1,033 calls during FY 2022. This number represents just over 40% of all calls. The following Intermediate Units had the highest amount of outreach to ConsultLine specialists based upon voluntary disclosure of location.

Types of Inquiries

ConsultLine specialists document the main topics associated with a caller's question(s). During FY 2022, the most regularly recurring topics, in order of frequency, pertained to the following:

Other high-interest topics included multidisciplinary evaluation, IEP implementation, discipline, and transportation.

Specialists provided publications, forms, web resources and other materials related to the caller's interests in 1156 instances. The majority of this information was electronically delivered.

Call Resolution Process and Provision of BSE Complaint Packets

ConsultLine's Call Resolution Process (CRP) is an effective dispute resolution tool for compliance-related concerns for IDEA-related issues and certain types of concerns related to Section 504 of the Rehabilitation Act of 1973. During a CRP, the specialist acts as a conduit of information between the parent (as defined in 34 CFR 16 § 300.30) and the school; the specialist does not serve as an advocate, decision-maker, mediator, or compliance advisor.

The CRP format and process includes an email summarizing the parent's compliance-related concerns, and to the extent known, the parent's proposed resolution. The email is prepared by the specialist in consultation with the parent so that the message accurately reflects the parent's concern. Once the message is drafted and reviewed with the parent, the parent provides verbal consent to send the message to the LEA administrator responsible for special education, the appropriate regional BSE division chief, and the regional BSE advisor. Once this email has been sent, the specialist's involvement in the CRP has concluded.

During FY 2022, a CRP was offered to 51 callers, and distributed with the parent's permission in 25 instances. Common reasons for declining the distribution of the CRP were that the parent wanted to try to work out the situation locally, the parent did not feel the email would be successful, or the parent wanted to file a complaint rather than send a CRP email.

Information about the BSE complaint process and the state complaint form is sent to the parent when CRP has been offered, and also when specifically requested by the caller.

During FY 2022, 56 state complaint forms and information packets were distributed to callers.

Chapter 16/Gifted Education

ConsultLine specialists assist callers who have questions or concerns about Chapter 16/gifted education. Some of these callers allege compliance violations. When this occurs, the specialist provides the caller with information about the procedural safeguards for gifted education, including the option to file a written complaint. During FY 2022, ConsultLine responded to 23 callers whose questions or concerns were specifically related to gifted education. The most frequent topics discussed include Chapter 16/gifted education regulations, procedural safeguards, clarification of regulations, GIEP content, and gifted multidisciplinary evaluation.

ConsultLine Feedback

When callers provide contact information, specialists conclude service by mailing or emailing an evaluation survey to the caller. The survey is brief and anonymous. Survey participants are asked to provide comments and to answer five satisfaction-based questions. Survey respondents assess the following areas: usefulness of information; identifying options for resolving concerns; timeliness of service; and general satisfaction. For FY 2022, survey results show that ConsultLine continues to maintain a high level of satisfaction from constituents.

Professional Development

ConsultLine staff continue to participate in high quality professional development opportunities to remain well-informed and effective in conveying useful information and relevant resources to callers. During FY 2022, professional development activities included the LRP National Institute; Pennsylvania Bar Institute's Exceptional Children Conference; and the Council of Administrators of Special Education (CASE) Quarterly Legal Review.





ODR provides two types of facilitation: IEP/IFSP/GIEP/Section 504 facilitation and resolution meeting facilitation. Both types of facilitation are voluntary, meaning it can only be used when all parties agree to allow a neutral third party, a facilitator, to attend the meeting.

Resolution Meeting Facilitation

A resolution meeting is required for due process requests initiated by parents, unless both parties agree to waive the meeting or utilize mediation. If both parties believe that the use of a neutral third party will increase the likelihood of reaching an agreement during the meeting, ODR will provide a facilitator upon request. Resolution Meeting Facilitation (RMF) helps parents and educators focus on the student's needs during the resolution meeting.

During FY 2022, ODR received six requests for a facilitator to attend a resolution meeting.


There was one request for a resolution meeting facilitation that was made during FY 2021 but the facilitated meeting occurred in FY 2022. Of the seven facilitations held during FY 2022, one ended with a resolution agreement. Of the six cases that did not end in an agreement, only one case moved forward to a fully adjudicated due process hearing. The remainder of the related due process hearings were withdrawn (3) or reached a due process agreement (2).

IEP Facilitation

Individualized Education Program (IEP) Facilitation is an option available to parents and school staff when they both agree that it would be valuable to have a neutral person, an IEP Facilitator, present at an IEP meeting. The IEP Facilitator assists in creating an atmosphere for open communication and the successful drafting of an IEP for the student. Facilitation services are also available for IFSP meetings for early intervention services, preschool services, GIEP meetings for students who are gifted, and 504 meetings for students who are eligible under Section 504.

Requests

In FY 2022, there were a total of 101 requests for IEP/GIEP/504 facilitation. This is a 49% increase in requests from last fiscal year. Consistent with prior years, the overwhelming majority of these requests (96) pertained to IEP meetings for school-aged students. Of the five remaining requests, one was for the IEP of a preschool child aged 3-5, three were for GIEP meetings, and one request was for a 504 plan meeting. There were no requests for birth-3 IFSP facilitation.



Outcomes

IDEA IEP Facilitation


Early Intervention Ages 3-5

The one request for IEP facilitation for ages 3-5 was withdrawn.

School Age

Of the 96 IEP facilitations for school-age students requested in FY 2022, 62 facilitated IEP meetings were held. A complete IEP was written during 32 meetings and a partial draft IEP was written in 18 meetings. In 12 cases, the IEP was not completed, even with the assistance and support of a facilitator. These outcomes show that 81% of the facilitated IEP meetings that took place in FY 2022 resulted in a full or partial IFP written.

Thirty-four requests for facilitation did not move forward to an IEP meeting for a variety of reasons. Fourteen of the requests were withdrawn. In nine instances, parties declined to participate in a facilitated IEP meeting. For three requests, the LEA did not respond to the request for facilitation and in five instances, the parent did not respond to the request for facilitation. In one case, the request for a facilitator was made one business day prior to the scheduled IEP meeting and a facilitator was not available. Finally, two IEP facilitation cases were still active at the end of the FY 2022 reporting period.



Gifted Education

There were three requests for GIEP facilitation. One of the requests was withdrawn and two of the requests moved forward to a facilitated GIEP meeting. Of these two meetings, one resulted in a completed GIEP and one did not result in a written GIEP.

Section 504

There was one request for a 504 meeting facilitation. This request did not move forward to a facilitated 504 meeting because there was no response from the LEA.





Pennsylvania is a member of the 7-PAK Consortium of Large States⁷, which includes the seven states with the largest number of children and students receiving special education services. While strict comparisons cannot be made among all states in the country, looking at states with similar characteristics to Pennsylvania provides some insight. When comparing Pennsylvania to the 7-PAK, the Commonwealth's rate of dispute resolution activity is comparable as is evident in the following three comparison charts8, which show the most recent federal data available (FY 2020):



In FY 2020, Pennsylvania ranked third among 7-PAK states in the number of mediation requests per 10,000 students with disabilities. California leads this group by a wide margin.






FIGURE 6: MEDIATION AGREEMENTS PER 10K, FY 2018 THRU FY 2020



Pennsylvania ranks fourth among 7-PAK states in the number of mediations held per 10,000 students with disabilities in FY 2020. Again, California leads this group by a wide margin, which is expected since the number of requests far surpasses the remaining 7-PAK states.

Pennsylvania is tied with NY for fifth among 7-PAK states in the number of mediation agreements per 10,000 students with disabilities in FY 2020. Again, it is not unexpected that California leads this group since it held the most mediations.



As in previous years, Pennsylvania lands in the middle of the 7-PAK states for these three mediation measures. ODR continues to make efforts to encourage mediation as a vehicle for dispute resolution between parents and LEAs. These efforts have led to encouraging outcomes in FY 2022 as set forth below.


Mediation Outreach and Training

During FY 2022, ODR has continued to engage in activities to raise awareness about mediation and share the benefits of the service. No-cost training sessions about ODR services, including mediation, are available to LEAs and parent organizations. ODR has presented to a variety of organizations in FY 2022, including Local Task Force groups, local Arc chapters, and parent training information centers.

To ensure ODR is offering high-quality mediation services, ODR's contracted mediators participate in professional development activities throughout the year, related to both special education and mediation practices. In FY 2022, an ODR hearing officer presented a special education law training for all ODR mediators. Mediators also participated in the Pennsylvania Council of Mediators conference, the Technical Assistance for Excellence in Special Education's mediation training, various webinars through CADRE, CASE, and LRP, and bi-monthly Community of Practice meetings with peers. In addition, to highlight best practices when mediating virtually, mediators participated in a training with Key2Ed on strategies to use during virtual mediation sessions.


Summary of Mediation Data

During FY 2022, there were 479 requests for mediation. This is a 13% increase in requests from FY 2021.



Eighty-nine percent of mediation requests this fiscal year (424) involved school age students with disabilities. Sixteen of these requests were for students who were twice exceptional, meaning they were eligible for both special education and gifted education. There were 34 requests for children aged 3-5 (7% of total requests) and one request for a birth-3 aged child. There were 16 mediation requests for students participating in gifted education programs, or 3% of the total received, and there were 4 requests for Section 504/protected handicapped students, or 1% of the total received. This is similar to the distribution of requests from the previous year when 85% of requests involved school age students and 9% of requests involved children aged 3-5.

A total of 526 mediation outcomes were reported for this fiscal year, 47 of which were initiated in the previous fiscal year (FY 2021) but closed in this fiscal year (FY 2022). The vast majority of these cases were related to school age issues. As can be seen in Figure 9, over a quarter of the mediation outcomes were reported as agreements (28%) and over a quarter were resolved outside of mediation (26%).



Mediation Requests by Intermediate Unit




FIGURE 11: PA MAP OF MEDIATION REQUESTS BY INTERMEDIATE UNIT FOR FY 2020






FIGURE 12: PA MAP OF MEDIATION REQUESTS BY INTERMEDIATE UNIT FOR FY 2021

There were few changes in the distribution of mediation requests by intermediate unit from the previous fiscal years. The four maps of the Commonwealth (Figures 10, 11, 12, and 13) demonstrate the consistency in statistics in requests from FY 2020 to the present time.

Mediation Outcomes

The following mediation outcomes include all FY 2022 mediation requests plus the outcomes of FY 2021 mediation requests that remained active at the end of last reporting year and closed in FY 2022, for a total of 526 outcomes to report.

Total Mediation Agreement Rate

There were 214 mediations held in FY 2022. Of these mediations, 147 resulted in a signed mediation agreement, which is a mediation agreement rate of 69%.


There was one mediation request for a birth-3 dispute. A mediation session was held, however, the parties did not reach a mediation agreement.







Mediation is a voluntary process, and therefore, neither families nor LEAs are obligated to agree to participate, nor are they required to report the reason for their refusal to participate. This makes it challenging to assess why mediation is utilized in some instances and not others. Over the years, ODR has implemented numerous strategies aimed at increasing participation in mediation.

Mediations Held Without Agreement

When mediation is held but parties aren't able to reach a written agreement, ConsultLine staff reach out to participants to learn more about why the mediation did not achieve its goals, as well as to provide additional information on dispute resolution options. The majority of respondents indicated the reason for not reaching a signed mediation agreement was simply that parties couldn't agree on the terms of the agreement.

In FY 2022, there were 12 mediations held that had a related due process complaint active at the same time as the mediation session. Half of them resulted in a signed mediation agreement, thereby eliminating the need for a due process hearing. Only one of the remaining six related due process complaints resulted in a fully adjudicated hearing with a hearing officer decision; the other five resolved in some fashion after the mediation session without the need for a due process hearing.

Parties frequently report to ODR that after their unsuccessful mediation session, they continue discussions and end up coming to an agreement outside of mediation. These responses support what mediators report and what the mediations related to due process data above supports, which is that even when parties are unable to reach agreement at the mediation session, settlement is still a possibility afterwards. While these smaller forms of agreement may not have been documented in a mediation agreement, they demonstrate that while a mediation looks "unsuccessful" on paper, it has oftentimes moved the dispute forward toward resolution.

Evaluative Mediation

In FY 2021, ODR introduced the option for parties to choose between a facilitative mediation or an evaluative mediation. In facilitative

mediation, the mediator will guide the parties to common ground without interjecting feedback and will not offer any opinion about the strength or weakness of a party's position. An evaluative mediator will use facilitative mediation techniques but may step in to ask directive questions and offer feedback and suggestions for the parties' consideration. An evaluative mediator may also brainstorm about potential outcomes of the issues and talk about what a hearing officer might decide.

In FY 2022, there were 12 requests for an evaluative mediation. Of these 12 requests, three requests were resolved outside of mediation and two were declined. The remaining seven requests moved forward to an evaluative mediation that resulted in a signed mediation agreement.

Virtual Mediation

ODR offers the option of both in-person and virtual mediation. Parties can choose whether they would like the mediation to take place virtually via Zoom or in person. The virtual mediation option was a necessity when schools were closed during the pandemic and, even though schools have reopened to in-person learning, virtual mediation continues to be a popular option. Of the mediations held in FY 2022, 69% were held virtually. This is down from the 78% of mediations held virtually during FY 2021. While there was an increase in in-person mediations held during this fiscal year, the virtual option continues to be heavily utilized. Participating virtually allows more flexibility in scheduling for the parties and can be more convenient for families who may otherwise be unable to attend an in-person mediation. Of the mediations held virtually during FY 2022, 64% resulted in a signed mediation agreement. Of the mediations held in person during this same time period, 78% resulted in a signed mediation agreement. ODR has noticed that

parties sometimes allot a shorter period of time to mediations conducted virtually via Zoom. ODR encourages parties to allow sufficient time for a mediation session to ensure ample time for all steps of the mediation process. ODR's scheduling process has been updated to assist parties in scheduling mediation in multiple hour increments.





FIGURE 18: MEDIATIONS HELD VIRTUALLY VS. IN-PERSON **Virtual Mediations In-Person Mediations** 22% **36**% 64% **78**% Agreement Agreement No Agreement No Agreement


Attorney Participation

Mediation in Pennsylvania underwent a significant change in March 2021, with the addition of attorney participation under certain circumstances. Since the inception of Pennsylvania's special education mediation program in 1986, attorneys had not been permitted to attend or participate in mediation in any way. During FY 2020, the Special Education Advisory Panel endorsed a change in this long-standing policy, recommending that the Commonwealth follow the process for attorney participation at resolution meetings.

As of March 1, 2021, if the family chooses to bring an attorney to mediation, the LEA may also bring counsel. If the family chooses not to have counsel, the LEA likewise does not bring counsel. It is noteworthy that prior to this change, Pennsylvania was one of only four states that did not allow attorneys at mediation. As shown in Figure 19, 19% (91) of the 479 mediation requests submitted in FY 2022 involved parties who were represented by an attorney, and 81% (388) were unrepresented. Clearly, parents are continuing to utilize mediation in most instances without legal representation, but those few parents who chose to bring an attorney to mediation have that option. This is the strength of this mediation set up: parents have choices in how to participate.

Of the 214 mediations that were held in FY 2022, 24 included attorney participation, with 54% resulting in a signed mediation agreement. This is an increase from the FY 2021 agreement rate with attorney participation, which was 32%. The remaining FY 2022 mediations were held without attorney participation, with 70% resulting in a signed mediation agreement.





Pre-mediation Outreach and Mediation Outcomes

In March 2021, when attorneys were first permitted to participate in mediation, ODR began to require pre-mediation outreach when parties in a mediation were represented. This addition to the process was made to address a concern that attorney fees would be a barrier when writing a mediation agreement. Mediators were asked to discuss with attorneys how they planned on handling attorney fees, with the hope that the issue would be resolved outside of the mediation session. For mediations with unrepresented parties, pre-mediation outreach is optional. When pre-mediation outreach was completed and a mediation session was held, the mediation agreement rate was 73%. When looking at only mediations held with unrepresented parties, the mediation agreement rate was 79% when pre-mediation outreach was completed.





Parents or educational agencies may also resolve educational disputes through a mechanism called due process. Due process differs from other dispute resolution opportunities in that a Hearing Officer decides the dispute for the parties. Throughout the due process proceedings, resolution through mediation—both facilitative and evaluative—remains available to the parties, as does Hearing Officer Settlement Conferences. In addition, during the proceedings, the parties may settle some or all of the issues among themselves at any time, and in most instances, do so.

Due Process Requests

Beginning with the Annual Report for FY 2020, ODR began reporting the most recent data available from CADRE¹¹, the national technical assistance center on special education dispute resolution, in order to deepen the understanding of dispute resolution across the country and Pennsylvania's standing. Typically, state data from CADRE is two years behind the current fiscal year. CADRE's national data collection—which is current through FY 2020—demonstrates that special education dispute resolution activity nationwide is not monolithic. There are vast differences between and among all states based on both child

count and activity. Despite Pennsylvania's size, the Commonwealth's rate of due process is comparable to the nation's average and not an outlier.12

FIGURE 22: DUE PROCESS COMPLAINTS FILED PER 10K FOR 7-PAK STATES,






FIGURE 23: DUE PROCESS REQUESTS: FY 2018-2022

Pro Se Parents

The majority of due process requests come from an attorney representing the parent. In a minority of cases, parents requested ODR services on their own, without being represented by counsel (i.e., "pro se"). The following table lists information regarding pro se parent requests received during the reporting period to include the age group or category; the number of requests received; and how many requests came from pro se parents in total for each age/category. The number of pro se parent requests are a subset of the total number of requests received. Results of pro se parent cases appear in the Due Process Outcomes section below.






FIGURE 26: DUE PROCESS REQUESTS - SECTION 504









FIGURE 31: PA MAP OF **DUE PROCESS REQUESTS BY INTERMEDIATE UNIT** FY 2022

Due Process Outcomes

Requests

A total of 953 requests were received during FY 2022. A total of 188 requests from FY 2021 carried over into the current fiscal year. The outcomes of these cases are as follows:

Settlement or Withdrawal

FY 2022 cases

In 713 cases (75%), the parties reached agreement without the need for a fully adjudicated hearing. In 214 instances, the parties reached agreement at the resolution meeting; the balance of settled cases occurred outside the auspices of the resolution meeting. This overall settlement rate of 75% is an increase from FY 20 (70%) and FY 21 (68%). Only 24 cases went to at least one hearing before settling.

FY 2021 cases

In 133 cases, the parties reached agreement without the need for a fully adjudicated hearing. In 14 instances, the parties reached agreement at the resolution meeting; the balance of settled cases occurred outside the auspices of the resolution meeting. Only nine cases went to at least one hearing before settling. In 13 cases, the parties reported a withdrawal of the request without specifying the reason for the withdrawal.

Hearing Officer Dismissal

FY 2022 cases

The hearing officer dismissed the case in 21

instances because there was no response from the parent; the filing was untimely; the complaint was insufficient; the hearing officer lacked jurisdiction; the wrong party was named; the issue was rendered moot; or res judicata applied because the issues raised had been previously decided.

FY 2021 cases

The hearing officer dismissed the case in five instances because the parent didn't respond; the filing was untimely; the complaint was insufficient; or the hearing officer lacked jurisdiction.

Hearing Officer Decisions

FY 2022 cases

The hearing officers wrote 55 decisions on requests received during FY 2022. After a decision is issued, the hearing officer categorizes the result for purposes of the Annual Report. This is not a precise calculation; the hearing officer has to use his or her best judgment in assessing whether the decision supports the parent or the LEA. The hearing officers categorized their decision outcomes as follows:








Appeals to the State and Federal Court

During FY 2022, there were 22 appeals to federal court; there were no appeals to state court. Only four of these appeals pertained to FY 2022 requests for hearing, with the balance pre-dating the reporting period. Parents accounted for 77% of the total number of appeals filed. Four of the appeals were limited to attorneys fees. At the close of the reporting period, 18 cases were still in progress. The Court dismissed one complaint due to a filing violation, and dismissed one complaint due to party settlement. The Court ruled on the substantive aspect of the case in two instances, affirming the hearing officers' decisions in their entirety.




